A BILL ENTITLED

1 AN ACT concerning

2 **Payroll Recovery Act**

3 FOR the purpose of requiring the Central Payroll Bureau of the Office of the State
4 Comptroller to establish certain pay periods and pay certain employees within
5 certain periods of time; requiring the Bureau to provide each employee a notice of
6 certain information and a statement, each pay period, that includes certain
7 information; requiring the Bureau to provide notice of at least a certain number of
8 pay periods before making certain changes; authorizing an employee or the
9 employee's exclusive representative to initiate a certain grievance procedure if the
10 Bureau does not pay the employee in a certain manner; authorizing the grievance to
11 be initiated up to a certain number of years after the failure to pay occurs;
12 establishing the damages the Bureau is required to pay under certain circumstances;
13 providing that certain employees eligible to file a grievance under this Act that are
14 barred by a certain time limitation may file the grievance on or before a certain date;
15 and generally relating to the payment of certain wages.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – State Personnel and Pensions**

6 2–402.

7 (a) Except as provided in subsection (b) of this section and notwithstanding any
8 other law, the Central Payroll Bureau of the Office of the State Comptroller shall provide
9 for the payment of all wages to:

10 (1) each officer and employee of the State who is paid from funds
11 appropriated by the General Assembly; and

12 (2) whether or not paid from funds appropriated by the General Assembly,
13 each officer and employee of:

14 (i) the University System of Maryland;

15 (ii) Morgan State University;

16 (iii) St. Mary’s College of Maryland; and

17 (iv) Baltimore City Community College.

18 (b) The Central Payroll Bureau shall maintain all supporting payroll records for
19 the payment of wages under this section.

20 **(C) (1) IN THIS SUBSECTION:**

21 **(I) “WAGE” MEANS ALL COMPENSATION THAT IS DUE TO AN**
22 **EMPLOYEE; AND**

23 **(II) “WAGE” INCLUDES:**

24 **1. A BONUS;**

25 **2. A COMMISSION;**

26 **3. A FRINGE BENEFIT;**

27 **4. OVERTIME WAGES;**

1 **5. PREMIUM PAY; OR**

2 **6. ANY OTHER REMUNERATION PROMISED FOR**
3 **SERVICE.**

4 **(2) THE CENTRAL PAYROLL BUREAU SHALL:**

5 **(I) ESTABLISH REGULAR PAY PERIODS; AND**

6 **(II) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS**
7 **SUBSECTION, PAY EACH EMPLOYEE ALL WAGES DUE AT LEAST ONCE EVERY TWO**
8 **WEEKS OR TWICE EACH MONTH.**

9 **(3) THE CENTRAL PAYROLL BUREAU MAY PAY AN ADMINISTRATIVE,**
10 **AN EXECUTIVE, OR A PROFESSIONAL EMPLOYEE LESS FREQUENTLY THAN**
11 **REQUIRED UNDER PARAGRAPH (2)(II) OF THIS SUBSECTION.**

12 **2-406.**

13 **(A) THE CENTRAL PAYROLL BUREAU OF THE OFFICE OF THE STATE**
14 **COMPTROLLER SHALL PROVIDE EACH EMPLOYEE:**

15 **(1) AT THE TIME OF HIRING, NOTICE OF:**

16 **(I) THE EMPLOYEE'S RATE OF PAY;**

17 **(II) THE REGULAR PAY PERIODS; AND**

18 **(III) THE EMPLOYEE'S LEAVE BENEFITS; AND**

19 **(2) FOR EACH PAY PERIOD, A STATEMENT OF THE GROSS EARNINGS**
20 **OF THE EMPLOYEE AND ANY DEDUCTIONS FROM THE GROSS EARNINGS.**

21 **(B) THE CENTRAL PAYROLL BUREAU SHALL PROVIDE NOTICE OF AT LEAST**
22 **ONE PAY PERIOD BEFORE A CHANGE IN:**

23 **(1) THE AMOUNT OF WAGES TO BE PAID; OR**

24 **(2) THE DATE ON WHICH WAGES ARE TO BE PAID.**

25 **2-407.**

1 **(A) IF THE CENTRAL PAYROLL BUREAU OF THE OFFICE OF THE STATE**
2 **COMPTROLLER DOES NOT PAY AN EMPLOYEE IN ACCORDANCE WITH § 2-402 OF**
3 **THIS SUBTITLE, THE EMPLOYEE OR THE EMPLOYEE'S EXCLUSIVE REPRESENTATIVE**
4 **MAY INITIATE A GRIEVANCE AT STEP TWO OF THE GRIEVANCE PROCEDURE**
5 **ESTABLISHED UNDER § 12-204 OF THIS ARTICLE.**

6 **(B) NOTWITHSTANDING § 12-203(B) OF THIS ARTICLE, A GRIEVANCE**
7 **UNDER SUBSECTION (A) OF THIS SECTION MAY BE INITIATED UP TO 2 YEARS AFTER**
8 **THE DATE ON WHICH THE FAILURE TO PAY OCCURRED.**

9 **(C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IN AN ACTION**
10 **UNDER SUBSECTION (A) OF THIS SECTION AN EMPLOYEE IS ENTITLED TO DAMAGES**
11 **IN THE AMOUNT OF 30% OF THE WAGE THAT THE CENTRAL PAYROLL BUREAU**
12 **FAILED TO PAY UNLESS THE WAGE IS WITHHELD AS A RESULT OF A BONA FIDE**
13 **DISPUTE.**

14 **(2) THE DAMAGES UNDER PARAGRAPH (1) OF THIS SUBSECTION:**

15 **(I) SHALL BE CALCULATED FOR EACH REGULAR PAY PERIOD**
16 **FOR WHICH THE WAGE IS NOT PAID; AND**

17 **(II) MAY NOT EXCEED THREE TIMES THE AMOUNT OF WAGE DUE**
18 **FOR A PAY PERIOD.**

20 **(a) Except as provided in subsection (b) of this section, the remedies available to**
21 **a grievant under this title are limited to the restoration of the rights, pay, status, or benefits**
22 **that the grievant otherwise would have had if the contested policy, procedure, or regulation**
23 **had been applied appropriately as determined by the final decision maker.**

24 **(b) (1) A decision maker at Step Two or Step Three of the grievance procedure:**

25 **(I) may order an appointing authority to grant back pay; AND**

26 **(II) ON A FINDING THAT WAGES WERE WITHHELD IN VIOLATION**
27 **OF §§ 2-402 AND 2-407 OF THIS ARTICLE, SHALL ORDER THE PAYMENT OF DAMAGES**
28 **IN ACCORDANCE WITH § 2-407(C) OF THIS ARTICLE.**

29 **(2) (i) In a reclassification grievance back pay may be awarded for a**
30 **period not exceeding 1 year before the grievance procedure was initiated.**

31 **(ii) A back pay order under this paragraph is in the discretion of the**
32 **Secretary and the Office of Administrative Hearings.**

1 (3) Subject to the limitations in Title 14, Subtitle 2 of this article, an
2 appointing authority shall carry out a back pay order **OR DAMAGES ORDER** issued under
3 this subsection.

4 SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding any other
5 provision of law, an employee that is eligible to file a grievance under this Act and is barred
6 by any time limitation under the State Personnel and Pensions Article may initiate a
7 grievance established by this Act on or before July 31, 2017.

8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
9 1, 2017.
