## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Counties and Municipalities – Land Bank Authorities**

3 FOR the purpose of altering certain provisions of law concerning the authority of a  
4 municipality to establish a land bank authority; making certain provisions of law  
5 concerning the establishment of a land bank authority applicable to a municipality  
6 or county; authorizing two or more local governments to enter into a certain  
7 intergovernmental cooperation agreement; providing for the continued operation of  
8 an authority under certain circumstances; establishing certain powers of an  
9 authority; authorizing an authority to enforce a water and sewer lien under certain  
10 circumstances; providing for the tax treatment of property sold by an authority to a  
11 nonprofit organization under certain circumstances; exempting property held by an  
12 authority from a certain requirement to sell; authorizing the Mayor and City Council  
13 of Baltimore City to transfer property to an authority under certain circumstances;  
14 exempting property held by an authority from certain taxes under certain  
15 circumstances; altering and defining certain terms; making certain conforming  
16 changes; and generally relating to land bank authorities.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 15 That Section(s) 5–401 through 5–431, respectively, and the subtitle “Subtitle 4.  
 16 Establishment of Land Bank Authorities by Municipalities” of Article – Local Government  
 17 of the Annotated Code of Maryland be renumbered to be Section(s) 1–1401 through 1–1431,  
 18 respectively, and the subtitle “Subtitle 14. Establishment of Land Bank Authorities by  
 19 Municipalities”.

20 SECTION 2. AND BE IT FURTHER ENACTED BY THE GENERAL ASSEMBLY  
 21 OF MARYLAND, That the Laws of Maryland read as follows:

### 22 Article – Local Government

23 Subtitle 14. Establishment of Land Bank Authorities [by Municipalities].

24 1–1401.

25 (a) In this subtitle the following words have the meanings indicated.

26 (b) “Authority” means a nonprofit or quasi–governmental entity created by [a  
 27 municipality] **ONE OR MORE LOCAL GOVERNMENTS** under § [5–403] **1–1403** of this  
 28 subtitle.

29 (c) “Board” means the board of directors of an authority.

30 (d) (1) “Bond” means a bond issued by an authority under this subtitle.

31 (2) “Bond” includes a bond, a refunding bond, a note, and any other  
 32 obligation.

33 (e) “Cost” includes:

- 1 (1) the purchase price of property;
- 2 (2) the cost to acquire any right, title, or interest in property;
- 3 (3) the cost of any improvements made to property;
- 4 (4) the amount to be paid to discharge each obligation necessary or  
5 desirable to vest title to any part of property in an authority or other owner;
- 6 (5) the cost of any property, right, easement, franchise, or permit  
7 associated with a project;
- 8 (6) the cost of labor, machinery, and equipment necessary to implement a  
9 project;
- 10 (7) financing charges;
- 11 (8) interest and reserves for principal and interest and for improvements;
- 12 (9) the cost of revenue and cost estimates, engineering and legal services,  
13 plans, specifications, studies, surveys, and other expenses necessary or incident to  
14 determining the feasibility or practicability of a project;
- 15 (10) administrative expenses; and
- 16 (11) other expenses as necessary or incident to:
  - 17 (i) financing a project;
  - 18 (ii) acquiring and improving a project;
  - 19 (iii) placing a project in operation, including reasonable provisions for  
20 working capital; and
  - 21 (iv) operating and maintaining a project.

22 (f) **“LOCAL GOVERNMENT” MEANS A MUNICIPALITY OR A COUNTY.**

- 23 (G) (1) “Project” means any organized plan carried out by an authority in  
24 relation to:
- 25 (i) acquiring and rehabilitating abandoned and dilapidated  
26 properties; and
  - 27 (ii) marketing and leasing [or], selling, **OR OTHERWISE**  
28 **TRANSFERRING** the rehabilitated properties.

1 (2) "Project" includes:

2 (i) acquiring land or an interest in land;

3 (ii) acquiring structures, equipment, and furnishings located on a  
4 property;

5 (iii) acquiring property that is functionally related and subordinate  
6 to a project; and

7 (iv) obtaining or contracting for any services necessary for the  
8 rehabilitation of a property.

9 [(g)] (H) (1) "Revenue" means the income, revenue, and other money an  
10 authority receives from or in connection with a project and all other income of an authority.

11 (2) "Revenue" includes grants, rentals, rates, fees, and charges.

12 [(h)] (I) "Tax sale property" means property or an interest in property sold by  
13 the tax collector of the county in accordance with Title 14, Subtitle 8, Part III of the  
14 Tax – Property Article.

15 [(i)] (J) (1) "Trust agreement" means an agreement entered into by an  
16 authority to secure a bond.

17 (2) "Trust agreement" includes a bond contract, bond resolution, or other  
18 contract with or for the benefit of a bondholder.

19 (K) "WATER AND SEWER AUTHORITY" MEANS AN AUTHORITY ESTABLISHED  
20 UNDER TITLE 9, SUBTITLE 9 OF THE ENVIRONMENT ARTICLE.

21 (L) "WATER AND SEWER LIEN" MEANS A LIEN ESTABLISHED UNDER § 9-949  
22 OF THE ENVIRONMENT ARTICLE.

23 1-1403.

24 (a) (1) By ordinance, the [legislative] GOVERNING body of a [municipality]  
25 LOCAL GOVERNMENT may establish a land bank authority in accordance with this  
26 subtitle.

27 (2) TWO OR MORE LOCAL GOVERNMENTS MAY ELECT TO ENTER INTO  
28 AN INTERGOVERNMENTAL COOPERATION AGREEMENT TO CREATE A SINGLE LAND  
29 BANK TO ACT ON BEHALF OF THE LOCAL GOVERNMENTS, WHICH MAY INCLUDE ONE  
30 OR MORE WATER AND SEWER AUTHORITIES.

31 (3) AN ORDINANCE ADOPTED UNDER THIS SECTION:

1                   **(I) IS ADMINISTRATIVE IN NATURE;**

2                   **(II) IS NOT SUBJECT TO REFERENDUM; AND**

3                   **(III) IN A CHARTER COUNTY THAT HAS A PUBLICLY ELECTED**  
4 **COUNTY EXECUTIVE OR IN A MUNICIPALITY THAT HAS A PUBLICLY ELECTED CHIEF**  
5 **EXECUTIVE OR MAYOR, IS SUBJECT TO APPROVAL BY THE COUNTY EXECUTIVE,**  
6 **CHIEF EXECUTIVE, OR MAYOR.**

7           (b) An ordinance adopted under subsection (a) of this section shall include  
8 proposed articles of incorporation of an authority that state:

9                   (1) the name of the authority, which shall be “Land Bank Authority of  
10 (name of the incorporating [municipality] **LOCAL GOVERNMENT**)”;

11                   (2) that the authority is formed under this subtitle;

12                   (3) the names, addresses, and terms of office of the initial members of the  
13 board;

14                   (4) the address of the principal office of the authority;

15                   (5) the purposes for which the authority is formed; and

16                   (6) the powers of the authority, subject to the limitations of this subtitle.

17           (c) (1) The chief executive, **COUNTY EXECUTIVE, OR MAYOR** of the  
18 incorporating [municipality] **LOCAL GOVERNMENT**, or any other official designated in the  
19 ordinance establishing an authority, shall execute and file the articles of incorporation of  
20 the authority for recordation with the State Department of Assessments and Taxation.

21                   (2) When the State Department of Assessments and Taxation accepts the  
22 articles of incorporation for recordation, the authority becomes a body politic and corporate  
23 and an instrumentality of the incorporating [municipality] **LOCAL GOVERNMENT**.

24                   (3) Acceptance of the articles of incorporation for recordation by the State  
25 Department of Assessments and Taxation is conclusive evidence of the formation of the  
26 authority.

27           (d) (1) By ordinance, the [legislative] **GOVERNING** body of the incorporating  
28 [municipality] **LOCAL GOVERNMENT** may adopt an amendment to the articles of  
29 incorporation of an authority.

30                   (2) Articles of amendment may contain any provision that lawfully could  
31 be contained in articles of incorporation at the time of the amendment.

1 (3) The articles of amendment shall be filed for recordation with the State  
2 Department of Assessments and Taxation.

3 (4) The articles of amendment are effective as of the time the State  
4 Department of Assessments and Taxation accepts the articles for recordation.

5 (5) Acceptance of the articles of amendment for recordation by the State  
6 Department of Assessments and Taxation is conclusive evidence that the articles have been  
7 lawfully and properly adopted.

8 (e) (1) Subject to this section and any limitations imposed by law on the  
9 impairment of contracts, the incorporating [municipality] **LOCAL GOVERNMENT**, in its  
10 sole discretion, by ordinance may:

11 (i) set or change the structure, organization, procedures, programs,  
12 or activities of an authority; or

13 (ii) **SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION,**  
14 terminate the authority.

15 **(2) IF ONE OR MORE LOCAL GOVERNMENTS ENGAGED IN AN**  
16 **INTERGOVERNMENTAL COOPERATION AGREEMENT DECIDE NOT TO TERMINATE**  
17 **THE AUTHORITY, THE AUTHORITY MAY CONTINUE TO OPERATE IF:**

18 **(I) THE NAME OF THE AUTHORITY IS REVISED TO REMOVE THE**  
19 **LOCAL GOVERNMENT THAT HAS DECIDED TO TERMINATE ITS PARTICIPATION IN THE**  
20 **AUTHORITY BY WITHDRAWAL;**

21 **(II) THE WITHDRAWING LOCAL GOVERNMENT DESIGNATES ALL**  
22 **PROPERTY TO REMAIN WITH THE AUTHORITY EXCEPT THAT:**

23 **1. ON DEMAND OF A WITHDRAWING LOCAL**  
24 **GOVERNMENT THAT IS A MUNICIPALITY, ALL PROPERTY LOCATED WHOLLY WITHIN**  
25 **THE MUNICIPALITY SHALL BE TRANSFERRED TO THE MUNICIPALITY; AND**

26 **2. ON DEMAND OF A WITHDRAWING LOCAL**  
27 **GOVERNMENT THAT IS A COUNTY, ALL PROPERTY LOCATED WHOLLY WITHIN THE**  
28 **COUNTY AND OUTSIDE ANY MUNICIPALITY PARTICIPATING IN THE**  
29 **INTERGOVERNMENTAL COOPERATION AGREEMENT SHALL BE TRANSFERRED TO**  
30 **THE COUNTY; AND**

31 **(III) ALL OBLIGATIONS OF THE AUTHORITY TO THE**  
32 **WITHDRAWING LOCAL GOVERNMENT AND OF THE WITHDRAWING LOCAL**

1 GOVERNMENT TO THE AUTHORITY ARE ASSUMED BY THE WITHDRAWING LOCAL  
2 GOVERNMENT.

3 [(2)] (3) On termination of the authority:

4 (i) title to all property of the authority shall be transferred to and  
5 shall vest in the incorporating [municipality] LOCAL GOVERNMENT; and

6 (ii) all obligations of the authority shall be transferred to and  
7 assumed by the incorporating [municipality] LOCAL GOVERNMENT.

8 1-1405.

9 (a) Except as limited by the authority's articles of incorporation, an authority has  
10 all the powers specified in this subtitle.

11 (b) An authority may:

12 (1) adopt, **AMEND, AND REPEAL** bylaws for the conduct of business of the  
13 authority;

14 (2) sue and be sued;

15 (3) maintain an office at a place the authority designates;

16 (4) borrow money;

17 (5) issue bonds and other obligations for any corporate purpose in  
18 accordance with this subtitle or an ordinance adopted under this subtitle;

19 (6) invest money of the authority in instruments, obligations, securities, or  
20 property;

21 (7) enter into contracts and execute the instruments or agreements  
22 necessary or convenient to carry out this subtitle or an ordinance adopted under this  
23 subtitle to accomplish the purposes of the authority;

24 (8) solicit and accept gifts, grants, loans, or other assistance in any form  
25 from any public or private source, subject to this subtitle or any ordinance adopted under  
26 this subtitle;

27 (9) participate in a program of the federal government, the State, a political  
28 subdivision of the State, or an intergovernmental entity created under State law;

29 (10) contract for goods and services;

1 (11) study, develop, and prepare reports or plans to assist in the authority's  
2 exercise of powers and to monitor and evaluate the authority's progress;

3 (12) contract with public or private entities for services necessary to manage  
4 and operate the authority;

5 (13) provide acquisition, management, and sale services to a [municipality]  
6 **LOCAL GOVERNMENT** for property owned by the [municipality] **LOCAL GOVERNMENT**;

7 (14) create, own, control, or be a member of a corporation, limited liability  
8 company, partnership, or other person, whether operated for profit or not for profit, for the  
9 purposes of developing property in order to maximize marketability;

10 (15) exercise a power usually possessed by a private corporation in  
11 performing similar functions, unless to do so would conflict with State law; [and]

12 **(16) INSURE AGAINST LOSSES IN CONNECTION WITH THE REAL**  
13 **PROPERTY, ASSETS, OR ACTIVITY OF THE AUTHORITY;**

14 **(17) DESIGN, DEVELOP, CONSTRUCT, DEMOLISH, REHABILITATE,**  
15 **RENOVATE, RELOCATE, AND OTHERWISE IMPROVE REAL PROPERTY OR INTERESTS**  
16 **IN REAL PROPERTY;**

17 **(18) RAISE REVENUE BY ANY LEGAL MEANS REQUIRED TO MAKE THE**  
18 **OPERATIONS AND ACTIVITIES OF THE AUTHORITY SELF-SUSTAINING; AND**

19 ~~[(16)]~~ **(19)** do all things necessary or convenient to carry out the powers  
20 expressly granted by this subtitle or by an ordinance adopted under this subtitle.

21 (c) An authority may delegate to a member or officer a power granted to the  
22 authority by this subtitle, including the power to execute a bond, obligation, certificate,  
23 deed, lease, mortgage agreement, or other document or instrument.

24 1-1406.

25 (a) An authority may:

26 (1) acquire real property or rights or interests in real property, directly or  
27 through a person or governmental entity, by gift, devise, transfer, exchange, foreclosure,  
28 purchase, or otherwise on terms and conditions and in a manner the authority considers  
29 proper;

30 (2) own property in the authority's name, including tax foreclosed property  
31 and property without clear title;

1 (3) sell, lease as lessor, transfer, and dispose of the authority's interest in  
2 property;

3 (4) procure insurance against loss in connection with the property, assets,  
4 or activities of the authority; and

5 (5) execute deeds, mortgages, contracts, leases, purchases, or other  
6 agreements regarding the property of the authority.

7 (b) Property purchased, owned, or sold under this section may not be located  
8 outside the [municipality] JURISDICTION OF THE LOCAL GOVERNMENT in which the  
9 authority is located.

10 (c) (1) AN AUTHORITY MAY CLEAR QUIET TITLE OR FORECLOSE ON A  
11 PROPERTY IN WHICH IT HOLDS AN INTEREST THAT IS NOT FEE SIMPLE TITLE BY:

9 The court may appoint an authority to serve as a receiver in a receivership  
 10 proceeding filed by a [municipality] LOCAL GOVERNMENT.

12 (a) An authority shall:

13 (1) adopt a code of ethics for the authority's directors, officers, and  
 14 employees;

15 (2) establish policies and procedures requiring:

16 (i) the disclosure of relationships that may create a conflict of  
 17 interest; and

18 (ii) any member of the board with a direct or indirect interest in a  
 19 matter before the authority to disclose the member's interest to the board before the board  
 20 takes any action on the matter; and

21 (3) comply with the Open Meetings Act.

22 (b) Except as otherwise provided in this subtitle or the ordinance establishing an  
 23 authority, the procedures of the incorporating [municipality] LOCAL GOVERNMENT  
 24 control any matter relating to the internal administration of an authority.

26 An authority may have the same immunities as [a municipality] THE LOCAL  
 27 GOVERNMENT THAT CREATES THE AUTHORITY UNDER § 1-1403 OF THIS SUBTITLE.

28 1-1412.

29 (a) Property held by an authority shall be inventoried and classified according to  
 30 title status and suitability for use.

1 (b) A clerk of the court may not charge a fee to record a document evidencing the  
2 transfer under this subtitle of property to the authority by the State or a [municipality]  
3 **LOCAL GOVERNMENT.**

4 1-1413.

5 (a) **(1)** After an unsuccessful attempt by the [municipality] **LOCAL**  
6 **GOVERNMENT** to collect outstanding liens at tax sale and subject to the approval of the  
7 **WATER AND SEWER AUTHORITY, GOVERNING BODY, OR** tax collector of the jurisdiction  
8 where the property is located, an authority may accept from a person with an interest in a  
9 parcel of **WATER AND SEWER LIEN PROPERTY**, tax delinquent property, or tax sale  
10 property a deed or assignment conveying that person's interest in the property instead of:

11 **[(1)] (I)** the foreclosure or sale of the property for delinquent taxes,  
12 penalties, and interest, as defined by § 14-801(d) of the Tax – Property Article; **[or]**

13 **[(2)] (II)** delinquent-specific taxes imposed by a local taxing jurisdiction;  
14 **OR**

15 **(III) DELINQUENT WATER AND SEWER LIENS IMPOSED BY A**  
16 **WATER AND SEWER AUTHORITY.**

17 **(2) (I) AFTER AN UNSUCCESSFUL ATTEMPT BY THE LOCAL**  
18 **GOVERNMENT OR WATER AND SEWER AUTHORITY TO COLLECT OUTSTANDING LIENS**  
19 **THAT ARE DELINQUENT AND AT THE DISCRETION OF THE GOVERNING BODY OF THE**  
20 **JURISDICTION, THE WATER AND SEWER AUTHORITY, OR THE TAX COLLECTOR**  
21 **WHERE THE PROPERTY IS LOCATED, AN AUTHORITY MAY ACCEPT FROM THE LOCAL**  
22 **GOVERNMENT OR WATER AND SEWER AUTHORITY WITH AN INTEREST IN A PARCEL**  
23 **OF DELINQUENT WATER AND SEWER LIEN PROPERTY, TAX DELINQUENT PROPERTY,**  
24 **OR TAX SALE PROPERTY ITS INTEREST IN THE WATER AND SEWER LIENS OR TAX**  
25 **LIENS IN THE PROPERTY.**

26 **(II) THE AUTHORITY MAY:**

27 **1. COLLECT ON LIENS OR TAXES COLLECTED UNDER**  
28 **SUBPARAGRAPH (I) OF THIS PARAGRAPH AND RETAIN ALL PAYMENT OF TAXES,**  
29 **LIENS, PENALTIES, OR ANY INTEREST ON THE LIENS OR TAXES; OR**

30 **2. FORECLOSE ON, ENTER INTO A DEED IN LIEU OF**  
31 **FORECLOSURE, OR SELL THE PROPERTY FOR THE LIENS OR TAXES AND RETAIN ALL**

33 **COSTS OF SELLING THE PROPERTY AND, IF ANY OTHER NET PROCEEDS REMAIN**

1 **DISTRIBUTION ON A PRO RATA BASIS TO THE APPROPRIATE TAXING UNITS AND**  
 2 **WATER AND SEWER AUTHORITIES IN A RATIO EQUAL TO THE DELINQUENT TAXES OR**  
 3 **WATER AND SEWER LIENS, PENALTIES, AND INTEREST OWED ON THE PROPERTY.**

4 (b) Conveyance of property by deed instead of foreclosure **OR TRANSFER OF A**  
 5 **LIEN OR TAX ON PROPERTY** under this section may not affect or impair any other lien  
 6 against the property or any existing recorded or unrecorded interest in the property,  
 7 including any:

8 (1) easement or right-of-way;

9 (2) future installment of a special assessment;

10 (3) lien recorded by the State;

11 (4) private deed restriction;

12 (5) security interest or mortgage; [or]

13 (6) tax lien of another taxing jurisdiction that does not consent to a release  
 14 of its lien; **OR**

15 **(7) WATER AND SEWER LIEN OF A WATER AND SEWER AUTHORITY**

12           When any property on which there are unpaid taxes due to any other taxing agency  
13 or to the State is purchased by the governing body of the county at a sale held by the  
14 collector under this subtitle, **OR AFTER BEING PURCHASED IS TRANSFERRED TO A**  
15 **LAND BANK AUTHORITY ESTABLISHED UNDER § 1-1403 OF THE LOCAL**  
16 **GOVERNMENT ARTICLE, NEITHER** the governing body of the county **NOR AN**  
17 **AUTHORITY** need [not] make and the collector or other taxing agency or the State is not

29           Until a judgment is issued by the circuit court that forecloses all rights of redemption  
30 in any property sold by the collector, the property shall continue to be assessed as though

33 on the assessment books or records to the holder of the certificate of sale notwithstanding
