13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
15	Article – Education
16	7–205.1.
17 18	(a) The State Board shall establish high school curriculum and graduation requirements for all public schools in accordance with this section.
19 20 21	(b) (1) Beginning with the 2015–2016 school year, all students shall be assessed using acceptable college placement cut scores no later than 11th grade to determine whether the student is ready for college—level credit—bearing course work in

in collaboration with local school systems and public community colleges, shall develop and

English Language Arts, Literacy, and Mathematics.



Subject to subparagraph (ii) of this paragraph, the Department,

- 1 implement, by the 2016–2017 school year, transition courses or other instructional opportunities to be delivered in the 12th grade to students who have not achieved college
- and career readiness by the end of the 11th grade.
- 4 (ii) The implementation of transition courses or other instructional opportunities required under subparagraph (i) of this paragraph:
- 6 1. Shall include an assessment or reassessment of the 7 student after completion of the course; and
- 8 2. May not preclude or replace enrollment in a course 9 otherwise required for graduation from high school.
- 10 (c) (1) Beginning with the 9th grade class of 2014, and subject to paragraph (2) of this subsection and subsection (e) of this section, each student shall enroll in a mathematics course in each year of high school that the student attends high school.
- 13 (2) The Department shall adopt regulations that establish the 14 mathematics and math-related courses that fulfill the requirements of this subsection, 15 which may include math-related career and technology program courses.
- 16 (d) It is the goal of the State that all students achieve mathematics competency 17 in Algebra II.
- 18 (e) A student who is enrolled in a credit—bearing mathematics transition course 19 under subsection (b)(2) of this section:
- 20 (1) Subject to item (2) of this subsection, shall be considered to meet the 21 requirements of subsection (c) of this section; and
- 22 (2) May not be considered to meet the requirements of subsection (c) of this section if other credit—bearing courses required for graduation have not been met.
- (F) IF A STUDENT IS REQUIRED TO COMPLETE HOURS FOR STUDENT SERVICE TO GRADUATE FROM HIGH SCHOOL, FIRE FIGHTING TRAINING AND VOLUNTEER HOURS MAY BE USED TO SATISFY THE STUDENT SERVICE REQUIREMENT.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2017.
