## Public Institutions of Higher Education – Access of Students to Emergency Contraception

4 FOR the purpose of requiring a public institution of higher education to require a student health center to provide during certain hours of operation of the student health 5 6 center on-site access to certain emergency contraception and contraceptive 7 counseling or referrals for contraceptive counseling to other qualified health care 8 providers; requiring a public institution of higher education to ensure the availability 9 of certain emergency contraception at all times, certain information relating to the 10 availability of emergency contraception on campus and off campus, and certain information in a certain format based on certain recommendations; defining certain 11 12 terms; and generally relating to access of students to emergency contraception at 13 public institutions of higher education.
