State Highway Administration – Traffic Control Devices – Decorative Treatments

FOR the purpose of requiring the State Highway Administration to establish a certain 4 $\mathbf{5}$ policy regarding the application of decorative treatments on certain traffic control 6 devices; authorizing a person to apply to a district office within the Administration 7 for a certain permit to install certain decorative treatments; authorizing a district 8 office to issue a permit to install certain decorative treatments on a traffic control 9 device within the jurisdiction of the district office; requiring the Administration to 10 adopt certain regulations; authorizing the Administration to adopt certain 11 regulations; and generally relating to the installation of decorative treatments on 12traffic control devices.
