CHAPTER _____

1 AN ACT concerning

2 **Estates and Trusts – Vehicle Transfers – Excise Tax and Fee Exemption**

3 FOR the purpose of providing that the motor vehicle excise tax and certificate of title fee
4 may not be imposed for the issuance of a certificate of title for certain vehicles
5 transferred, under certain circumstances, to a trust or from a trust to certain
6 beneficiaries; altering a certain definition; defining a certain term; and generally
7 relating to an exemption from the motor vehicle excise tax and certificate of title fee.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Estates and Trusts**

12 14.5–103.

13 (a) In this title the following words have the meanings indicated.

14 (d) “Beneficiary” means a person that:

15 (1) Has a present or future beneficial interest in a trust, vested or
16 contingent; or

17 (2) In a capacity other than that of a trustee, holds a power of appointment
18 over trust property.

19 (t) (1) “Qualified beneficiary” means a beneficiary that on the date the
20 qualification of the beneficiary is determined:

21 (i) Is a distributee or permissible distributee of trust income or
22 principal;

23 (ii) Would be a distributee or permissible distributee of trust income
24 or principal if the interests of the distributees described in item (i) of this paragraph
25 terminated on that date without causing the trust to terminate; or

26 (iii) Would be a distributee or permissible distributee of trust income
27 or principal if the trust terminated on that date and no power of appointment was exercised.

28 (2) “Qualified beneficiary” does not include an appointee under the will of
29 a living person or the object of an unexercised inter vivos power of appointment.

30 (v) (1) “Settlor” means a person, including a testator, that creates or
31 contributes property to a trust.

1 (2) “Settlor” includes a person that, with other settlors, creates or
2 contributes property to a trust in which case each such person is a settlor of the portion of
3 the trust property attributable to the contribution of that person except to the extent
4 another person has the power to revoke or withdraw that portion.

6 (a) (1) In this section the following words have the meanings indicated.

7 (2) “Consideration” does not include the amount of any obligation under a
8 mortgage, [or] deed of trust, **OR OTHER WRITING** encumbering the transferred property.

9 (3) “Trust” does not include:

10 (i) A real estate investment trust as defined in § 8–101 of the
11 Corporations and Associations Article; or

12 (ii) A statutory trust as defined in § 12–101 of the Corporations and
13 Associations Article.

14 (4) **“VEHICLE” INCLUDES:**

15 **(I) A MOTOR VEHICLE, A TRAILER, A SEMITRAILER, A MOPED, A**
16 **MOTOR SCOOTER, OR AN OFF–HIGHWAY RECREATIONAL VEHICLE FOR WHICH SALES**
17 **AND USE TAX IS NOT COLLECTED AT THE TIME OF PURCHASE; OR**

18 **(II) A MOTOR VEHICLE, TRAILER, OR SEMITRAILER THAT IS IN**
19 **INTERSTATE OPERATION AND REGISTERED UNDER § 13–109(C) OR (D) OF THE**
20 **TRANSPORTATION ARTICLE WITHOUT A CERTIFICATE OF TITLE.**

21 (b) A recordation tax, transfer tax, or any other State or local excise tax may not
22 be imposed on the transfer of real property or an interest in real property without
23 consideration or on the recordation of an instrument that transfers real property or an
24 interest in real property without consideration if:

25 (1) The transfer is to a trust; or

26 (2) The transfer is from a trust to one or more beneficiaries and:

27 (i) The transfer is made to a person that would be exempt from tax
28 under Title 12 or Title 13 of the Tax – Property Article if the transfer had been made to
29 that person directly by the grantor; or

30 (ii) The transfer is made during the life of the grantor of the trust
31 and the trustee of the trust originally acquired the real property for adequate consideration.

1 **(26) A VEHICLE THAT IS TRANSFERRED TO A TRUST OR FROM A TRUST**
2 **TO ONE OR MORE BENEFICIARIES IN ACCORDANCE WITH § 14.5-1001 OF THE**
3 **ESTATES AND TRUSTS ARTICLE.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
5 1, 2017.
