1 AN ACT concerning

2 **Criminal Law – Controlled Dangerous Substances – Places of Use**

3 FOR the purpose of altering the prohibition against keeping a dwelling, a building, a
4 vehicle, a vessel, an aircraft, or any other place resorted to by individuals for the
5 purpose of administering illegally controlled dangerous substances to remove the
6 prohibition from provisions relating to common nuisance; altering a certain penalty;
7 and generally relating to controlled dangerous substances.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 5–601.

17 (a) Except as otherwise provided in this title, a person may not:

1 (1) possess or administer to another a controlled dangerous substance,
2 unless obtained directly or by prescription or order from an authorized provider acting in
3 the course of professional practice; [or]

4 (2) obtain or attempt to obtain a controlled dangerous substance, or
5 procure or attempt to procure the administration of a controlled dangerous substance by:

6 (i) fraud, deceit, misrepresentation, or subterfuge;

7 (ii) the counterfeiting or alteration of a prescription or a written
8 order;

9 (iii) the concealment of a material fact;

10 (iv) the use of a false name or address;

11 (v) falsely assuming the title of or representing to be a
12 manufacturer, distributor, or authorized provider; or

13 (vi) making, issuing, or presenting a false or counterfeit prescription
14 or written order; **OR**

15 **(3) KEEP A DWELLING, A BUILDING, A VEHICLE, A VESSEL, AN**
16 **AIRCRAFT, OR ANY OTHER PLACE RESORTED TO BY INDIVIDUALS FOR THE PURPOSE**
17 **OF ADMINISTERING ILLEGALLY CONTROLLED DANGEROUS SUBSTANCES.**

19 (a) “Common nuisance” means a dwelling, building, vehicle, vessel, aircraft, or
20 other place[:

21 (1) resorted to by individuals for the purpose of administering illegally
22 controlled dangerous substances; or

23 (2)] where controlled dangerous substances or controlled paraphernalia are
24 manufactured, distributed, dispensed, stored, or concealed illegally.

25 (b) A person may not keep a common nuisance.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 October 1, 2017.
