#### 1 AN ACT concerning

### Criminal Law – Hate Crimes – Law Enforcement Officers (Blue Lives Matter Act of 2017)

FOR the purpose of including law enforcement officers within the scope of certain
prohibitions against committing certain crimes against certain persons, damaging
certain property of certain persons, burning certain objects, and damaging certain
buildings with which certain persons or groups have contacts or associations or
under circumstances exhibiting animosity against a certain person or group; defining
a certain term; and generally relating to hate crimes against law enforcement
officers.
