A BILL ENTITLED

1 AN ACT concerning

2 **Public Health – Expedited Partner Therapy – Pharmacist Dispensing**

3 FOR the purpose of authorizing, notwithstanding any other provision of law, a licensed
4 pharmacist to dispense antibiotic therapy prescribed to certain partners of patients
5 diagnosed with certain sexually transmitted infections without making a certain
6 physical assessment; and generally relating to expedited partner therapy and
7 dispensing of antibiotic therapy by a licensed pharmacist.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Health – General**

16 18–214.1.

17 (a) The purpose of expedited partner therapy is to provide antibiotic therapy to
18 any partner of a patient diagnosed with a sexually transmitted infection identified in
19 subsection (b) of this section in order to:

20 (1) Contain and stop the further spread of the infection; and

21 (2) Reduce the likelihood of reinfection in the diagnosed patient.

22 (b) Notwithstanding any other provision of law, the following health care
23 providers may prescribe, dispense, or otherwise provide antibiotic therapy to any sexual

1 partner of a patient diagnosed with chlamydia or gonorrhea without making a personal
2 physical assessment of the patient's partner:

3 (1) A physician licensed under Title 14 of the Health Occupations Article;

4 (2) An advanced practice registered nurse with prescriptive authority
5 licensed under Title 8 of the Health Occupations Article acting in accordance with § 8-508
6 of the Health Occupations Article;

7 (3) An authorized physician assistant licensed under Title 15 of the Health
8 Occupations Article acting in accordance with § 15-302.2 of the Health Occupations Article;
9 and

10 (4) A registered nurse employed by a local health department who complies
11 with:

12 (i) The formulary developed and approved under § 3-403(b) of this
13 article; and

14 (ii) The requirements established under § 8-512 of the Health
15 Occupations Article.

16 (c) This section may not be construed to otherwise expand the prescribing or
17 dispensing authority of an advanced practice registered nurse with prescriptive authority
18 or a physician assistant.

19 **(D) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A PHARMACIST**
20 **LICENSED UNDER TITLE 12 OF THE HEALTH OCCUPATIONS ARTICLE MAY DISPENSE**
21 **ANTIBIOTIC THERAPY PRESCRIBED IN ACCORDANCE WITH SUBSECTION (B) OF THIS**
22 **SECTION.**

23 **[(d)] (E)** The Secretary shall adopt regulations to implement the requirements
24 of this section in public and private health care settings in the State.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2017.
