A BILL ENTITLED

1 AN ACT concerning

2 **Code Revision – Maryland Vehicle Law – Penalties**

3 FOR the purpose of revising, restating, and recodifying the laws of this State relating to
4 penalties for violations of the Maryland Vehicle Law; repealing certain redundant
5 provisions; clarifying language; making certain technical and stylistic changes;
6 providing for the construction of this Act; providing for the effect and construction of
7 certain provisions of this Act; authorizing the publisher of the Annotated Code to
8 make certain corrections in a certain manner; and generally relating to the Maryland
9 Vehicle Law.

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
28 That the Laws of Maryland read as follows:

29 **Article – Transportation**

30 12–301.

31 (a) On application, the Administration shall issue an identification card to any
32 applicant who:

33 (1) Is a resident of this State;

34 (2) Does not have a driver’s license;

35 (3) Presents a birth certificate or other proof of age and identity acceptable
36 to the Administration;

1 (4) Provides satisfactory documentary evidence that the applicant has
2 lawful status;

3 (5) (i) Provides satisfactory documentary evidence that the applicant
4 has a valid Social Security number by presenting the applicant's Social Security
5 Administration account card or, if the Social Security Administration account card is not
6 available, any of the following documents bearing the applicant's Social Security number:

7 1. A current W-2 form;

8 2. A current SSA-1099 form;

9 3. A current non-SSA-1099 form; or

10 4. A current pay stub with the applicant's name and Social
11 Security number on it; or

12 (ii) Provides satisfactory documentary evidence that the applicant is
13 not eligible for a Social Security number; and

14 (6) Presents a completed application for an identification card on a form
15 furnished by the Administration.

16 (b) (1) Except as provided in paragraph (2) of this subsection, the
17 Administration shall establish a fee for the issuance of an identification card and for
18 issuance of a duplicate identification card.

19 (2) A fee is not required if the applicant for the card:

20 (i) Is 65 years old or older;

21 (ii) Is legally blind;

22 (iii) Has permanently lost the use of a leg or an arm;

23 (iv) Is permanently disabled so severely that the applicant cannot
24 move without the aid of crutches or a wheelchair; or

25 (v) Has a physical or mental impairment that substantially limits a
26 "major life activity" as defined in the federal Americans with Disabilities Act.

27 (c) A person may not commit any fraud in applying for an identification card
28 issued under this section.

29 (d) A person may not commit any misrepresentation in applying for an
30 identification card issued under this section.

1 (e) A person may not commit any fraud in using an identification card issued
2 under this section.

3 (f) A person may not make any misrepresentation in using an identification card
4 issued under this section.

5 (g) (1) An identification card shall be:

6 (i) Of the size and design that the Administration requires; and

7 (ii) Tamperproof, to the extent possible.

8 (2) The card shall contain:

9 (i) The name and address of the applicant;

10 (ii) The birth date of the applicant;

11 (iii) The sex of the applicant;

12 (iv) A description of the applicant;

13 (v) A color photograph of the applicant taken by the procedure that
14 the Administration requires;

15 (vi) The expiration date of the identification card;

16 (vii) The signature of the applicant; and

17 (viii) The signature and seal of the issuing agent.

18 (h) An identification card may be used as legal identification of the individual to
19 whom it is issued for any purpose.

20 (i) (1) Subject to paragraph (2) of this subsection, an identification card issued
21 to an applicant expires at the end of a period of not more than 8 years determined in
22 regulations adopted by the Administration.

23 (2) (i) If an applicant has temporary lawful status, the Administration
24 may not issue an identification card to the applicant for a period that extends beyond the
25 expiration date of the applicant's authorized stay in the United States or, if there is no
26 expiration date, for a period longer than 1 year.

27 (ii) Nothing contained in this paragraph may be construed to allow
28 the issuance of an identification card for a period longer than the period described in
29 paragraph (1) of this subsection.

1 (iii) The Administration shall indicate on the face and in the
2 machine-readable zone of a temporary identification card issued under this paragraph that
3 the card is a temporary identification card.

4 (3) An identification card may be renewed on application and payment of
5 the fee required by this section.

6 (j) The identification card shall be surrendered by the holder upon being issued
7 a Maryland driver's license.

8 (k) The Administrator may issue an identification card to an applicant:

9 (1) Whose privilege to drive has been refused, canceled, suspended, or
10 revoked; or

11 (2) Who has been issued a temporary license under § 16-205.1(b)(3)(iii) of
12 this article.

13 (l) (1) The Administration may cancel an identification card issued under this
14 section if the Administration determines that the holder of the identification card:

15 (i) Was not entitled to be issued the identification card;

16 (ii) Failed to provide accurate or required information in the
17 application for the identification card;

18 (iii) Fraudulently applied for or obtained the identification card; or

19 (iv) Is otherwise in violation of subsection (c), (d), (e), or (f) of this
20 section.

21 (2) If the Administration cancels an identification card under paragraph
22 (1) of this subsection, the holder of the identification card immediately shall surrender the
23 canceled identification card to the Administration.

24 **(M) (1) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (C) OR (D)**
25 **OF THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 3 YEARS OR A**
26 **FINE NOT EXCEEDING \$2,500 OR BOTH.**

27 **(2) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (E) OR (F)**
28 **OF THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 2 MONTHS OR A**
29 **FINE NOT EXCEEDING \$500 OR BOTH.**

5 (a) (1) Except as otherwise provided in this section or elsewhere in the
6 Maryland Vehicle Law, each motor vehicle, trailer, semitrailer, and pole trailer driven on
7 a highway shall be registered under this subtitle.

8 (2) If a motor vehicle required to be registered under this subtitle is not
9 registered, a person may not park the unregistered motor vehicle on any:

10 (i) Public alley, street, or highway; or

11 (ii) Private property used by the public in general, including parking
12 lots of shopping centers, condominiums, apartments, or town house developments.

13 (3) The provisions of paragraph (2) of this subsection do not apply to a
14 motor vehicle that is exempt from registration under this section or § 13-402.1 of this
15 subtitle.

16 (b) Except as otherwise expressly authorized in this title, the Administration may
17 not register or renew the registration of a vehicle unless the Administration has issued to
18 the owner a certificate of title of the vehicle or has received an application for the certificate
19 of title.

20 (c) Registration under this subtitle is not required for:

21 (1) A vehicle that is driven on a highway:

22 (i) In conformity with the provisions of this title relating to
23 manufacturers, transporters, dealers, secured parties, owners or operators of special mobile
24 equipment, or nonresidents; or

25 (ii) Under a temporary registration card issued by the
26 Administration;

27 (2) A vehicle owned and used by the United States, unless an authorized
28 officer or employee of the United States requests registration of the vehicle;

29 (3) A farm tractor or any farm equipment;

30 (4) A vehicle the front or rear wheels of which are lifted from the highway;

31 (5) A towed vehicle that is attached to the towing vehicle by a tow bar and
32 for which no driver is necessary;

1 (6) A vehicle owned by and in the possession of a licensed dealer for purpose
2 of sale;

3 (7) A vehicle owned by a new resident of this State during the first 60 days
4 of residency provided the vehicle displays valid registration issued by the jurisdiction of the
5 resident's former domicile;

6 (8) New vehicles being operated as part of a shuttle, as defined in § 13–626
7 of this title, while following a registered vehicle displaying a shuttle permit issued by the
8 Administration;

9 (9) A vehicle operated in connection with maritime commerce exclusively
10 within any terminal owned or leased by the Maryland Port Administration;

11 (10) A snowmobile that is operated on highways and roadways as prescribed
12 by § 25–102(a)(14) of this article;

13 (11) A golf cart that is operated on a highway on Smith Island, provided that
14 the golf cart is equipped with lighting devices as required by the Administration if it is
15 operated on a highway between dusk and dawn;

16 (12) A golf cart that is operated on a highway in the City of Crisfield,
17 Somerset County, in accordance with § 21–104.2 of this article;

18 (13) A golf cart that is operated on an Allegany County highway as allowed
19 by the county under § 25–102(a)(16) of this article; or

20 (14) A vehicle owned by an accredited consular or diplomatic officer of a
21 foreign government and operated for official or personal purposes when the vehicle displays
22 a valid diplomatic license plate issued by the United States government.

23 (d) (1) If a motor vehicle, trailer, or semitrailer is registered in another state,
24 displays current registration plates issued for it by that state, and is brought into this State
25 by a nonresident for transporting seasonal farm workers to be employed on farms in this
26 State or for work incidental to seasonal crop operations on farms in this State, the vehicle
27 need not be registered in this State if:

28 (i) The vehicle is being used as an incidental part of harvesting
29 operations within a distance of not more than 35 miles from the source of the crop; and

30 (ii) The owner of the vehicle has obtained an exemption permit for
31 the vehicle, as provided in this subsection.

32 (2) When the Administration receives a certification by the Secretary of
33 State Police that a vehicle is entitled to an exemption under this subsection, the
34 Administration shall issue an exemption permit on the form the Secretary of State Police

1 approves. The form shall be carried at all times by the driver of the vehicle for which it is
2 issued or in a conspicuous place on the vehicle.

3 (3) The exemption permit is:

4 (i) Valid for a period of 90 days from the date of issue; and

5 (ii) Eligible for renewal under the procedure set forth in this
6 subsection for an additional period of not more than 90 days in any 1 calendar year.

7 (4) The Secretary of State Police:

8 (i) May require a certificate of inspection of the equipment of the
9 vehicle; and

10 (ii) Shall require a certificate of insurance by a company authorized
11 to do business in this State, certifying that the vehicle is insured to the same extent as
12 required of vehicles registered in this State.

13 (e) Except for members elected from this State, if a member of the United States
14 Congress resides in this State during his term of office in the Congress, he need not register
15 his vehicles in this State during that time.

16 (f) A trailer or semitrailer operated in intrastate service need not be registered
17 in this State if:

18 (1) It is registered in another state;

19 (2) The truck tractor or other vehicle that is towing it is registered in this
20 State; and

21 (3) The registered owner of the truck tractor or other towing vehicle has at
22 least one trailer or semitrailer registered in this State for each truck tractor also registered
23 in this State.

24 (g) (1) A trailer or semitrailer rented or leased in intrastate service need not
25 be registered in this State if, subject to paragraph (2) of this subsection:

26 (i) The trailer or semitrailer has a chassis weight of 1,000 pounds or
27 less;

28 (ii) The trailer or semitrailer is registered in another state; and

29 (iii) The owner of the trailer or semitrailer annually has registered in
30 this State a number of these trailers and semitrailers that is at least equal to the average
31 number of these trailers and semitrailers that the owner annually will have available in
32 this State for rent or lease in intrastate service.

1 (2) If a person claims exemption for a trailer or semitrailer under this
2 subsection, the person shall file annually with the Administration, at the time and in the
3 manner that the Administration requires, an affidavit that sets forth, as to all such trailers
4 and semitrailers that the person has available in all states for rent or lease:

5 (i) The total number annually registered in all states;

6 (ii) The total number annually registered in this State; and

7 (iii) The average total number annually available for rent or lease in
8 this State.

9 (h) (1) A motor vehicle rented in intrastate service need not be registered in
10 this State if, subject to paragraph (3) of this subsection:

11 (i) The motor vehicle is registered in another state; and

12 (ii) The owner of the motor vehicle annually has registered in this
13 State a percentage of the total number of these motor vehicles in a rental fleet as
14 determined under paragraph (2) of this subsection.

15 (2) The percentage of the total number of motor vehicles in a rental fleet
16 that must be registered in this State is determined by dividing the gross revenue received
17 in the preceding year for the use of such rental vehicles arising from all motor vehicle rental
18 transactions occurring in this State by the total gross revenue received in the preceding
19 year for the use of such rental vehicles arising from all motor vehicle rental transactions
20 occurring in all jurisdictions in which the rental fleet is operated. The resulting percentage
21 shall be applied to the total number of motor vehicles in the rental fleet and that figure, to
22 the nearest whole number, shall be the number of rental motor vehicles that shall be fully
23 registered and titled in this State.

24 (3) If a person claims exemption for a motor vehicle under this subsection,
25 the person shall file annually with the Administration, at the time and in the manner that
26 the Administration requires, an affidavit that sets forth, as to all such motor vehicles that
27 the person has available in all states for rent:

28 (i) The gross revenue received in the preceding year for the use of
29 such rental motor vehicles arising from all motor vehicle rental transactions occurring in
30 Maryland; and

31 (ii) The total gross revenue received in the preceding year for the use
32 of such rental motor vehicles arising from all motor vehicle rental transactions occurring
33 in all jurisdictions.

1 ~~[(4)]~~ **(1)** **(1)** A person [who rents] **MAY NOT RENT** to another person a
 2 motor vehicle or [attempts] **ATTEMPT** to rent to another person a motor vehicle in this
 3 State in violation of [any of the provisions of] this section [is guilty of a misdemeanor].

4 ~~[(i)]~~ **(2)** A person [who drives or attempts] **MAY NOT DRIVE OR ATTEMPT** to
 5 drive a vehicle on any highway in this State in violation of [any of the provisions of] this
 6 section [is guilty of a misdemeanor].

14 (a) A nonresident may drive or permit the driving of a foreign vehicle in this State,
 15 without registering the vehicle in this State, if:

16 (1) At all times while driven in this State, the vehicle:

17 (i) Is registered in and displays current registration plates issued
 18 for it in the owner's place of residence; and

19 (ii) Carries as provided in § 13–409(a) of this subtitle, a current
 20 registration card issued for it in the owner's place of residence; and

21 (2) Except as otherwise provided in this section or under an agreement in
 22 compliance with Title 12, Subtitle 4 of this article, the vehicle is not:

23 (i) Used for transporting persons for hire, compensation, or profit;

24 (ii) Regularly operated in carrying on business in this State;

25 (iii) Designed, used, or maintained primarily for the transportation
 26 of property; or

27 (iv) In the custody of any resident for more than 30 days during any
 28 registration year.

29 (b) With the approval of the Governor, the Administration may permit a foreign
 30 vehicle to be driven in this State by:

1 (1) Issuing complimentary guest cards, permits, or licenses to persons
2 visiting this State from any foreign country; or

3 (2) Recognizing and permitting the use of guest cards, permits, or licenses
4 granted by other states.

5 (c) If a nonresident is a member of the armed forces of the United States or of the
6 United States Public Health Service and is serving on active duty in this State or an
7 adjoining state or the District of Columbia, the nonresident need not register his personal
8 passenger vehicles in this State if the vehicles are registered in the state of his residence.

9 (d) If a nonresident is a student enrolled in an accredited school, college, or
10 university of this State or of a bordering state or is serving a medical internship in this
11 State, the nonresident need not register his vehicles in this State if:

12 (1) The state of which the nonresident is a resident extends the same
13 privileges to the residents of this State; and

14 (2) The nonresident meets the required security provisions of the Maryland
15 Vehicle Law as to any vehicle to which this exemption applies.

16 (e) (1) Except as provided in paragraphs (2) and (3) of this subsection, if a
17 nonresident temporarily maintains or occupies a dwelling in this State for a period in excess
18 of 30 days but not in excess of 1 year, the nonresident shall obtain a nonresident's permit
19 from the Administration, in lieu of registration, within 10 days immediately following the
20 30-day period.

21 (2) A nonresident exempt from registration under subsection (d) of this
22 section shall obtain a nonresident's permit from the Administration, in lieu of registration,
23 within 30 days of maintaining or occupying a dwelling in this State.

24 (3) A nonresident exempt from registration under subsection (c) of this
25 section may obtain a nonresident's permit from the Administration, in lieu of registration,
26 if the permit application is made within 10 days immediately following the 30-day period.

27 (4) (i) On application, a nonresident's permit may be issued by the
28 Administration, or an agent designated by the Administration, in a form determined by the
29 Administration.

30 (ii) For each nonresident permit it issues, an agent designated by the
31 Administration may collect a fee not to exceed \$4 in addition to the nonresident permit fee
32 to offset expenses incurred in the issuance of nonresident permits.

33 (5) The application shall be accompanied by:

34 (i) A fee established by the Administration;

1 (ii) Evidence to reasonably establish that the applicant has a
 2 domicile outside of this State and is not a resident as defined in § 11–149 of this article;
 3 and

4 (iii) Evidence that the nonresident meets the required security
 5 provisions of the Maryland Vehicle Law.

6 (6) The nonresident permit shall be displayed on the windshield of the
 7 nonresident’s exempt vehicle in the place and manner prescribed by the Administration.

8 (7) (i) A nonresident permit issued under paragraph (1) or (2) of this
 9 subsection shall be issued for a period not to exceed 1 year.

10 (ii) A nonresident permit issued under paragraph (3) of this
 11 subsection shall be valid until the expiration date of the registration plates of the vehicle
 12 to which it is issued.

13 (iii) 1. A nonresident permit issued under paragraph (2) of this
 14 subsection may be renewed annually in accordance with the nonresident’s eligibility for the
 15 exemption provided in subsection (d) of this section.

16 2. A renewal fee established by the Administration shall be
 17 paid at the time of renewal.

18 (8) (i) Of the funds collected under paragraphs (5)(i) and (7)(iii)2 of this
 19 subsection, the Administration shall retain an amount equal to its administrative costs
 20 under this section.

21 (ii) Any excess funds shall be credited to the Gasoline and Motor
 22 Vehicle Revenue Account for distribution as highway user revenues in accordance with §§
 23 8–403 and 8–404 of this article.

24 (f) A person [who drives or attempts] **MAY NOT DRIVE OR ATTEMPT** to drive a
 25 vehicle on any highway in this State in violation of [any of the provisions of] this section
 26 [is guilty of a misdemeanor].

27 REVISOR’S NOTE: Subsection (f) of this section is revised in standard language

34 (a) (1) In this subtitle the following words have the meanings indicated.

1 (2) “Certified nurse practitioner” means an individual who is licensed by
2 the State Board of Nursing to practice registered nursing as described in § 8–101 of the
3 Health Occupations Article and who is certified as a nurse practitioner by the State Board
4 of Nursing.

5 (3) “Licensed chiropractor” means a chiropractor who is licensed by the
6 State Board of Chiropractic and Massage Therapy Examiners to practice chiropractic or
7 chiropractic with the right to practice physical therapy as described in § 3–301 of the Health
8 Occupations Article.

9 (4) “Licensed optometrist” means an optometrist who is licensed by the
10 State Board of Examiners in Optometry to practice optometry as described in § 11–101 of
11 the Health Occupations Article.

12 (5) “Licensed physical therapist” means a physical therapist who is
13 licensed by the State Board of Physical Therapy Examiners to practice physical therapy as
14 described in § 13–101 of the Health Occupations Article.

15 (6) “Licensed physician” means a physician, including a doctor of
16 osteopathy, who is licensed by the State Board of Physicians to practice medicine as
17 described in § 14–101 of the Health Occupations Article.

18 (7) “Licensed physician assistant” means an individual who is licensed
19 under Title 15 of the Health Occupations Article to practice medicine with physician
20 supervision.

21 (8) “Licensed podiatrist” means a podiatrist who is licensed by the State
22 Board of Podiatric Medical Examiners to practice podiatry as described in § 16–101 of the
23 Health Occupations Article.

24 (b) (1) The owner of any vehicle described in paragraph (3) of this subsection
25 may apply to the Administration for the assignment to that vehicle of a special disability
26 registration number and special disability registration plates, if a certified nurse
27 practitioner, licensed physician, licensed physician assistant, licensed chiropractor,
28 licensed optometrist, licensed podiatrist, or licensed physical therapist certifies, in
29 accordance with paragraph (2) of this subsection, that the applicant:

30 (i) Has lung disease to such an extent that forced (respiratory)
31 expiratory volume for one second when measured by spirometry is less than one liter, or
32 arterial oxygen tension (PO₂) is less than 60 mm/hg on room air at rest;

33 (ii) Has cardiovascular disease limitations classified in severity as
34 Class III or Class IV according to standards accepted by the American Heart Association;

35 (iii) Is unable to walk 200 feet without stopping to rest;

1 (iv) Is unable to walk without the use of, or assistance from, a brace,
2 cane, crutch, another person, prosthetic device, or other assistive device;

3 (v) Requires a wheelchair for mobility;

4 (vi) Has lost a foot, leg, hand, or arm;

5 (vii) Has lost the use of a foot, leg, hand, or arm;

6 (viii) Has a permanent impairment of both eyes so that:

7 1. The central visual acuity is 20/200 or less in the better eye,
8 with corrective glasses; or

9 2. There is a field defect in which the peripheral field has
10 contracted to such an extent that the widest diameter of visual field subtends an angular

26 sold by a licensed vehicle dealer, an obligor, or an agent under which the obligor agrees to
27 perform over a fixed period of time, for a specific duration, and for a specific identifiable
28 price, provided that the purchase of the contract is optional to the purchaser, any of the
29 following services:

30 1. The repair, replacement, or maintenance of a motor
31 vehicle, or the indemnification for the repair, replacement, or maintenance of a motor
32 vehicle, for the operational or structural failure of the motor vehicle due to a defect in
33 materials, workmanship, or normal wear and tear, with or without additional provisions

1 for incidental payment of indemnity for services including towing, rental and emergency
2 road service, and road hazard protection;

3 2. The repair, replacement, or maintenance of a motor
4 vehicle for the operational or structural failure of one or more parts or systems of the motor
5 vehicle brought about by the failure of an additive product to perform as represented;

6 3. The repair or replacement of tires or wheels on a motor
7 vehicle damaged as a result of coming into contact with road hazards, including potholes,
8 rocks, wood debris, metal parts, glass, plastic, curbs, or composite scraps;

9 4. The removal and repair of dents, dings, or creases on a
10 motor vehicle using the process of paintless dent removal;

11 5. The repair of chips or cracks in, or the replacement of,

20 under § 2–314 of the Commercial Law Article.

21 (l) A person that sells a mechanical repair contract may not, directly or indirectly,
22 make a false, deceptive, or misleading statement with respect to:

23 (1) The person's affiliation with a motor vehicle manufacturer,
24 manufacturer's subsidiary, distributor, factory branch, or dealer;

30 promissory note or other evidence of indebtedness on a vehicle sales contract knowing that
31 it requires the debtor to pay an amount greater than that agreed on in the written contract

1 (e) A dealer or an agent or employee of a dealer may not willfully fail to perform,
2 without justification, any vehicle sales contract.

16 SUBTITLE.

17 (II) THE REGISTERED OWNER OF THE VEHICLE HAS THE
18 BURDEN OF PROVING THAT A BONA FIDE SALE, GIFT, OR OTHER TRANSFER OF THE
19 VEHICLE HAS OCCURRED.

20 (D) (1) THE REGISTERED OWNER OF A VEHICLE IMPOUNDED OR
21 IMMOBILIZED UNDER THIS SECTION IS RESPONSIBLE FOR ALL ACTUAL COSTS
22 INCURRED AS A RESULT OF THE IMMOBILIZATION OF THE VEHICLE OR THE TOWING,
23 PRESERVING, AND STORING OF THE IMPOUNDED VEHICLE.

24 (2) THE COURT MAY REQUIRE THE REGISTERED OWNER OF A

15 **(2) THE NOTICE SHALL:**

16 **(I) STATE THAT THE VEHICLE HAS BEEN IMMOBILIZED OR**
17 **IMPOUNDED BY BEING TAKEN INTO CUSTODY;**

18 **(II) DESCRIBE THE YEAR, MAKE, MODEL, AND VEHICLE**
19 **IDENTIFICATION NUMBER OF THE VEHICLE;**

20 **(III) PROVIDE THE LOCATION WHERE THE VEHICLE IS**
21 **IMMOBILIZED OR THE LOCATION OF THE FACILITY WHERE THE VEHICLE IS**
22 **IMPOUNDED;**

23 **(IV) INCLUDE THE AMOUNT OF THE ACTUAL COSTS OF**
24 **IMMOBILIZATION OR TOWING, PRESERVATION, AND STORAGE OF AN IMPOUNDED**
25 **VEHICLE;**

26 **(V) INCLUDE THE AMOUNT OF THE ACTUAL COSTS OF THE**
27 **NOTICES REQUIRED UNDER THIS SUBSECTION; AND**

28 **(VI) PROVIDE THAT, IF AN IMPOUNDED VEHICLE IS NOT**

1 **(3) IF AN IMPOUNDED VEHICLE IS NOT RECLAIMED WITHIN 10 DAYS**
2 **AFTER THE DATE SPECIFIED IN A COURT ORDER UNDER THIS SECTION, THE VEHICLE**
3 **SHALL BE CONSIDERED AN ABANDONED VEHICLE SUBJECT TO TITLE 25, SUBTITLE**

5 **(G) (1) THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A**
6 **LIENHOLDER FROM EXERCISING ITS RIGHTS UNDER APPLICABLE LAW, INCLUDING**

1 **(II) IF THE VEHICLE HAS BEEN REPOSSESSED OR OTHERWISE**
2 **LAWFULLY TAKEN BY THE LIENHOLDER AND THE TIME SPECIFIED BY A COURT**
3 **ORDER UNDER THIS SECTION HAS NOT EXPIRED, THE LIENHOLDER SHALL RETURN**
4 **THE VEHICLE WITHIN 21 DAYS AFTER THE REDEMPTION TO THE POLICE**
5 **DEPARTMENT THAT IMPOUNDED OR IMMOBILIZED THE VEHICLE.**

6 **(H) THIS SECTION DOES NOT AFFECT THE REQUIREMENTS OF TITLE 25,**
7 **SUBTITLE 2 OF THIS ARTICLE REGARDING ABANDONED VEHICLES.**

25 motor vehicle for a period of 60 days if convicted under the laws of this State or any other
26 state of 2 serious traffic violations arising from separate incidents occurring within a
27 3-year period committed:

28 (1) While operating a commercial motor vehicle; or

29 (2) While holding a commercial instructional permit or commercial driver's
30 license and operating a noncommercial vehicle, and the conviction would result in
31 suspension, revocation, or cancellation of the driver's license.

32 (g) The Administration shall disqualify any person from driving a commercial
33 motor vehicle for a period of 120 days if convicted under the laws of this State or any other
34 state of 3 serious traffic violations arising from separate incidents occurring within a
35 3-year period committed:

36 (1) While operating a commercial motor vehicle; or

1 (2) While holding a commercial instructional permit or commercial driver's
2 license and operating a noncommercial motor vehicle, and the conviction would result in
3 suspension, revocation, or cancellation of the driver's license.

4 (h) The Administration may disqualify a person from driving a commercial motor
5 vehicle for a controlled dangerous substance offense in the manner provided under Article
6 41, Title 1, Subtitle 5 of the Code.

7 (i) (1) In this subsection the following terms have the meanings indicated:

8 (i) "Commercial motor vehicle" means:

9 1. A "commercial motor vehicle" as defined in § 16-803 of this
10 subtitle; and

11 2. Except as provided in § 16-803(c)(2) of this subtitle, any
12 self-propelled or towed vehicle used on a public highway to transport passengers or
13 property, if the vehicle has a gross vehicle weight rating of 10,001 or more pounds.

14 (ii) "Out-of-service order" means a declaration by an authorized
15 enforcement officer of a federal, State, Canadian, Mexican or local jurisdiction that a driver,
16 a commercial motor vehicle, or a motor carrier operation, is put out of service pursuant to
17 Title 49, §§ 386.72, 392.5, 392.9A, 395.13, and 396.9 of the Code of Federal Regulations,
18 compatible laws, or the North American Uniform Out-of-Service Criteria.

19 (2) A driver who is convicted of violating an out-of-service order while
20 driving a commercial motor vehicle is [disqualified]:

21 **(I) DISQUALIFIED** for the period of time specified in regulation by
22 the United States Secretary of Transportation; **AND**

23 **(II) SUBJECT TO THE CIVIL PENALTIES SPECIFIED IN**
24 **REGULATION BY THE UNITED STATES SECRETARY OF TRANSPORTATION.**

25 (j) A driver who is convicted of a violation of any of the provisions of §§ 21-701

4 license has been issued, that the applicant has falsified any information or certification

6 commercial driver's license, the Administration shall suspend, cancel, or revoke the
7 commercial instructional permit or commercial driver's license or pending application, or
8 disqualify the person from operating a commercial motor vehicle, for a period of not less
9 than 60 days.

10 (3) The Administration shall cancel the commercial driver's license of any
11 individual who fails to submit to the Administration a current certificate of physical
12 examination, as required under 49 C.F.R. § 391.43 and § 391.45.

13 (l) After suspending, revoking, or canceling a commercial instructional permit or
14 commercial driver's license, or after disqualifying a person who holds a commercial
15 instructional permit or commercial driver's license from operating a commercial motor
16 vehicle, the Administration shall update its records to reflect that action within 10 days.

17 (m) After suspending, revoking, or canceling a nonresident commercial driver's
18 privilege, or after disqualifying a nonresident driver from operating a commercial motor
19 vehicle, the Administration shall notify the licensing authority of the state which issued
20 the commercial instructional permit or commercial driver's license within 10 days.

21 (n) An individual who is disqualified from driving a commercial motor vehicle
22 under this section shall surrender the individual's driver's license to the Administration.

23 (o) (1) The Administration may issue a noncommercial driver's license of an
24 appropriate class to an individual who is disqualified or whose commercial driver's license
25 is canceled under this section if:

26 (i) The individual surrenders the commercial instructional permit
27 or commercial driver's license; and

28 (ii) The individual's driving privilege is not otherwise refused,
29 suspended, revoked, or canceled in this State or any other state.

30 (2) (i) The Administration may immediately reinstate an individual's
31 noncommercial driving privilege and, subject to subparagraph (ii) of this paragraph, issue
32 a noncommercial driver's license of an appropriate class to an individual whose commercial
33 driver's license is canceled under subsection (k)(3) of this section if:

34 1. The cancellation results solely from the failure to submit
35 a certificate of physical examination;

36 2. The individual's driving privilege is not expired; and

1 3. The individual's driving privilege is not otherwise refused,
2 suspended, revoked, or canceled in this State or any other state.

4 license under this paragraph unless the individual surrenders the commercial driver's

10 permit or commercial driver's license under this paragraph when the applicant pays any
11 required fees.

12 (2) On termination of a disqualification period of at least 1 year, an
13 individual may apply for a new commercial instructional permit or commercial driver's

15 (3) The Administration shall issue a commercial instructional permit or
16 commercial driver's license to the applicant when the applicant:

17 (i) Passes the skills and knowledge tests required by this subtitle;

18 (ii) Is eligible to drive pursuant to the Commercial Driver's License

20 (iii) Surrenders any previously issued driver's instructional permit or

22 (iv) Pays the fees required by § 16-818(a)(1) of this subtitle.

23 (q) If an individual is disqualified based on multiple offenses committed at the

25 of the same incident, the Administration:

 27 Fire Marshal or from a propane industry source.

28 (2) The vehicle identification decal required by this section shall be a

6 (a) A person may not sell or offer for sale any tire that has been regrooved or recut
7 unless:

10 by the United States Department of Transportation.

11 (b) A person may not sell or transfer any vehicle that is equipped with regrooved
12 or recut tires, unless the tires comply with the requirements of subsection (a) of this section.

13 (c) A person may not drive or otherwise move on any highway in this State any
14 vehicle that is equipped with regrooved or recut tires, unless the tires comply with the
15 requirements of subsection (a) of this section.

16 (d) A person may not sell, offer for sale, or have in his possession with intent to

18 fact being plainly shown by a marking or label in the English language on the shoulder

 11 system in constant operation when the vehicle's ignition is engaged.

21 which an inspection certificate or a repair order certification has been issued under this

23 (k) A person may not willfully violate any rule or regulation adopted under this
24 subtitle relating to inspection procedures and inspection station requirements.

25 **(L) A PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT TO**

2 meet the requirements established under this subtitle.

8 (a) The operation of a diesel vehicle on any highway in this State constitutes the
9 consent of the driver and owner of the diesel vehicle to be subject to an emissions test

12 to stop the diesel vehicle and submit it to an emissions test administered by an emissions
13 inspector:

14 (1) When a diesel vehicle is required to submit to:

15 (i) Weighing and measuring under § 24-111 of this article; or

16 (ii) A motor carrier safety inspection under § 25-111 of this article;

17 or

18 (2) At any location or time, when a police officer has reasonable cause to
19 believe that an individual diesel vehicle is violating emissions standards established under
20 this subtitle.

21 (C) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (B) OF THIS

31 (a) (1) In this section the following words have the meanings indicated.

1 (2) “Primary connecting system” means the combination of devices and
2 their attaching structures that are used to connect a towed vehicle to a towing vehicle.

3 (3) “Safety chain” means a flexible tension member connected from the
4 front of the towed vehicle to the rear of the towing vehicle for the purpose of retaining the
5 connection between the towed and towing vehicles if the connection provided by the
6 primary connecting system fails.

7 (4) “Tow dolly” means a vehicle having a tongue or towbar attachment
8 designed to tow other vehicles and used to tow:

9 (i) Another vehicle when the front or rear wheels of the towed
10 vehicle are placed in a cradle-like device that lifts the wheels from the highway; or

11 (ii) A trailer or semitrailer when the towing vehicle has a fifth-wheel
12 attachment device.

13 (5) “Towbar” means a strut or column-like device temporarily attached
14 between the rear of a towing vehicle and the front of the towed vehicle.

15 (b) When towing another vehicle, the driver shall ensure that:

16 (1) The towed vehicle is securely attached to the towing vehicle by a
17 primary connecting system;

18 (2) The connection used is:

19 (i) Structurally adequate for the weight drawn; and

20 (ii) Mounted properly and securely, without excessive slack, but with
21 enough slack to allow for articulation of the connection;

22 (3) The locking device that prevents separation of the towed and towing
23 vehicles is working properly and is locked in place; and

24 (4) One or more safety chains are attached to the towed vehicle and the
25 frame of the towing vehicle and have no more slack than is necessary for proper turning.

26 (c) Attachment of the safety chains to the pintle hook does not satisfy the
27 requirements of this section.

28 (d) Except for the connection between any two vehicles carrying poles, pipes,
29 machinery, or other objects that cannot be readily dismembered, the connection between
30 vehicles may not exceed 15 feet.

1 (e) A connection made with a fifth-wheel connection device is not required to use
2 safety chains or cables as additional securing devices.

3 (f) If a vehicle is towed by a rope, chain, or cable, a driver must be in and capable
4 of steering the towed vehicle.

5 (g) A primary connecting system used in a combination of vehicles shall be
6 designed, constructed, and installed to insure that a towed vehicle does not shift or swerve
7 more than 6 inches to either side of the path of the towing vehicle while the towing vehicle
8 is moving in a straight line on a level, smooth, paved surface.

9 (h) While one vehicle is towing another and the connection is a chain, rope, or
10 cable, a white, red, or orange-fluorescent warning flag or cloth at least 18 inches square
11 shall be displayed on the connection.

30 (a) (1) In this section and in § 24-111.1 of this subtitle the following words
31 have the meanings indicated.

32 (2) "CVISN" means the Commercial Vehicle Information Systems and
33 Network, a motor carrier program managed by the Department, together with other State
34 agencies.

1 (3) “CVISN transponder” means an electronic device acquired by motor
2 carriers to allow electronic signaling through CVISN.

3 (4) “Police officer” means:

4 (i) Any uniformed police officer;

5 (ii) Any civilian employee of the Department of State Police or the
6 Maryland Transportation Authority Police assigned to enforce this subtitle, but only while
7 acting under written authorization of the Secretary of State Police; or

8 (iii) Any civilian employee of a local government who is:

9 1. Acting under the immediate direction and control of a
10 uniformed police officer;

11 2. Acting under written authorization of the Secretary of
12 State Police; and

13 3. Certified by the Department of State Police to perform the
14 weighing and measurement authorized under this section.

15 (b) (1) The driver of a vehicle must stop and submit the vehicle to a
16 measurement or weighing:

17 (i) When directed by a police officer who has reason to believe that
18 the size or weight of a vehicle being driven on a highway violates this subtitle; or

19 (ii) When directed by an electronic signal to a CVISN transponder.

20 (2) The weighing authorized by this subsection:

21 (i) May be done with either portable or stationary scales; and

22 (ii) In either case, shall be done by methods established by experts
23 in the field of weights and measures and adopted by rule or regulation of the Department
24 of State Police.

25 (3) If more than 1 statutory weight limit tolerance applies to a vehicle being
26 weighed under this section, the police officer shall grant only the greatest applicable
27 tolerance.

28 (c) The operation of a vehicle on any highway in this State constitutes the consent
29 of the driver and the owner of the vehicle to the measurement and weighing provided for
30 in this section.

1 (d) (1) The driver of a vehicle shall obey every sign and every direction of a
 2 police officer or an electronic signal to a CVISN transponder to stop the vehicle and submit
 3 it to measurement or weighing.

4 (2) If a driver fails or refuses to comply with the direction of a police officer
 5 or an electronic signal to a CVISN transponder to submit a vehicle to measurement or
 6 weighing, the police officer shall have the authority to take the vehicle and its load into
 7 temporary custody for the purpose of weighing and measuring.

8 (3) The police officer may utilize resources specified in [§ 27–111(b)] §
 9 **16–303.1(B)** of this article to conduct the weighing or measuring.

10 (4) In addition to any fine or penalty attributable to the weighing and
 11 measuring, or other offense, the driver is[:

12 (i) Subject to a fine and penalty specified in § 27–101(l) of this
 13 article; and

14 (ii) Responsible] **RESPONSIBLE** for any actual costs incurred in
 15 weighing and measuring the vehicle and its load because of the driver’s failure or refusal
 16 to comply with the direction of a police officer or an electronic signal to a CVISN
 17 transponder.

18 (e) A sign used to direct vehicles under this section may be displayed only by a
 19 police officer who is assigned to enforce this title.

20 **(F) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (D) OR (E) OF**
 21 **THIS SECTION IS SUBJECT TO:**

22 **(1) FOR A FIRST OFFENSE, A FINE NOT EXCEEDING \$1,000;**

23 **(2) FOR A SECOND OFFENSE, A FINE NOT EXCEEDING \$2,000; AND**

24 **(3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING**
 25 **\$3,000.**

26 REVISOR’S NOTE: Subsection (f) of this section is new language derived without

 28 section.

29 In subsection (d)(4) of this section, the former reference to penalties “specified
 30 in § 27–101(l) of this article” is deleted as unnecessary in light of the
 31 incorporation of those penalties into this section.

32 The Department of Legislative Services notes, for consideration by the
 33 General Assembly, that the source law for this revised section imposes two

1 separate duties on drivers. Under subsection (b) of this section, a driver is
2 required to stop and submit a vehicle to measurement or weighing when
3 directed by (1) a police officer “who has reason to believe” that a size or weight
4 violation exists; or (2) a commercial vehicle information systems and network
5 signal (CVISN). Under subsection (d) of this section, a driver is required to
6 obey a signal or direction of a police officer or a CVISN transponder to stop

18 (a) Except as otherwise provided in this section, as to any vehicle found to exceed
19 the weight limits permitted under this subtitle, if the overweight does not exceed 5,000
20 pounds, a police officer may require the driver to unload the excess weight.

21 (b) Except as otherwise provided in this section, as to any vehicle found to exceed
22 the weight limits permitted under this subtitle, if the overweight exceeds 5,000 pounds, the
23 vehicle may not be moved until the excess weight is unloaded.

24 (c) Except on interstate highways, if an overweight vehicle bears registration
25 plates issued by this State and is transporting liquid milk in bulk from the producer, the
26 vehicle may be granted a 5 percent tolerance on the applicable registration or statutory

11 **(3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING**
 12 **\$3,000.**

13 REVISOR'S NOTE: Subsection (g) of this section is new language derived without
 14 substantive change from former § 27-101(l) of this article, as it related to this
 15 section.

16 In the introductory language of subsection (g) of this section, the
 17 cross-reference to subsection (e) of this section is substituted for the former
 18 cross-reference to subsection (e)(2) of this section for accuracy. Chapter 177 of
 19 2012 amended § 24-111.1 of this article to be in its present form. Before
 20 Chapter 177 was enacted, subsection (e)(1) of the former law authorized the
 21 driver of a vehicle with an overweight load of perishable products to proceed
 22 to the vehicle's destination if it was the first perishable load overweight
 23 violation by the driver in the calendar year. Subsection (e)(2) of the former law
 24 established a duty for a second or subsequent violation in a calendar year that
 25 any excess weight be unloaded before moving the vehicle. Section 27-101(l) of
 26 this article provided enhanced penalties for failure to unload excess perishable
 27 goods under subsection (e)(2) of the former law (the only provision of
 28 subsection (e) that imposed a duty on the driver). Chapter 177, however,
 29 rewrote § 24-111.1(e) of this article to authorize the driver of a vehicle with
 30 an overweight load of perishable products to proceed to the vehicle's

1 **(3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING**
2 **\$3,000.**

6 (a) (1) When located on the right-of-way of any State highway, a mobile
7 seafood or produce vendor may not sell, or offer for sale, any seafood or produce, unless the
8 vendor has a lease from the State that allows the vendor to sell, or offer for sale, seafood or
9 produce.

10 (2) The State may require a mobile seafood or produce vendor to submit an
11 application and pay a reasonable fee to be applied to administrative costs.

12 (3) The State may not enter into a lease with a mobile produce vendor
13 unless the applicable county licenses mobile produce vendors.

14 (b) A mobile seafood or produce vendor may not sell, or offer for sale, any seafood
15 or produce, when located:

1 (a) [A violation of this subtitle is a misdemeanor punishable by the penalty
2 specified in § 27–101(b) of this article.

3 (b)] The charging of a person with a violation of this subtitle shall be by means of
4 a traffic citation in the form determined under § 1–605(d) of the Courts Article.

5 [(c)] (B) The charging of a person with a violation of this section may be
6 performed by any State or local police officer.

7 REVISOR'S NOTE: Subsection (a) of this section is repealed as unnecessary in light

15 (I) THE MAXIMUM WEIGHT LIMIT FOR WHICH THE VEHICLE OR
16 COMBINATION OF VEHICLES IS REGISTERED;

17 (II) A STATUTORY WEIGHT LIMIT; OR

18 (III) SUBJECT TO PARAGRAPH (2)(I) OF THIS SUBSECTION, THE
19 MAXIMUM WEIGHT LIMIT IMPOSED BY SIGNS THAT HAVE BEEN PLACED TO
20 REGULATE THE WEIGHT OF A VEHICLE PASSING OVER A BRIDGE OR CULVERT UNDER
21 § 24–206 OF THIS TITLE.

22 (2) THIS SECTION DOES NOT APPLY TO A PERSON WHO:

23 (I) VIOLATES A WEIGHT LIMIT IMPOSED BY SIGNS IF THERE
24 ARE NO SIGNS POSTING THE WEIGHT LIMIT LOCATED:

25 1. AT THE BRIDGE OR CULVERT; AND

26 2. BEFORE THE LAST AVAILABLE ALTERNATE ROUTE
27 THAT BYPASSES THE BRIDGE OR CULVERT; OR

28 (II) IS OPERATING AN EMERGENCY VEHICLE WHEN
29 RESPONDING TO AN EMERGENCY.

1 **(B) EXCEPT ON AN INTERSTATE HIGHWAY, A TOLERANCE OF 1,000 POUNDS**
2 **OVER A WEIGHT LIMIT TO WHICH THIS SECTION APPLIES IS ALLOWED, AND ONLY**
3 **WEIGHT IN EXCESS OF THIS TOLERANCE IS A VIOLATION, IF:**

4 **(1) THE OVERALL GROSS WEIGHT DOES NOT EXCEED 80,000 POUNDS,**
5 **INCLUDING ANY ENFORCEMENT OR STATUTORY TOLERANCES; OR**

6 **(2) THE VEHICLE IS BEING OPERATED UNDER A VALID PERMIT FOR**
7 **GROSS WEIGHT EXCEEDING 80,000 POUNDS.**

8 **(C) EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, A PERSON**
9 **CONVICTED OF A WEIGHT VIOLATION TO WHICH THIS SECTION APPLIES ON ANY**
10 **HIGHWAY IN THE STATE, INCLUDING AN INTERSTATE HIGHWAY, IS SUBJECT TO THE**
11 **FOLLOWING FINES:**

12 **(1) 1 CENT FOR EACH POUND FOR THE FIRST 1,000 POUNDS OF**
13 **WEIGHT OVER ANY ALLOWABLE WEIGHT;**

14 **(2) 5 CENTS FOR EACH POUND OF EXCESS WEIGHT OVER 1,000**
15 **POUNDS BUT LESS THAN 5,001 POUNDS;**

16 **(3) 12 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
17 **OVER 5,000 POUNDS BUT LESS THAN 10,001 POUNDS;**

18 **(4) 20 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
19 **OVER 10,000 POUNDS BUT LESS THAN 20,001 POUNDS; AND**

20 **(5) 40 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
21 **OVER 20,000 POUNDS.**

22 **(D) A PERSON CONVICTED OF A WEIGHT VIOLATION TO WHICH THIS**
23 **SECTION APPLIES ON THE WILLIAM PRESTON LANE, JR. MEMORIAL (CHESAPEAKE**
24 **BAY) BRIDGE, OR ITS APPURTENANT APPROACHES THAT ARE UNDER THE**
25 **JURISDICTION OF THE MARYLAND TRANSPORTATION AUTHORITY, IS SUBJECT TO**
26 **THE FOLLOWING FINES:**

27 **(1) 1 CENT FOR EACH POUND FOR THE FIRST 1,000 POUNDS OVER ANY**
28 **ALLOWABLE WEIGHT;**

29 **(2) 5 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT OVER**
30 **1,000 POUNDS BUT LESS THAN 2,001 POUNDS;**

1 **(3) 10 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
2 **OVER 2,000 POUNDS BUT LESS THAN 5,001 POUNDS;**

3 **(4) 24 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
4 **OVER 5,000 POUNDS BUT LESS THAN 10,001 POUNDS;**

5 **(5) 40 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
6 **OVER 10,000 POUNDS BUT LESS THAN 20,001 POUNDS; AND**

7 **(6) 80 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**
8 **OVER 20,000 POUNDS.**

9 **(E) IN COMPUTING A FINE UNDER THIS SECTION, A CREDIT FOR ANY EXCESS**
10 **WEIGHT CAUSED BY AN ACCUMULATION OF CINDERS, SNOW, OR ICE SHALL BE**
11 **GRANTED.**

12 **(F) NOTWITHSTANDING ANY OTHER LAW, A COURT MAY NOT SUSPEND OR**
13 **REDUCE A FINE IMPOSED FOR A CONVICTION FOR A WEIGHT VIOLATION.**

14 **(G) (1) IF AN OUT-OF-STATE VEHICLE IS SUBJECT TO A WEIGHT**
15 **VIOLATION OR AN OUT-OF-STATE PERSON IS RESPONSIBLE FOR OR OPERATING A**
16 **VEHICLE SUBJECT TO A WEIGHT VIOLATION:**

17 **(I) THE PERSON IS SUBJECT TO A CITATION AND FURTHER**
18 **PROCEEDINGS UNDER TITLE 26 OF THIS ARTICLE; OR**

19 **(II) THE VEHICLE SHALL BE IMPOUNDED UNTIL THE FINE IS**
20 **PAID OR ACCEPTABLE COLLATERAL IS POSTED.**

21 **(2) CARGO CONTAINED IN THE VEHICLE MAY NOT BE IMPOUNDED.**

22 **(3) IF THE FINE HAS NOT BEEN PAID OR ACCEPTABLE COLLATERAL**
23 **HAS NOT BEEN POSTED WITHIN 90 DAYS AFTER THE DATE OF IMPOUNDMENT, THE**
24 **VEHICLE MAY BE SOLD AT PUBLIC AUCTION UNDER THE JURISDICTION OF THE**
25 **COURT TO SATISFY THE FINE, ACCRUED INTEREST, AND COSTS.**

26 REVISOR'S NOTE: This section is new language derived without substantive
27 change from former § 27-105 of this article.

28 In the introductory language of subsection (a)(1) of this section, the former
29 inaccurate reference to a person who is "charged with" a weight violation is
30 deleted as the penalties implicitly apply to a person who is convicted of a
31 weight violation.

1 In subsection (a)(1)(i) of this section, the former redundant reference to the
2 maximum “registered” weight limit is deleted as included in the reference to
3 the maximum weight limit for which the vehicle “is registered”.

4 In subsection (a)(1)(ii) of this section, the former redundant reference to a
5 statutory weight limit “set forth in the Maryland Vehicle Law” is deleted as
6 included in the reference to weight violations under “the Maryland Vehicle
7 Law” in the introductory language of subsection (a)(1) of this section.

8 The introductory language of subsection (a)(2) of this section is added for
9 clarity and consistency with subsection (a)(1) of this section.

10 In subsection (a)(2)(i) of this section, the reference to posting the “weight limit”
11 is substituted for the former reference to posting the “restriction” for clarity
12 and consistency within this section.

13 In subsection (a)(2)(ii) of this section, the former clause “, as defined in §
14 11–118 of this article,” is deleted as unnecessary because all of the defined
15 terms in Title 11 of this article apply throughout the Maryland Vehicle Law.

16 In the introductory language of subsections (b), (c), and (d) of this section, the
17 references to a “weight limit [or violation] to which this section applies” are
18 substituted for the former references to a “registered weight limit, statutory
19 weight limit, or weight limit imposed by signs” for clarity and brevity.

20 In the introductory language of subsection (b) of this section, the former
21 reference to a “loading error” is deleted as included in the reference to a
22 “tolerance”.

23 In the introductory language of subsections (c) and (d) of this section, the
24 former references to fines “in addition to court costs” are deleted because court
25 costs are separate from and paid in addition to a fine for a traffic violation. *See*
26 § 7–301 of the Courts Article. In addition, prepay fines for traffic violations set
27 by the District Court in the penalty deposit schedule include court costs.

28 Also in the introductory language of subsections (c) and (d) of this section, the
29 former redundant references to “weight violations that occur” on any highway
30 or the Chesapeake Bay Bridge are deleted as included in the references to a
31 “weight violation to which this section applies” on any highway or the
32 Chesapeake Bay Bridge for clarity and brevity.

33 In subsection (f) and the introductory language of subsection (g)(1) of this
34 section, the references to a “weight” violation are added for clarity and
35 consistency within this section.

36 In subsection (f) of this section, the reference prohibiting “a court” from
37 suspending or reducing a fine is added for clarity.

1 In the introductory language of subsection (g)(1) of this section, the reference
2 to an out-of-state vehicle “subject to a weight violation” is substituted for the
3 former reference to an out-of-state vehicle “being operated at the time the
4 offense is committed” for clarity, brevity, and to more explicitly connect the
5 vehicle to the violation.

6 In subsection (g)(1)(i) of this section, the reference to a person being subject to
7 “a citation” and further proceedings is added for clarity.

8 Subsection (g)(2) of this section, formerly § 27–105(f)(2), is rewritten for clarity
9 and brevity.

10 In subsection (g)(2) of this section, the former clause “, and the cargo may not
11 be held” is deleted as implicit in the prohibition against impounding cargo.

12 The Department of Legislative Services notes, for consideration by the
13 General Assembly, that there are overlaps in the graduated schedules of
14 excess weight fines in subsections (c) and (d) of this section (*e.g.*, “over 5,000
15 pounds” and “less than 5,001 pounds”). The General Assembly may wish to
16 amend these subsections to eliminate the overlaps.

17 The Department of Legislative Services further notes, for consideration by the
18 General Assembly, that revised subsection (g)(1)(ii) of this section (former §
19 27–105(f)), among other things, requires the impoundment of an out-of-state
20 vehicle subject to a weight violation. This provision may well raise
21 constitutional issues under the federal “dormant” commerce clause, in that it
22 could be interpreted as interfering with interstate commerce. As a practical
23 matter, the Department of State Police states that it does not impound these
24 vehicles and has not done so for decades (if ever). The General Assembly may
25 wish to repeal this provision.

27 (a) (1) With the advice of the State Department of Education, the Motor
28 Vehicle Administration shall adopt and enforce rules and regulations not inconsistent with
29 the Maryland Vehicle Law to govern the safe operation of all school vehicles.

30 (2) The following shall be subject to the rules and regulations adopted
31 under this section:

32 (i) Every school or school district and its officers and employees;

33 (ii) Every person employed under contract by a school or school
34 district; and

35 (iii) Every person that owns or operates a school vehicle.

1 (b) (1) Any officer or employee of any school or school district who violates any
2 rule or regulation adopted under this section or fails to include the obligation to comply
3 with these rules and regulations in any contract executed by him on behalf of a school or
4 school district is guilty of misconduct and subject to removal from office or employment.

5 (2) (I) [Any] A person that owns or operates a school vehicle [and
6 violates] **MAY NOT VIOLATE** any rule or regulation adopted under this section [is guilty of
7 a misdemeanor and the].

8 (II) A vehicle involved **IN A VIOLATION UNDER SUBPARAGRAPH**
9 **(I) OF THIS PARAGRAPH** is subject to suspension or revocation of its registration.

10 REVISOR'S NOTE: Subsection (b)(2) of this section is revised in standard language
11 used to state a prohibition.

12 The former reference to being "guilty of a misdemeanor" is repealed as
13 unnecessary in light of § 27–101 of this article, which makes a violation of the
14 Maryland Vehicle Law a misdemeanor punishable by a \$500 fine, except as
15 otherwise provided.

16 25–111.

17 (a) (1) In this section the following words have the meanings indicated.

18 (2) (i) "Direct assistance" means the provision of transportation and
19 other relief services by a motor carrier or its drivers for the immediate restoration of
20 essential services or the delivery of essential supplies.

21 (ii) "Direct assistance" does not include:

22 1. Transportation related to the long-term rehabilitation of
23 damaged physical infrastructure; or

24 2. Routine commercial deliveries made after the initial
25 threat to life or property caused by a transportation emergency has passed.

26 (3) "Emergency relief" means an operation for which a motor carrier or
27 driver of a commercial motor vehicle, in response to a transportation emergency, provides
28 direct assistance to supplement State and local efforts and capabilities to save lives or
29 property or to protect public health or safety.

30 (4) "Essential services" includes electric or natural gas service, medical
31 care, sewer service, water service, telecommunications service, or telecommunication
32 transmissions.

1 (5) “Essential supplies” includes food or fuel.

2 (6) “Hazardous materials inspector” means a person who is assigned by the
3 Department of the Environment and certified by the Department of State Police to perform
4 an inspection authorized under this section.

5 (7) “Natural or man-made emergency” means a hurricane, a tornado, a
6 thunderstorm, a snowstorm, an ice storm, a blizzard, a flood, wind-driven water, a tidal
7 wave, a tsunami, an earthquake, a volcanic eruption, a mud slide, a drought, a forest fire,
8 an explosion, an electricity blackout, or any other similar occurrence.

9 (8) “Police officer” means:

10 (i) Any uniformed law enforcement officer who is certified or under
11 the direction of a law enforcement officer who is certified by the Department of State Police
12 to perform an inspection authorized under this section;

13 (ii) Any civilian employee of the Department of State Police assigned
14 to enforce any regulation adopted under this section, but only while acting under written
15 authorization of the Secretary of State Police;

16 (iii) Any civilian employee of the Maryland Transportation Authority
17 Police who is:

18 1. Acting under the immediate direction and control of a
19 uniformed police officer;

20 2. Acting under the written authorization of the Secretary of
21 State Police; and

22 3. Certified by the Department of State Police to perform an
23 inspection authorized under this section; or

24 (iv) Any civilian employee of a local government who is:

25 1. Acting under the immediate direction and control of a
26 uniformed police officer;

27 2. Acting under the written authorization of the Secretary of
28 State Police; and

29 3. Certified by the Department of State Police to perform an
30 inspection authorized under this section.

31 (9) “Public Service Commission inspector” means a person who is assigned
32 by the Public Service Commission and certified by the Department of State Police to
33 perform an inspection authorized under this section.

1 (10) "Transportation emergency" means any natural or man-made
2 emergency that interrupts or may interrupt the delivery of essential services or essential
3 supplies or otherwise immediately threatens human life or public welfare.

4 (b) (1) Upon direction by a police officer or by an electronic signal to vehicles
5 equipped with a CVISN transponder, the driver of any vehicle that is subject to any
6 regulation adopted under this section shall stop and submit to an inspection:

7 (i) All applicable driver records, including driver's license, driver
8 hours of service record and certificate of physical examination;

9 (ii) All load manifests, including bills of lading or other shipping
10 documents; and

11 (iii) All cargo and cargo areas.

12 (2) A police officer who is certified by the Department of State Police to
13 perform an inspection authorized under this section, a Public Service Commission
14 inspector, or a hazardous materials inspector may conduct a safety inspection of the vehicle
15 that is subject to a regulation adopted under this section or § 22-409 of this article.

16 (c) The operation of a vehicle on any highway in this State constitutes the consent
17 of the driver and the owner of the vehicle to the inspection provided for in this section.

18 (d) (1) The driver of a vehicle shall obey every sign and every direction of a
19 police officer or an electronic signal to a CVISN transponder to stop the vehicle and submit
20 to the required inspection.

21 (2) If a driver fails or refuses to comply with the direction of a police officer
22 or an electronic signal to a CVISN transponder to submit a vehicle to the required
23 inspection, the police officer shall have the authority to take the vehicle and its load into
24 temporary custody for the purpose of inspecting the vehicle, load, its equipment, or
25 documents.

26 (3) The police officer may utilize resources as specified in [§ 27-111(b)] §
27 **16-303.1(B)** of this article to conduct the safety inspection.

28 (4) In addition to any fine or penalty attributable to the inspection, or other
29 offense, the driver is[:

30 (i) Subject to a fine and penalty as specified in § 27-101(l) of this
31 article; and

32 (ii) ~~Responsible~~ **RESPONSIBLE** for any additional costs incurred in
33 inspecting the vehicle and its load because of the driver's failure or refusal to comply with
34 the direction of a police officer or an electronic signal to a CVISN transponder.

1 (e) A sign used to direct vehicles under this section may be displayed only by a
2 police officer who is assigned to enforce this section.

3 (f) (1) Except as provided in subsection (i) of this section, the Administration
4 may adopt regulations as are necessary for the safe operation of vehicles that:

5 (i) Exceed a gross vehicle weight rating of 10,000 pounds;

6 (ii) Are required to be marked or placarded for the transportation of
7 hazardous materials; or

8 (iii) Are designed to transport 16 or more passengers including the
9 driver over the highways of this State.

10 (2) Any regulation adopted pursuant to this subsection shall:

11 (i) Be formulated jointly by the Administration and the Department
12 of State Police;

13 (ii) Duplicate or be consistent with the Federal Motor Carrier Safety
14 Regulations contained in:

15 1. 49 C.F.R., Part 40 (“Procedures for Transportation
16 Workplace Drug and Alcohol Testing Programs”) and Part 382 (“Controlled Substances and
17 Alcohol Use and Testing”), with respect to drug and alcohol testing regulations applicable
18 to drivers required by regulation to possess a commercial driver’s license;

19 2. 49 C.F.R., Part 385, Subparts A, C, and D (“New Entrant
20 Safety Assurance Program”);

21 3. 49 C.F.R., Part 386, Subparts F and G (“Injunctions and
22 Imminent Hazards; Penalties”); and

23 4. 49 C.F.R., Parts 390 through 399 (“General Safety
24 Requirements”);

25 (iii) Apply to all vehicles with a gross vehicle weight rating or gross
26 combination weight rating over 10,000 pounds that are subject to the Federal Motor Carrier
27 Safety Regulations; and

28 (iv) Apply to vehicles with a gross vehicle weight rating or gross
29 combination weight rating over 10,000 pounds that are not subject to the Federal Motor
30 Carrier Safety Regulations, if the regulation adopted by the Motor Vehicle Administration
31 specifically states that it applies to the vehicle.

1 (3) The regulations adopted under this subsection may require that
2 registrants of motor vehicles subject to this subsection have knowledge of applicable federal
3 and State motor carrier safety regulations.

4 (g) Any motor carrier or driver operating a vehicle that is subject to the
5 regulations adopted under this section shall, at all times when operating the vehicle on a
6 highway in this State, comply with the regulations adopted under this section.

7 (h) (1) During normal business hours, a police officer, a hazardous materials
8 inspector, or a Public Service Commission inspector may enter the premises and inspect
9 equipment and review and copy records of motor carriers subject to the regulations adopted
10 under § 22–409 or § 23–302 of this article, Federal Motor Carrier Safety Regulations,
11 Federal Hazardous Materials Regulations, or Public Service Commission laws and
12 regulations.

13 (2) During normal business hours, trained personnel from the Commercial
14 Vehicle Enforcement Division of the Department of State Police may enter the premises
15 and inspect, review, and copy records of motor carriers subject to the regulations adopted
16 under this section, § 22–409 of this article, or § 23–302 of this article, including:

17 (i) Any record required by this section;

18 (ii) Driver qualification files;

19 (iii) Hours of service records;

20 (iv) Drug and alcohol testing records of drivers required to be tested
21 under this section; and

22 (v) Insurance records.

23 (i) (1) Except as provided for in paragraph (2) of this subsection, regulations
24 adopted under this section for intrastate motor carrier transportation may not:

25 (i) Apply the provisions of § 391.21, § 391.23, § 391.31, or § 391.35
26 of the Federal Motor Carrier Safety Regulations to:

27 1. A driver who is a regularly employed driver of a motor
28 carrier for a continuous period that began before July 1, 1986, if the driver continues to be
29 a regularly employed driver of the motor carrier; or

30 2. The motor carrier, with regard to a driver described under
31 item 1 of this item, if the motor carrier continues to employ the driver;

32 (ii) Limit a driver's time or hours on duty if:

1 1. The driver operates only within a 150 air mile radius of
2 the driver's normal work reporting location;

3 2. The driver returns to the driver's normal work reporting
4 location;

5 3. The driver is released from work within a period of 16
6 consecutive hours, not more than 12 of which are dedicated to driving, and is given at least
7 8 consecutive hours off duty; and

30 2. Operates only in intrastate commerce; and

31 3. Has a mental or physical condition which would disqualify
32 the person under the Federal Motor Carrier Safety Regulations and:

1 A. The condition existed on October 1, 2003 or at the time of
2 the first physical examination after that date to which the person submitted as required by
3 regulations adopted by the Administration under subsection (k) of this section; and

4 B. A physician who has examined the person has determined

6 (3) “CVISN” means the Commercial Vehicle Information Systems and
7 Network, a motor carrier program managed by the Department, together with other State
8 agencies.

19 automotive dismantler and recycler or scrap processor.

22 shall be imposed as provided in this section.

23 (b) Except on interstate highways, a loading error or tolerance of 1,000 pounds
24 over a registered weight limit, statutory weight limit, or weight limit imposed by signs is
25 allowed and only weight in excess of this tolerance is a violation provided that:

26 (1) An overall gross weight may not exceed 80,000 pounds, including any
27 enforcement or statutory tolerances; or

28 (2) The vehicle is being operated under a valid permit for gross weight in
29 excess of 80,000 pounds.

30 (c) Subject to subsection (d) of this section, the following fines, in addition to court
31 costs, are applicable to weight violations over the registered weight limit, statutory weight
32 limit, or weight limit imposed by signs, and for weight violations that occur on any highway
33 of this State, including interstate highways:

1 (1) 1 cent for each pound for the first 1,000 pounds of weight over any
2 allowable weight;

3 (2) 5 cents for each pound of excess weight over 1,000 pounds, but less than
4 5,001 pounds;

6 and less than 10,001 pounds;

7 (4) 20 cents for each additional pound of excess weight over 10,000 pounds
8 but less than 20,001 pounds; and
