1 AN ACT concerning

2 **Code Revision – Maryland Vehicle Law – Penalties**

3 FOR the purpose of revising, restating, and recodifying the laws of this State relating to  
 4 penalties for violations of the Maryland Vehicle Law; repealing certain redundant  
 5 provisions; clarifying language; making certain technical and stylistic changes;  
 6 providing for the construction of this Act; providing for the effect and construction of  
 7 certain provisions of this Act; authorizing the publisher of the Annotated Code to  
 8 make certain corrections in a certain manner; and generally relating to the Maryland  
 9 Vehicle Law.

32 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
33 That the Laws of Maryland read as follows:

34 **Article – Transportation**

35 12–301.

36 (a) On application, the Administration shall issue an identification card to any  
37 applicant who:

1 (1) Is a resident of this State;

2 (2) Does not have a driver's license;

3 (3) Presents a birth certificate or other proof of age and identity acceptable  
4 to the Administration;

5 (4) Provides satisfactory documentary evidence that the applicant has  
6 lawful status;

7 (5) (i) Provides satisfactory documentary evidence that the applicant  
8 has a valid Social Security number by presenting the applicant's Social Security  
9 Administration account card or, if the Social Security Administration account card is not  
10 available, any of the following documents bearing the applicant's Social Security number:

11 1. A current W-2 form;

12 2. A current SSA-1099 form;

13 3. A current non-SSA-1099 form; or

14 4. A current pay stub with the applicant's name and Social  
15 Security number on it; or

16 (ii) Provides satisfactory documentary evidence that the applicant is  
17 not eligible for a Social Security number; and

18 (6) Presents a completed application for an identification card on a form  
19 furnished by the Administration.

20 (b) (1) Except as provided in paragraph (2) of this subsection, the  
21 Administration shall establish a fee for the issuance of an identification card and for  
22 issuance of a duplicate identification card.

23 (2) A fee is not required if the applicant for the card:

24 (i) Is 65 years old or older;

25 (ii) Is legally blind;

26 (iii) Has permanently lost the use of a leg or an arm;

27 (iv) Is permanently disabled so severely that the applicant cannot  
28 move without the aid of crutches or a wheelchair; or

29 (v) Has a physical or mental impairment that substantially limits a  
30 "major life activity" as defined in the federal Americans with Disabilities Act.

1 (c) A person may not commit any fraud in applying for an identification card  
2 issued under this section.

3 (d) A person may not commit any misrepresentation in applying for an  
4 identification card issued under this section.

5 (e) A person may not commit any fraud in using an identification card issued  
6 under this section.

7 (f) A person may not make any misrepresentation in using an identification card  
8 issued under this section.

9 (g) (1) An identification card shall be:

10 (i) Of the size and design that the Administration requires; and

11 (ii) Tamperproof, to the extent possible.

12 (2) The card shall contain:

13 (i) The name and address of the applicant;

14 (ii) The birth date of the applicant;

15 (iii) The sex of the applicant;

16 (iv) A description of the applicant;

17 (v) A color photograph of the applicant taken by the procedure that  
18 the Administration requires;

19 (vi) The expiration date of the identification card;

20 (vii) The signature of the applicant; and

21 (viii) The signature and seal of the issuing agent.

22 (h) An identification card may be used as legal identification of the individual to  
23 whom it is issued for any purpose.

24 (i) (1) Subject to paragraph (2) of this subsection, an identification card issued  
25 to an applicant expires at the end of a period of not more than 8 years determined in  
26 regulations adopted by the Administration.

27 (2) (i) If an applicant has temporary lawful status, the Administration  
28 may not issue an identification card to the applicant for a period that extends beyond the

1 expiration date of the applicant's authorized stay in the United States or, if there is no  
2 expiration date, for a period longer than 1 year.

3 (ii) Nothing contained in this paragraph may be construed to allow  
4 the issuance of an identification card for a period longer than the period described in  
5 paragraph (1) of this subsection.

6 (iii) The Administration shall indicate on the face and in the  
7 machine-readable zone of a temporary identification card issued under this paragraph that  
8 the card is a temporary identification card.

9 (3) An identification card may be renewed on application and payment of  
10 the fee required by this section.

11 (j) The identification card shall be surrendered by the holder upon being issued  
12 a Maryland driver's license.

13 (k) The Administrator may issue an identification card to an applicant:

14 (1) Whose privilege to drive has been refused, canceled, suspended, or  
15 revoked; or

16 (2) Who has been issued a temporary license under § 16-205.1(b)(3)(iii) of  
17 this article.

18 (l) (1) The Administration may cancel an identification card issued under this  
19 section if the Administration determines that the holder of the identification card:

20 (i) Was not entitled to be issued the identification card;

21 (ii) Failed to provide accurate or required information in the  
22 application for the identification card;

23 (iii) Fraudulently applied for or obtained the identification card; or

24 (iv) Is otherwise in violation of subsection (c), (d), (e), or (f) of this  
25 section.

26 (2) If the Administration cancels an identification card under paragraph  
27 (1) of this subsection, the holder of the identification card immediately shall surrender the  
28 canceled identification card to the Administration.

29 **(M) (1) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (C) OR (D)**  
30 **OF THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 3 YEARS OR A**  
31 **FINE NOT EXCEEDING \$2,500 OR BOTH.**

1           **(2) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (E) OR (F)**  
2 **OF THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 2 MONTHS OR A**  
3 **FINE NOT EXCEEDING \$500 OR BOTH.**

8           (a) (1) Except as otherwise provided in this section or elsewhere in the  
9 Maryland Vehicle Law, each motor vehicle, trailer, semitrailer, and pole trailer driven on  
10 a highway shall be registered under this subtitle.

11           (2) If a motor vehicle required to be registered under this subtitle is not  
12 registered, a person may not park the unregistered motor vehicle on any:

13                   (i) Public alley, street, or highway; or

14                   (ii) Private property used by the public in general, including parking  
15 lots of shopping centers, condominiums, apartments, or town house developments.

16           (3) The provisions of paragraph (2) of this subsection do not apply to a  
17 motor vehicle that is exempt from registration under this section or § 13-402.1 of this  
18 subtitle.

19           (b) Except as otherwise expressly authorized in this title, the Administration may  
20 not register or renew the registration of a vehicle unless the Administration has issued to  
21 the owner a certificate of title of the vehicle or has received an application for the certificate  
22 of title.

23           (c) Registration under this subtitle is not required for:

24                   (1) A vehicle that is driven on a highway:

25                           (i) In conformity with the provisions of this title relating to  
26 manufacturers, transporters, dealers, secured parties, owners or operators of special mobile  
27 equipment, or nonresidents; or

28                           (ii) Under a temporary registration card issued by the  
29 Administration;

30                   (2) A vehicle owned and used by the United States, unless an authorized  
31 officer or employee of the United States requests registration of the vehicle;

32                   (3) A farm tractor or any farm equipment;

1 (4) A vehicle the front or rear wheels of which are lifted from the highway;

2 (5) A towed vehicle that is attached to the towing vehicle by a tow bar and  
3 for which no driver is necessary;

4 (6) A vehicle owned by and in the possession of a licensed dealer for purpose  
5 of sale;

6 (7) A vehicle owned by a new resident of this State during the first 60 days  
7 of residency provided the vehicle displays valid registration issued by the jurisdiction of the  
8 resident's former domicile;

9 (8) New vehicles being operated as part of a shuttle, as defined in § 13-626  
10 of this title, while following a registered vehicle displaying a shuttle permit issued by the  
11 Administration;

12 (9) A vehicle operated in connection with maritime commerce exclusively  
13 within any terminal owned or leased by the Maryland Port Administration;

14 (10) A snowmobile that is operated on highways and roadways as prescribed  
15 by § 25-102(a)(14) of this article;

16 (11) A golf cart that is operated on a highway on Smith Island, provided that  
17 the golf cart is equipped with lighting devices as required by the Administration if it is  
18 operated on a highway between dusk and dawn;

19 (12) A golf cart that is operated on a highway in the City of Crisfield,  
20 Somerset County, in accordance with § 21-104.2 of this article;

21 (13) A golf cart that is operated on an Allegany County highway as allowed  
22 by the county under § 25-102(a)(16) of this article; or

23 (14) A vehicle owned by an accredited consular or diplomatic officer of a  
24 foreign government and operated for official or personal purposes when the vehicle displays  
25 a valid diplomatic license plate issued by the United States government.

26 (d) (1) If a motor vehicle, trailer, or semitrailer is registered in another state,  
27 displays current registration plates issued for it by that state, and is brought into this State  
28 by a nonresident for transporting seasonal farm workers to be employed on farms in this  
29 State or for work incidental to seasonal crop operations on farms in this State, the vehicle  
30 need not be registered in this State if:

31 (i) The vehicle is being used as an incidental part of harvesting  
32 operations within a distance of not more than 35 miles from the source of the crop; and

33 (ii) The owner of the vehicle has obtained an exemption permit for  
34 the vehicle, as provided in this subsection.

1           (2) When the Administration receives a certification by the Secretary of  
2 State Police that a vehicle is entitled to an exemption under this subsection, the  
3 Administration shall issue an exemption permit on the form the Secretary of State Police  
4 approves. The form shall be carried at all times by the driver of the vehicle for which it is  
5 issued or in a conspicuous place on the vehicle.

6           (3) The exemption permit is:

7           (i) Valid for a period of 90 days from the date of issue; and

8           (ii) Eligible for renewal under the procedure set forth in this  
9 subsection for an additional period of not more than 90 days in any 1 calendar year.

10          (4) The Secretary of State Police:

11          (i) May require a certificate of inspection of the equipment of the  
12 vehicle; and

13          (ii) Shall require a certificate of insurance by a company authorized  
14 to do business in this State, certifying that the vehicle is insured to the same extent as  
15 required of vehicles registered in this State.

16          (e) Except for members elected from this State, if a member of the United States  
17 Congress resides in this State during his term of office in the Congress, he need not register  
18 his vehicles in this State during that time.

19          (f) A trailer or semitrailer operated in intrastate service need not be registered  
20 in this State if:

21          (1) It is registered in another state;

22          (2) The truck tractor or other vehicle that is towing it is registered in this  
23 State; and

24          (3) The registered owner of the truck tractor or other towing vehicle has at  
25 least one trailer or semitrailer registered in this State for each truck tractor also registered  
26 in this State.

27          (g) (1) A trailer or semitrailer rented or leased in intrastate service need not  
28 be registered in this State if, subject to paragraph (2) of this subsection:

29          (i) The trailer or semitrailer has a chassis weight of 1,000 pounds or  
30 less;

31          (ii) The trailer or semitrailer is registered in another state; and



1 (iii) The owner of the trailer or semitrailer annually has registered in  
2 this State a number of these trailers and semitrailers that is at least equal to the average  
3 number of these trailers and semitrailers that the owner annually will have available in  
4 this State for rent or lease in intrastate service.

5 (2) If a person claims exemption for a trailer or semitrailer under this  
6 subsection, the person shall file annually with the Administration, at the time and in the  
7 manner that the Administration requires, an affidavit that sets forth, as to all such trailers  
8 and semitrailers that the person has available in all states for rent or lease:

9 (i) The total number annually registered in all states;

10 (ii) The total number annually registered in this State; and

11 (iii) The average total number annually available for rent or lease in  
12 this State.

13 (h) (1) A motor vehicle rented in intrastate service need not be registered in  
14 this State if, subject to paragraph (3) of this subsection:

15 (i) The motor vehicle is registered in another state; and

16 (ii) The owner of the motor vehicle annually has registered in this  
17 State a percentage of the total number of these motor vehicles in a rental fleet as  
18 determined under paragraph (2) of this subsection.

19 (2) The percentage of the total number of motor vehicles in a rental fleet  
20 that must be registered in this State is determined by dividing the gross revenue received  
21 in the preceding year for the use of such rental vehicles arising from all motor vehicle rental  
22 transactions occurring in this State by the total gross revenue received in the preceding  
23 year for the use of such rental vehicles arising from all motor vehicle rental transactions  
24 occurring in all jurisdictions in which the rental fleet is operated. The resulting percentage  
25 shall be applied to the total number of motor vehicles in the rental fleet and that figure, to  
26 the nearest whole number, shall be the number of rental motor vehicles that shall be fully  
27 registered and titled in this State.

28 (3) If a person claims exemption for a motor vehicle under this subsection,  
29 the person shall file annually with the Administration, at the time and in the manner that  
30 the Administration requires, an affidavit that sets forth, as to all such motor vehicles that  
31 the person has available in all states for rent:

32 (i) The gross revenue received in the preceding year for the use of  
33 such rental motor vehicles arising from all motor vehicle rental transactions occurring in  
34 Maryland; and

1 (ii) The total gross revenue received in the preceding year for the use  
2 of such rental motor vehicles arising from all motor vehicle rental transactions occurring  
3 in all jurisdictions.

4 ~~[(4)]~~ **(1)** A person ~~[who rents]~~ **MAY NOT RENT** to another person a  
5 motor vehicle or ~~[attempts]~~ **ATTEMPT** to rent to another person a motor vehicle in this

17 (a) A nonresident may drive or permit the driving of a foreign vehicle in this State,  
18 without registering the vehicle in this State, if:

19 (1) At all times while driven in this State, the vehicle:

20 (i) Is registered in and displays current registration plates issued  
21 for it in the owner's place of residence; and

22 (ii) Carries as provided in § 13-409(a) of this subtitle, a current  
23 registration card issued for it in the owner's place of residence; and

24 (2) Except as otherwise provided in this section or under an agreement in  
25 compliance with Title 12, Subtitle 4 of this article, the vehicle is not:

26 (i) Used for transporting persons for hire, compensation, or profit;

27 (ii) Regularly operated in carrying on business in this State;

28 (iii) Designed, used, or maintained primarily for the transportation  
29 of property; or

30 (iv) In the custody of any resident for more than 30 days during any  
31 registration year.

1 (b) With the approval of the Governor, the Administration may permit a foreign  
2 vehicle to be driven in this State by:

3 (1) Issuing complimentary guest cards, permits, or licenses to persons  
4 visiting this State from any foreign country; or

5 (2) Recognizing and permitting the use of guest cards, permits, or licenses  
6 granted by other states.

7 (c) If a nonresident is a member of the armed forces of the United States or of the  
8 United States Public Health Service and is serving on active duty in this State or an  
9 adjoining state or the District of Columbia, the nonresident need not register his personal  
10 passenger vehicles in this State if the vehicles are registered in the state of his residence.

11 (d) If a nonresident is a student enrolled in an accredited school, college, or  
12 university of this State or of a bordering state or is serving a medical internship in this  
13 State, the nonresident need not register his vehicles in this State if:

14 (1) The state of which the nonresident is a resident extends the same  
15 privileges to the residents of this State; and

16 (2) The nonresident meets the required security provisions of the Maryland  
17 Vehicle Law as to any vehicle to which this exemption applies.

18 (e) (1) Except as provided in paragraphs (2) and (3) of this subsection, if a  
19 nonresident temporarily maintains or occupies a dwelling in this State for a period in excess  
20 of 30 days but not in excess of 1 year, the nonresident shall obtain a nonresident's permit  
21 from the Administration, in lieu of registration, within 10 days immediately following the  
22 30-day period.

23 (2) A nonresident exempt from registration under subsection (d) of this  
24 section shall obtain a nonresident's permit from the Administration, in lieu of registration,  
25 within 30 days of maintaining or occupying a dwelling in this State.

26 (3) A nonresident exempt from registration under subsection (c) of this  
27 section may obtain a nonresident's permit from the Administration, in lieu of registration,  
28 if the permit application is made within 10 days immediately following the 30-day period.

29 (4) (i) On application, a nonresident's permit may be issued by the  
30 Administration, or an agent designated by the Administration, in a form determined by the  
31 Administration.

32 (ii) For each nonresident permit it issues, an agent designated by the  
33 Administration may collect a fee not to exceed \$4 in addition to the nonresident permit fee  
34 to offset expenses incurred in the issuance of nonresident permits.

35 (5) The application shall be accompanied by:

1 (i) A fee established by the Administration;

2 (ii) Evidence to reasonably establish that the applicant has a  
3 domicile outside of this State and is not a resident as defined in § 11–149 of this article;  
4 and

5 (iii) Evidence that the nonresident meets the required security  
6 provisions of the Maryland Vehicle Law.

7 (6) The nonresident permit shall be displayed on the windshield of the  
8 nonresident’s exempt vehicle in the place and manner prescribed by the Administration.

9 (7) (i) A nonresident permit issued under paragraph (1) or (2) of this  
10 subsection shall be issued for a period not to exceed 1 year.

11 (ii) A nonresident permit issued under paragraph (3) of this  
12 subsection shall be valid until the expiration date of the registration plates of the vehicle  
13 to which it is issued.

14 (iii) 1. A nonresident permit issued under paragraph (2) of this  
15 subsection may be renewed annually in accordance with the nonresident’s eligibility for the  
16 exemption provided in subsection (d) of this section.

17 2. A renewal fee established by the Administration shall be  
18 paid at the time of renewal.

19 (8) (i) Of the funds collected under paragraphs (5)(i) and (7)(iii)2 of this  
20 subsection, the Administration shall retain an amount equal to its administrative costs  
21 under this section.

22 (ii) Any excess funds shall be credited to the Gasoline and Motor  
23 Vehicle Revenue Account for distribution as highway user revenues in accordance with §§  
24 8–403 and 8–404 of this article.

25 (f) A person [who drives or attempts] **MAY NOT DRIVE OR ATTEMPT** to drive a  
26 vehicle on any highway in this State in violation of [any of the provisions of] this section  
27 [is guilty of a misdemeanor].

2 (a) (1) In this subtitle the following words have the meanings indicated.

3 (2) “Certified nurse practitioner” means an individual who is licensed by  
4 the State Board of Nursing to practice registered nursing as described in § 8–101 of the  
5 Health Occupations Article and who is certified as a nurse practitioner by the State Board  
6 of Nursing.

7 (3) “Licensed chiropractor” means a chiropractor who is licensed by the  
8 State Board of Chiropractic and Massage Therapy Examiners to practice chiropractic or  
9 chiropractic with the right to practice physical therapy as described in § 3–301 of the Health  
10 Occupations Article.

11 (4) “Licensed optometrist” means an optometrist who is licensed by the  
12 State Board of Examiners in Optometry to practice optometry as described in § 11–101 of  
13 the Health Occupations Article.

14 (5) “Licensed physical therapist” means a physical therapist who is  
15 licensed by the State Board of Physical Therapy Examiners to practice physical therapy as  
16 described in § 13–101 of the Health Occupations Article.

17 (6) “Licensed physician” means a physician, including a doctor of  
18 osteopathy, who is licensed by the State Board of Physicians to practice medicine as  
19 described in § 14–101 of the Health Occupations Article.

20 (7) “Licensed physician assistant” means an individual who is licensed  
21 under Title 15 of the Health Occupations Article to practice medicine with physician  
22 supervision.

23 (8) “Licensed podiatrist” means a podiatrist who is licensed by the State  
24 Board of Podiatric Medical Examiners to practice podiatry as described in § 16–101 of the  
25 Health Occupations Article.

26 (b) (1) The owner of any vehicle described in paragraph (3) of this subsection  
27 may apply to the Administration for the assignment to that vehicle of a special disability  
28 registration number and special disability registration plates, if a certified nurse  
29 practitioner, licensed physician, licensed physician assistant, licensed chiropractor,  
30 licensed optometrist, licensed podiatrist, or licensed physical therapist certifies, in  
31 accordance with paragraph (2) of this subsection, that the applicant:

32 (i) Has lung disease to such an extent that forced (respiratory)  
33 expiratory volume for one second when measured by spirometry is less than one liter, or

1 (8) "Toll collection facility" means any point on an Authority highway

3 (9) "Toll violation" means the failure to pay a video toll within the time

6 conjunction with a toll collection facility that produces a recorded image when a video toll  
7 transaction occurs.

8 (11) "Video toll" means the amount assessed by the Authority when a video  
9 toll transaction occurs.

10 (12) "Video toll transaction" means any transaction in which a motor vehicle  
11 does not or did not pay a toll at the time of passage through a toll collection facility with a  
12 video monitoring system.

13 (b) (1) Except as provided in subsection (g) of this section, the registered owner  
14 of a motor vehicle shall be liable to the Authority for payment of a video toll as provided for  
15 in the regulations of the Authority.

16 (2) The Authority shall send the registered owner of a motor vehicle that  
17 has incurred a video toll a notice of toll due.

18 (3) Except as provided in subsection (g) of this section, the person alleged  
19 to be liable who receives a notice of toll due shall have at least 30 days to pay the video toll.

20 (c) (1) Failure of the person alleged to be liable to pay the video toll under a  
21 notice of toll due by the date stated on the notice shall constitute a toll violation subject to  
22 a civil citation and a civil penalty, which shall be assessed 15 days after the toll violation

- 18                   (ii)    The statutory defenses described in subsection (g) of this section  
19 that were originally included in the notice of toll due; and
- 20                   (iii)   A warning that failure to pay the video toll and civil penalty, to  
21 contest liability in the manner and time prescribed, or to appear at a trial requested is an  
22 admission of liability and a waiver of available defenses, and may result in the refusal or  
23 suspension of the motor vehicle registration and referral for collection.

15 system shall be evidence of the facts contained therein and shall be admissible in any

3 (d) Except for the connection between any two vehicles carrying poles, pipes,  
4 machinery, or other objects that cannot be readily dismembered, the connection between  
5 vehicles may not exceed 15 feet.

6 (e) A connection made with a fifth-wheel connection device is not required to use  
7 safety chains or cables as additional securing devices.

8 (f) If a vehicle is towed by a rope, chain, or cable, a driver must be in and capable  
9 of steering the towed vehicle.

10 (g) A primary connecting system used in a combination of vehicles shall be  
11 designed, constructed, and installed to insure that a towed vehicle does not shift or swerve  
12 more than 6 inches to either side of the path of the towing vehicle while the towing vehicle  
13 is moving in a straight line on a level, smooth, paved surface.

14 (h) While one vehicle is towing another and the connection is a chain, rope, or  
15 cable, a white, red, or orange-fluorescent warning flag or cloth at least 18 inches square  
16 shall be displayed on the connection.

17 (i) Except as otherwise provided in this title, or when one tow dolly is used to tow  
18 one other vehicle, a vehicle may not be operated in combination with more than one other  
19 vehicle.

20 (j) (1) The Administration may adopt regulations that establish standards for  
21 hitching devices and towing procedures for towing and towed vehicles.

22 (2) Except as otherwise provided in this section, this subsection applies to  
23 tractor-trailer combinations, semitrailer combinations, and any other vehicle combinations  
24 designed and used for carrying freight or merchandise in furtherance of any commercial  
25 enterprise.

26 **(K) A PERSON CONVICTED OF A VIOLATION OF THIS SECTION THAT RESULTS**  
27 **IN THE DEATH OR, AS DEFINED IN § 20-102(C) OF THIS ARTICLE, SERIOUS BODILY**  
28 **INJURY OF ANOTHER PERSON IS SUBJECT TO A FINE NOT EXCEEDING \$1,000.**

29 REVISOR'S NOTE: Subsection (k) of this section is new language derived without  
30 substantive change from former § 27-101(bb) of this article.

31 In subsection (k) of this section, the reference to the serious bodily injury "of  
32 another person" is added for clarity and consistency with § 20-102(c) of this  
33 article.

1 (a) (1) In this section and in § 24–111.1 of this subtitle the following words  
2 have the meanings indicated.

3 (2) “CVISN” means the Commercial Vehicle Information Systems and  
4 Network, a motor carrier program managed by the Department, together with other State  
5 agencies.

6 (3) “CVISN transponder” means an electronic device acquired by motor  
7 carriers to allow electronic signaling through CVISN.

8 (4) “Police officer” means:

9 (i) Any uniformed police officer;

10 (ii) Any civilian employee of the Department of State Police or the  
11 Maryland Transportation Authority Police assigned to enforce this subtitle, but only while  
12 acting under written authorization of the Secretary of State Police; or

13 (iii) Any civilian employee of a local government who is:

14 1. Acting under the immediate direction and control of a  
15 uniformed police officer;

16 2. Acting under written authorization of the Secretary of  
17 State Police; and

18 3. Certified by the Department of State Police to perform the  
19 weighing and measurement authorized under this section.

20 (b) (1) The driver of a vehicle must stop and submit the vehicle to a  
21 measurement or weighing:

22 (i) When directed by a police officer who has reason to believe that  
23 the size or weight of a vehicle being driven on a highway violates this subtitle; or

24 (ii) When directed by an electronic signal to a CVISN transponder.

25 (2) The weighing authorized by this subsection:

26 (i) May be done with either portable or stationary scales; and

27 (ii) In either case, shall be done by methods established by experts  
28 in the field of weights and measures and adopted by rule or regulation of the Department  
29 of State Police.

1 (3) If more than 1 statutory weight limit tolerance applies to a vehicle being  
2 weighed under this section, the police officer shall grant only the greatest applicable  
3 tolerance.

4 (c) The operation of a vehicle on any highway in this State constitutes the consent  
5 of the driver and the owner of the vehicle to the measurement and weighing provided for  
6 in this section.

7 (d) (1) The driver of a vehicle shall obey every sign and every direction of a  
8 police officer or an electronic signal to a CVISN transponder to stop the vehicle and submit  
9 it to measurement or weighing.

10 (2) If a driver fails or refuses to comply with the direction of a police officer  
11 or an electronic signal to a CVISN transponder to submit a vehicle to measurement or  
12 weighing, the police officer shall have the authority to take the vehicle and its load into  
13 temporary custody for the purpose of weighing and measuring.

14 (3) The police officer may utilize resources specified in [§ 27-111(b)] §  
15 **16-303.1(B)** of this article to conduct the weighing or measuring.

16 (4) In addition to any fine or penalty attributable to the weighing and  
17 measuring, or other offense, the driver is[:

18 (i) Subject to a fine and penalty specified in § 27-101(l) of this  
19 article; and

20 (ii) Responsible] **RESPONSIBLE** for any actual costs incurred in  
21 weighing and measuring the vehicle and its load because of the driver's failure or refusal  
22 to comply with the direction of a police officer or an electronic signal to a CVISN  
23 transponder.

24 (e) A sign used to direct vehicles under this section may be displayed only by a  
25 police officer who is assigned to enforce this title.

26 **(F) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (D) OR (E) OF**  
27 **THIS SECTION IS SUBJECT TO:**

28 **(1) FOR A FIRST OFFENSE, A FINE NOT EXCEEDING \$1,000;**

29 **(2) FOR A SECOND OFFENSE, A FINE NOT EXCEEDING \$2,000; AND**

30 **(3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING**  
31 **\$3,000.**

1 REVISOR'S NOTE: Subsection (f) of this section is new language derived without  
2 substantive change from former § 27-101(l) of this article, as it related to this  
3 section.

4 In subsection (d)(4) of this section, the former reference to penalties "specified  
5 in § 27-101(l) of this article" is deleted as unnecessary in light of the  
6 incorporation of those penalties into this section.

7 The Department of Legislative Services notes, for consideration by the  
8 General Assembly, that the source law for this revised section imposes two  
9 separate duties on drivers. Under subsection (b) of this section, a driver is  
10 required to stop and submit a vehicle to measurement or weighing when  
11 directed by (1) a police officer "who has reason to believe" that a size or weight  
12 violation exists; or (2) a commercial vehicle information systems and network  
13 signal (CVISN). Under subsection (d) of this section, a driver is required to  
14 obey a signal or direction of a police officer or a CVISN transponder to stop  
15 the vehicle and submit to measurement or weighing. The duties imposed  
16 under subsection (b) of this section are wholly included under the duties  
17 imposed under subsection (d) of this section.

18 The enhanced penalties that are being revised into this section explicitly do  
19 not apply to subsection (b) of this section. In fact, the penalty deposit schedule  
20 produced by the District Court establishes prepay penalties for subsection (d)  
21 of this section in accordance with the enhanced penalties but does not include  
22 any prepay penalties for a violation of subsection (b) of this section. The  
23 General Assembly may wish to clarify this section by repealing subsection (b)

25 24-111.1.

26 (a) Except as otherwise provided in this section, as to any vehicle found to exceed  
27 the weight limits permitted under this subtitle, if the overweight does not exceed 5,000  
28 pounds, a police officer may require the driver to unload the excess weight.

29 (b) Except as otherwise provided in this section, as to any vehicle found to exceed  
30 the weight limits permitted under this subtitle, if the overweight exceeds 5,000 pounds, the  
31 vehicle may not be moved until the excess weight is unloaded.

32 (c) Except on interstate highways, if an overweight vehicle bears registration  
33 plates issued by this State and is transporting liquid milk in bulk from the producer, the  
34 vehicle may be granted a 5 percent tolerance on the applicable registration or statutory  
35 gross weight limit. However, a tolerance granted under this subsection may not permit the  
36 gross weight of the vehicle to exceed 80,000 pounds.

37 (d) As to an overweight vehicle carrying an indivisible load:

1 (1) If it is the first indivisible load overweight violation by the driver of the  
 2 vehicle, the vehicle may be allowed to proceed, after a permit to do so is obtained from the  
 3 State Highway Administration; and

4 (2) If it is a second or subsequent indivisible load overweight violation by

 8 vehicle shall be allowed to proceed to its destination if:

9 (1) It is the first perishable load overweight violation by the driver of the  
 10 vehicle following a period of at least 365 consecutive days without a perishable load

12 (2) The overweight does not exceed 5,000 pounds.

13 (f) All material or cargo unloaded under this section shall be cared for by the  
 14 motor carrier or operator of the vehicle at the risk of the motor carrier or operator.

15 **(G) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (B), (D)(2), OR**  
 16 **(E) OF THIS SECTION IS SUBJECT TO:**

17 **(1) FOR A FIRST OFFENSE, A FINE NOT EXCEEDING \$1,000;**

18 **(2) FOR A SECOND OFFENSE, A FINE NOT EXCEEDING \$2,000; AND**

19 **(3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING**  
 20 **\$3,000.**

21 REVISOR'S NOTE: Subsection (g) of this section is new language derived without  
 22 substantive change from former § 27-101(l) of this article, as it related to this  
 23 section.

24 In the introductory language of subsection (g) of this section, the  
 25 cross-reference to subsection (e) of this section is substituted for the former  
 26 cross-reference to subsection (e)(2) of this section for accuracy. Chapter 177 of  
 27 2012 amended § 24-111.1 of this article to be in its present form. Before  
 28 Chapter 177 was enacted, subsection (e)(1) of the former law authorized the  
 29 driver of a vehicle with an overweight load of perishable products to proceed  
 30 to the vehicle's destination if it was the first perishable load overweight  
 31 violation by the driver in the calendar year. Subsection (e)(2) of the former law  
 32 established a duty for a second or subsequent violation in a calendar year that  
 33 any excess weight be unloaded before moving the vehicle. Section 27-101(l) of  
 34 this article provided enhanced penalties for failure to unload excess perishable  
 35 goods under subsection (e)(2) of the former law (the only provision of

1 subsection (e) that imposed a duty on the driver). Chapter 177, however,  
2 rewrote § 24–111.1(e) of this article to authorize the driver of a vehicle with  
3 an overweight load of perishable products to proceed to the vehicle’s  
4 destination if (1) it is the first perishable load overweight violation by the  
5 driver in the previous 365 days (under new subsection (e)(1)); and (2) the  
6 overweight does not exceed 5,000 pounds (under new subsection (e)(2)). Thus,  
7 a person must fail to meet both conditions under subsection (e)(1) and (2)  
8 before a duty is imposed. Chapter 177, however, did not amend § 27–101(l) by  
9 correcting the cross–reference to reflect the new formulation of the required  
10 duty (i.e., from subsection “(e)(2)” to subsection “(e)”).

4 (F) A PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT

6 (1) FOR THE FIRST OFFENSE, A FINE NOT EXCEEDING \$1,000;

7 (2) FOR A SECOND OFFENSE, A FINE NOT EXCEEDING \$2,000; AND

8 (3) FOR A THIRD OR SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING  
 9 \$3,000.

10 REVISOR'S NOTE: Subsection (f) of this section is new language derived without  
 11 substantive change from former § 27-101(u) of this article.

12 24-303.

13 (a) (1) When located on the right-of-way of any State highway, a mobile  
 14 seafood or produce vendor may not sell, or offer for sale, any seafood or produce, unless the  
 15 vendor has a lease from the State that allows the vendor to sell, or offer for sale, seafood or  
 16 produce.

17 (2) The State may require a mobile seafood or produce vendor to submit an  
 18 application and pay a reasonable fee to be applied to administrative costs.

19 (3) The State may not enter into a lease with a mobile produce vendor  
 20 unless the applicable county licenses mobile produce vendors.

21 (b) A mobile seafood or produce vendor may not sell, or offer for sale, any seafood  
 22 or produce, when located:

23 (1) Within 50 yards of any vehicular entrance to or exit from a school or  
 24 place of worship, unless the vendor has written permission of the applicable school board  
 25 or person who is responsible for the buildings and grounds of the place of worship;

4 (c) The State Highway Administration may adopt regulations to implement this

7 (a) [A violation of this subtitle is a misdemeanor punishable by the penalty  
8 specified in § 27-101(b) of this article.

9 (b)] The charging of a person with a violation of this subtitle shall be by means of  
10 a traffic citation in the form determined under § 1-605(d) of the Courts Article.

11 [(c)] (B) The charging of a person with a violation of this section may be  
12 performed by any State or local police officer.

21 (i) **THE MAXIMUM WEIGHT LIMIT FOR WHICH THE VEHICLE OR**  
22 **COMBINATION OF VEHICLES IS REGISTERED;**

23 (ii) **A STATUTORY WEIGHT LIMIT; OR**

24 (iii) **SUBJECT TO PARAGRAPH (2)(I) OF THIS SUBSECTION, THE**  
25 **MAXIMUM WEIGHT LIMIT IMPOSED BY SIGNS THAT HAVE BEEN PLACED TO**  
26 **REGULATE THE WEIGHT OF A VEHICLE PASSING OVER A BRIDGE OR CULVERT UNDER**  
27 **§ 24-206 OF THIS TITLE.**

28 (2) **THIS SECTION DOES NOT APPLY TO A PERSON WHO:**

1                   **(I) VIOLATES A WEIGHT LIMIT IMPOSED BY SIGNS IF THERE**  
2 **ARE NO SIGNS POSTING THE WEIGHT LIMIT LOCATED:**

3                   **1. AT THE BRIDGE OR CULVERT; AND**

4                   **2. BEFORE THE LAST AVAILABLE ALTERNATE ROUTE**  
5 **THAT BYPASSES THE BRIDGE OR CULVERT; OR**

6                   **(II) IS OPERATING AN EMERGENCY VEHICLE WHEN**  
7 **RESPONDING TO AN EMERGENCY.**

8                   **(B) EXCEPT ON AN INTERSTATE HIGHWAY, A TOLERANCE OF 1,000 POUNDS**  
9 **OVER A WEIGHT LIMIT TO WHICH THIS SECTION APPLIES IS ALLOWED, AND ONLY**  
10 **WEIGHT IN EXCESS OF THIS TOLERANCE IS A VIOLATION, IF:**

11                   **(1) THE OVERALL GROSS WEIGHT DOES NOT EXCEED 80,000 POUNDS,**  
12 **INCLUDING ANY ENFORCEMENT OR STATUTORY TOLERANCES; OR**

13                   **(2) THE VEHICLE IS BEING OPERATED UNDER A VALID PERMIT FOR**  
14 **GROSS WEIGHT EXCEEDING 80,000 POUNDS.**

15                   **(C) EXCEPT AS PROVIDED IN SUBSECTION (D) OF THIS SECTION, A PERSON**  
16 **CONVICTED OF A WEIGHT VIOLATION TO WHICH THIS SECTION APPLIES ON ANY**  
17 **HIGHWAY IN THE STATE, INCLUDING AN INTERSTATE HIGHWAY, IS SUBJECT TO THE**  
18 **FOLLOWING FINES:**

19                   **(1) 1 CENT FOR EACH POUND FOR THE FIRST 1,000 POUNDS OF**  
20 **WEIGHT OVER ANY ALLOWABLE WEIGHT;**

21                   **(2) 5 CENTS FOR EACH POUND OF EXCESS WEIGHT OVER 1,000**  
22 **POUNDS BUT LESS THAN 5,001 POUNDS;**

23                   **(3) 12 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**  
24 **OVER 5,000 POUNDS BUT LESS THAN 10,001 POUNDS;**

25                   **(4) 20 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**  
26 **OVER 10,000 POUNDS BUT LESS THAN 20,001 POUNDS; AND**

27                   **(5) 40 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT**  
28 **OVER 20,000 POUNDS.**

29                   **(D) A PERSON CONVICTED OF A WEIGHT VIOLATION TO WHICH THIS**  
30 **SECTION APPLIES ON THE WILLIAM PRESTON LANE, JR. MEMORIAL (CHESAPEAKE**  
31 **BAY) BRIDGE, OR ITS APPURTENANT APPROACHES THAT ARE UNDER THE**

1 JURISDICTION OF THE MARYLAND TRANSPORTATION AUTHORITY, IS SUBJECT TO  
2 THE FOLLOWING FINES:

3 (1) 1 CENT FOR EACH POUND FOR THE FIRST 1,000 POUNDS OVER ANY  
4 ALLOWABLE WEIGHT;

5 (2) 5 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT OVER  
6 1,000 POUNDS BUT LESS THAN 2,001 POUNDS;

7 (3) 10 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT  
8 OVER 2,000 POUNDS BUT LESS THAN 5,001 POUNDS;

9 (4) 24 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT  
10 OVER 5,000 POUNDS BUT LESS THAN 10,001 POUNDS;

11 (5) 40 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT  
12 OVER 10,000 POUNDS BUT LESS THAN 20,001 POUNDS; AND

13 (6) 80 CENTS FOR EACH ADDITIONAL POUND OF EXCESS WEIGHT  
14 OVER 20,000 POUNDS.

15 (E) IN COMPUTING A FINE UNDER THIS SECTION, A CREDIT FOR ANY EXCESS  
16 WEIGHT CAUSED BY AN ACCUMULATION OF CINDERS, SNOW, OR ICE SHALL BE  
17 GRANTED.

18 (F) NOTWITHSTANDING ANY OTHER LAW, A COURT MAY NOT SUSPEND OR  
19 REDUCE A FINE IMPOSED FOR A CONVICTION FOR A WEIGHT VIOLATION.

20 (G) (1) IF AN OUT-OF-STATE VEHICLE IS SUBJECT TO A WEIGHT  
21 VIOLATION OR AN OUT-OF-STATE PERSON IS RESPONSIBLE FOR OR OPERATING A  
22 VEHICLE SUBJECT TO A WEIGHT VIOLATION:

23 (I) THE PERSON IS SUBJECT TO A CITATION AND FURTHER  
24 PROCEEDINGS UNDER TITLE 26 OF THIS ARTICLE; OR

25 (II) THE VEHICLE SHALL BE IMPOUNDED UNTIL THE FINE IS  
26 PAID OR ACCEPTABLE COLLATERAL IS POSTED.

27 (2) CARGO CONTAINED IN THE VEHICLE MAY NOT BE IMPOUNDED.

28 (3) IF THE FINE HAS NOT BEEN PAID OR ACCEPTABLE COLLATERAL  
29 HAS NOT BEEN POSTED WITHIN 90 DAYS AFTER THE DATE OF IMPOUNDMENT, THE

1 VEHICLE MAY BE SOLD AT PUBLIC AUCTION UNDER THE JURISDICTION OF THE  
2 COURT TO SATISFY THE FINE, ACCRUED INTEREST, AND COSTS.

3 REVISOR'S NOTE: This section is new language derived without substantive  
4 change from former § 27–105 of this article.

5 In the introductory language of subsection (a)(1) of this section, the former  
6 inaccurate reference to a person who is “charged with” a weight violation is  
7 deleted as the penalties implicitly apply to a person who is convicted of a  
8 weight violation.

9 In subsection (a)(1)(i) of this section, the former redundant reference to the  
10 maximum “registered” weight limit is deleted as included in the reference to  
11 the maximum weight limit for which the vehicle “is registered”.

12 In subsection (a)(1)(ii) of this section, the former redundant reference to a  
13 statutory weight limit “set forth in the Maryland Vehicle Law” is deleted as  
14 included in the reference to weight violations under “the Maryland Vehicle  
15 Law” in the introductory language of subsection (a)(1) of this section.

16 The introductory language of subsection (a)(2) of this section is added for  
17 clarity and consistency with subsection (a)(1) of this section.

18 In subsection (a)(2)(i) of this section, the reference to posting the “weight limit”  
19 is substituted for the former reference to posting the “restriction” for clarity  
20 and consistency within this section.

21 In subsection (a)(2)(ii) of this section, the former clause “, as defined in §  
22 11–118 of this article,” is deleted as unnecessary because all of the defined  
23 terms in Title 11 of this article apply throughout the Maryland Vehicle Law.

24 In the introductory language of subsections (b), (c), and (d) of this section, the  
25 references to a “weight limit [or violation] to which this section applies” are  
26 substituted for the former references to a “registered weight limit, statutory  
27 weight limit, or weight limit imposed by signs” for clarity and brevity.

28 In the introductory language of subsection (b) of this section, the former  
29 reference to a “loading error” is deleted as included in the reference to a  
30 “tolerance”.

31 In the introductory language of subsections (c) and (d) of this section, the  
32 former references to fines “in addition to court costs” are deleted because court  
33 costs are separate from and paid in addition to a fine for a traffic violation. *See*  
34 § 7–301 of the Courts Article. In addition, prepay fines for traffic violations set  
35 by the District Court in the penalty deposit schedule include court costs.

1 Also in the introductory language of subsections (c) and (d) of this section, the  
2 former redundant references to “weight violations that occur” on any highway  
3 or the Chesapeake Bay Bridge are deleted as included in the references to a  
4 “weight violation to which this section applies” on any highway or the  
5 Chesapeake Bay Bridge for clarity and brevity.

6 In subsection (f) and the introductory language of subsection (g)(1) of this  
7 section, the references to a “weight” violation are added for clarity and  
8 consistency within this section.

9 In subsection (f) of this section, the reference prohibiting “a court” from  
10 suspending or reducing a fine is added for clarity.

11 In the introductory language of subsection (g)(1) of this section, the reference  
12 to an out-of-state vehicle “subject to a weight violation” is substituted for the  
13 former reference to an out-of-state vehicle “being operated at the time the  
14 offense is committed” for clarity, brevity, and to more explicitly connect the  
15 vehicle to the violation.

16 In subsection (g)(1)(i) of this section, the reference to a person being subject to  
17 “a citation” and further proceedings is added for clarity.

18 Subsection (g)(2) of this section, formerly § 27–105(f)(2), is rewritten for clarity  
19 and brevity.

20 In subsection (g)(2) of this section, the former clause “, and the cargo may not  
21 be held” is deleted as implicit in the prohibition against impounding cargo.

22 The Department of Legislative Services notes, for consideration by the  
23 General Assembly, that there are overlaps in the graduated schedules of  
24 excess weight fines in subsections (c) and (d) of this section (*e.g.*, “over 5,000  
25 pounds” and “less than 5,001 pounds”). The General Assembly may wish to  
26 amend these subsections to eliminate the overlaps.

27 The Department of Legislative Services further notes, for consideration by the

12 (b) In conjunction with the Maryland Transportation Authority, the  
13 Administration may adopt regulations and develop procedures to carry out the refusal or  
14 suspension of a registration as authorized by this section.

15 (c) The procedures specified in this section are in addition to any other penalty  
16 provided by law for toll violations under § 21–1414 of this article.

17 (d) The provisions of this section may be applied to enforce a reciprocal agreement  
18 entered into by the State and another jurisdiction in accordance with § 21–1415 of this  
19 article.]

23 (a) In this section, “police department” has the same meaning indicated in §  
24 25–201 of this article.

25 (b) (1) For the purpose of impounding or immobilizing a vehicle under this  
26 section, the police department may use its own personnel, equipment, and facilities or,  
27 subject to the provisions of paragraph (2) of this subsection, use other persons, equipment,  
28 and facilities for immobilizing vehicles or removing, preserving, and storing impounded  
29 vehicles.

30 (2) A police department may not authorize the use of a tow truck under  
31 paragraph (1) of this subsection unless the tow truck is registered under § 13–920 of this  
32 article.

33 (c) (1) As a sentence, a part of a sentence, or a condition of probation, a court  
34 may order, for not more than 180 days, the impoundment or immobilization of a solely

1 owned vehicle used in the commission of a violation of § 16–303(c) or (d) of this article if, at  
2 the time of the violation:

3 (i) The owner of the vehicle was driving the vehicle; and

4 (ii) The owner's license was suspended or revoked under § 16–205 of  
5 this article.

6 (2) Among the factors that a court may consider in determining whether to  
7 order an impoundment or immobilization of a vehicle is whether the vehicle is the primary  
8 means of transportation available for the use of the individual's immediate family.

9 (3) (i) Subject to the provisions of subparagraph (ii) of this paragraph,  
10 impoundment or immobilization of a vehicle may not be ordered under this section, if the  
11 registered owner of the vehicle made a bona fide sale, gift, or other transfer of the vehicle  
12 to another person before the date of the finding of a violation of § 16–303(c) or (d) of this  
13 article.

14 (ii) The registered owner of the vehicle has the burden of proving  
15 that a bona fide sale, gift, or other transfer of the vehicle has occurred.

16 (d) (1) The registered owner of a vehicle impounded or immobilized under this  
17 section is responsible for all actual costs incurred as a result of the immobilizing of the  
18 vehicle, or the towing, preserving, and storing of the impounded vehicle.

19 (2) The court may require the registered owner of a vehicle impounded or  
20 immobilized under this section to post a bond or other adequate security to equal the actual  
21 costs of immobilizing the vehicle, or towing, preserving, and storing the vehicle, and  
22 providing the notices required under subsection (f) of this section.

23 (3) Subject to the provisions of this section, a police department that  
24 impounds a vehicle by taking the vehicle into custody or immobilizes a vehicle under this  
25 section promptly shall return possession or use of the vehicle to the registered owner of the  
26 vehicle on payment of all actual costs of immobilizing the vehicle, or towing, preserving,  
27 and storing the impounded vehicle, and providing the notices required under subsection (f)  
28 of this section.

29 (e) If a court orders the impoundment or immobilization of a vehicle under this  
30 section, the court shall provide for the execution of the impoundment or immobilization by  
31 a police department.

32 (f) (1) If a court orders the impoundment or immobilization of a vehicle under  
33 this section, the police department that executes the immobilization, or the impoundment  
34 by taking the vehicle into custody, shall, as soon as reasonably possible and within 7 days  
35 after the police department executes the court order, send a notice by certified mail, return  
36 receipt requested, bearing a postmark from the United States Postal Service, to:

1 (i) Each registered owner of the vehicle as shown in the records of  
2 the Administration; and

3 (ii) Each secured party, as shown in the records of the  
4 Administration.

5 (2) The notice shall:

6 (i) State that the vehicle has been immobilized, or impounded by  
7 being taken into custody;

8 (ii) Describe the year, make, model, and vehicle identification  
9 number of the vehicle;

10 (iii) Provide the location of where the vehicle is immobilized or the  
11 location of the facility where the vehicle is impounded;

12 (iv) Include the amount of the actual costs of immobilization, or  
13 towing, preservation, and storage of an impounded vehicle;

14 (v) Include the amount of the actual costs of the notices required  
15 under this paragraph; and

16 (vi) Provide that, if an impounded vehicle is not reclaimed as  
17 required under this subsection, within 10 days after the date specified in the court order,  
18 the impounded vehicle will be considered an abandoned vehicle and subject to the  
19 provisions of Title 25, Subtitle 2 of this article.

20 (3) If an impounded vehicle is not reclaimed within 10 days after the date  
21 specified in a court order under this section, the vehicle shall be considered an abandoned  
22 vehicle subject to the provisions of Title 25, Subtitle 2 of this article.

23 (g) (1) This section may not be construed to prohibit a lienholder from  
24 exercising its rights under applicable law, including the right to sell a vehicle that has been  
25 impounded or immobilized under this section, in the event of a default in the obligation  
26 giving rise to the lien.

27 (2) (i) A lienholder exercising the right to sell a vehicle that has been  
28 impounded or immobilized under this section shall notify, in writing, the police department  
29 with custody of the vehicle of the lienholder's intention to sell the vehicle.

30 (ii) The notice shall be accompanied by copies of documents giving  
31 rise to the lien and shall include an affidavit under oath by the lienholder that the  
32 underlying obligation is in default and the reasons for the default.

33 (iii) On request of the lienholder and on payment of all costs required  
34 under this section, the vehicle shall be released to the lienholder.

1           (3) Except as provided in paragraph (4) of this subsection, the rights and  
2 duties provided by law to the lienholder for the sale of collateral securing an obligation in  
3 default shall govern the repossession and sale of the vehicle.

4           (4) (i) The lienholder may not be required to take possession of the  
5 vehicle before a sale of the vehicle.

6                       (ii) The proceeds of any sale shall be applied first to the actual costs  
7 of immobilization, or towing, preservation, and storage of an impounded vehicle, and the  
8 actual costs of the notices required under subsection (f) of this section, then as provided by  
9 law for distribution of proceeds of a sale by the lienholder.

10           (5) (i) If the interest of the owner in the vehicle is redeemed, the  
11 lienholder shall, within 10 days after the redemption, mail a notice of the redemption to  
12 the police department who impounded or immobilized the vehicle.

13                       (ii) If the vehicle has been repossessed or otherwise lawfully taken  
14 by the lienholder and the time specified by a court order under this section has not expired,  
15 the lienholder shall return the vehicle within 21 days after the redemption to the police  
16 department who impounded or immobilized the vehicle.

17           (h) This section does not affect the requirements of Title 25, Subtitle 2 of this  
18 article regarding abandoned vehicles.]

22           (a) In addition to being disqualified from driving a commercial motor vehicle  
23 under § 16–812 of this article, a driver or owner who is convicted of violating § 25–112 of

25 months or both.

26           (b) The Administration may not register or transfer the registration of any vehicle  
27 involved in a violation under § 25–112 of this article until final disposition of the violation.

28           (c) The penalties specified in this section are in addition to any other penalty  
29 provided by law for a violation of § 25–112 of this article.]

9 known that the accident might result in serious bodily injury to another person and serious  
10 bodily injury actually occurred to another person, is guilty of a felony and on conviction is  
11 subject to imprisonment for not more than 5 years or a fine of not more than \$5,000 or both.

12 (c) A person who violates § 20–102 of this article (“Driver to remain at scene —  
13 Accident resulting in bodily injury or death”) and who knew or reasonably should have  
14 known that the accident might result in the death of another person and death actually  
15 occurred to another person, is guilty of a felony and on conviction is subject to imprisonment  
16 for not more than 10 years or a fine of not more than \$10,000 or both.】

20 (a) If a person violates any provision of Title 21, Subtitle 4 of this article and the

24 (1) The person is subject to a fine of not more than \$1,000; and

25 (2) The Administration may suspend the person’s license for not more than  
26 180 days.

28 request a hearing on a license suspension imposed under this section.】
