CHAPTER _____

1 AN ACT concerning

2 **Education – Fire Drill Requirements – State Fire Prevention Code**

3 FOR the purpose of requiring the State Superintendent of Schools to require certain county
4 superintendents of schools to hold fire drills in each public school in accordance with
5 the State Fire Prevention Code; and generally relating to fire drills in public schools.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 7–408.

1 (a) The State Superintendent shall require each county superintendent to hold a
2 fire drill in each public school [at least 10 times each school year and at least once every 60
3 days] **IN ACCORDANCE WITH THE STATE FIRE PREVENTION CODE ESTABLISHED**
4 **UNDER § 6–206 OF THE PUBLIC SAFETY ARTICLE.**

5 (b) Each public school shall:

6 (1) Keep records of these fire drills; and

7 (2) Send a copy to the county superintendent.

10 (a) (1) (i) To protect life and property from the hazards of fire and
11 explosion, the Commission shall adopt comprehensive regulations as a State Fire
12 Prevention Code.

13 (ii) The State Fire Prevention Code shall comply with standard safe
14 practice as embodied in widely recognized standards of good practice for fire prevention and
15 fire protection.

16 (iii) The State Fire Prevention Code has the force and effect of law in
17 the political subdivisions of the State.

18 (d) (1) The State Fire Prevention Code establishes the minimum requirements
19 to protect life and property from the hazards of fire and explosion.

20 (2) If a State or local law or regulation is more stringent than the State
21 Fire Prevention Code, the more stringent law or regulation governs if the more stringent
22 law or regulation is:

23 (i) not inconsistent with the State Fire Prevention Code; and

24 (ii) not contrary to recognized standards and good engineering
25 practices.

26 (3) If there is a question whether a State or local law or regulation governs,
27 the decision of the Commission determines:

28 (i) which law or regulation governs; and

29 (ii) whether State and local officials have complied with the State
30 Fire Prevention Code.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2017.
