- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

- 18 (a) (1) In this section the following words have the meanings indicated.

19 (2) "Charging document" means a written accusation alleging that a 20 defendant has committed an offense.

(3) "Citation" means a charging document, other than an indictment, an
information, or a statement of charges, issued to a defendant by a peace officer or other
person authorized by law to do so.

8 (d) Notwithstanding any other provision of the Code or the Maryland Rules, a 9 statement of charges for an offense allegedly committed in the course of executing the 10 duties of the law enforcement officer, emergency services personnel, or the educator may 11 not be filed against a law enforcement officer, emergency services personnel, or educator 12 until the State's Attorney has investigated the circumstances of the matter and made 13 recommendations to the District Court Commissioner in accordance with subsection (c) of 14 this section.

15 (e) This section may not be construed to preclude the State's Attorney from 16 making a determination that an information should be filed against a law enforcement 17 officer, emergency services personnel, or an educator or that a grand jury should be 18 convened to determine whether an indictment should be filed.
