1 AN ACT concerning

Juvenile Court - Jurisdiction

- 3 FOR the purpose of repealing certain provisions of law that exclude from the jurisdiction of 4 the juvenile court a child of a certain age alleged to have committed any of certain offenses; repealing certain provisions of law governing the transfer of certain 5 6 criminal cases to the juvenile court and governing certain criminal court procedures 7 involving a child whose case is eligible for transfer to the juvenile court or whose 8 charges were excluded from the jurisdiction of the juvenile court; altering certain 9 requirements relating to events that must be reported to the Criminal Justice 10 Information System Central Repository; altering certain requirements relating to 11 the fingerprinting of a child adjudicated delinquent; providing for the application of this Act; and generally relating to juvenile law and the jurisdiction of the juvenile 12 13 court.

- 1 (b) Except as provided in subsection (c) of this section, a court exercising criminal 2 jurisdiction in a case involving a child may transfer the case to the juvenile court before 3 trial or before a plea is entered under Maryland Rule 4–242 if:
- 4 (1) the accused child was at least 14 but not 18 years of age when the 5 alleged crime was committed;
- 6 (2) the alleged crime is excluded from the jurisdiction of the juvenile court 7 under § 3–8A–03(d)(1), (4), or (5) of the Courts Article; and
- 8 (3) the court determines by a preponderance of the evidence that a transfer 9 of its jurisdiction is in the interest of the child or society.
- 10 (c) The court may not transfer a case to the juvenile court under subsection (b) of 11 this section if:
- 12 (1) the child was convicted in an unrelated case excluded from the jurisdiction of the juvenile court under § 3–8A–03(d)(1) or (4) of the Courts Article; or
- 14 (2) the alleged crime is murder in the first degree and the accused child 15 was 16 or 17 years of age when the alleged crime was committed.
- 16 (d) In determining whether to transfer jurisdiction under subsection (b) of this section, the court shall consider:
- 18 (1) the age of the child;
- 19 (2) the mental and physical condition of the child;
- 20 (3) the amenability of the child to treatment in an institution, facility, or 21 program available to delinquent children;
- 22 (4) the nature of the alleged crime; and
- 23 (5) the public safety.
- 24 (e) In making a determination under this section, the court may order that a study be made concerning the child, the family of the child, the environment of the child, and other matters concerning the disposition of the case.
- 27 (f) The court shall make a transfer determination within 10 days after the date 28 of a transfer hearing.
- 29 (g) If the court transfers its jurisdiction under this section, the court may order 30 the child held for an adjudicatory hearing under the regular procedure of the juvenile court.
