1 AN ACT concerning

2 **Property Tax Credit – Residential Property Damaged by Natural Disaster**

3 FOR the purpose of altering a certain property tax credit authorized against the county or  
4 municipal corporation property tax for certain residential real property damaged by  
5 flooding to include damage caused by a natural disaster; providing for the application  
6 of this Act; and generally relating to a property tax credit for residential real property  
7 damaged by a natural disaster.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

17 The Mayor and City Council of Baltimore City or the governing body of a county or  
18 of a municipal corporation may grant, by law, a property tax credit under this section  
19 against the county or municipal corporation property tax imposed on residential real
