3 FOR the purpose of authorizing funds in the Bay Restoration Fund to be used for the costs 4 associated with the purchase of certain nutrient eredits load reductions, not to exceed $\mathbf{5}$ a certain amount per year in certain years; requiring certain regulations to be 6 adopted in a certain manner and in accordance with certain requirements; requiring 7 the Department of the Environment to consult with the Secretary of Agriculture and 8 Transportation, the Secretary of Natural Resources, the Secretary of Commerce, the 9 Secretary of Agriculture, and certain stakeholders when developing certain 10regulations; requiring the load reductions purchased under this Act to be consistent 11 with certain accounting procedures; requiring the Department to report to the Bay 12Restoration Fund Advisory Committee annually on the implementation of this Act; 13 requiring the Department, on or before a certain date, to report to certain committees
