## A BILL ENTITLED

1 AN ACT concerning

2 **Public Health – Rabies Vaccination Information – Submission to Local Agencies**  
3 **and Use for Licensing**

4 FOR the purpose of requiring, under certain circumstances, a licensed veterinarian who  
5 vaccinates a dog, cat, or ferret against rabies to send to a certain local agency certain  
6 rabies vaccination information; requiring the licensed veterinarian to send the  
7 information within a certain number of days after a vaccination certificate is  
8 completed; establishing a certain penalty; requiring a local agency to forward the  
9 information to another local agency under certain circumstances; repealing the  
10 prohibition on using information in a rabies vaccination record that a licensed  
11 veterinarian keeps to license a dog, cat, or ferret; defining a certain term; and  
12 generally relating to rabies vaccination information.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

20 **Article – Health – General**

21 18–319.

22 (A) IN THIS SECTION, “LOCAL AGENCY” MEANS THE AGENCY THAT HAS  
23 BEEN DESIGNATED BY A LOCAL JURISDICTION AS THE AGENCY THAT IS  
24 RESPONSIBLE FOR THE ENFORCEMENT OF STATE AND LOCAL ANIMAL LAWS WITHIN  
25 THE LOCAL JURISDICTION.

1           **[(a)] (B)**     A licensed veterinarian who vaccinates a dog, cat, or ferret against  
2 rabies:

3                   (1)     May select the vaccine to be used;

4                   (2)     Shall administer the vaccine in a manner that is consistent with the  
5 recommendations of the National Association of State Public Health Veterinarians;

6                   (3)     Shall issue to the owner of the dog, cat, or ferret a vaccination  
7 certificate, on the form that the Department approves; **[and]**

8                   (4)     Shall keep a record of the vaccination for a period of 5 years; **AND**

9                   **(5)     IF REQUESTED BY A LOCAL AGENCY, SHALL SEND TO THE LOCAL**  
10 **AGENCY:**

11                           **(I)     A COPY OF EACH SIGNED AND COMPLETED VACCINATION**  
12 **CERTIFICATE; OR**

13                           **(II)    INFORMATION     REGARDING     EACH     ADMINISTERED**  
14 **VACCINATION USING THE METHOD SPECIFIED BY THE LOCAL AGENCY.**

15           **(C)   (1)   IF THE LICENSED VETERINARIAN IS REQUIRED TO SEND**  
16 **VACCINATION INFORMATION TO A LOCAL AGENCY UNDER SUBSECTION (B)(5) OF**  
17 **THIS SECTION, THE LICENSED VETERINARIAN SHALL SEND THE INFORMATION**  
18 **WITHIN 45 DAYS AFTER A VACCINATION CERTIFICATE IS COMPLETED.**

19                   **(2)    IF A LICENSED VETERINARIAN WILLFULLY FAILS TO COMPLY**  
20 **WITH PARAGRAPH (1) OF THIS SUBSECTION, A LOCAL AGENCY MAY IMPOSE A CIVIL**  
21 **PENALTY NOT EXCEEDING \$10 FOR EACH VIOLATION.**

22           **(D)    IF A LOCAL AGENCY IS SENT VACCINATION INFORMATION UNDER**  
23 **SUBSECTION (B)(5) OF THIS SECTION FOR A DOG, CAT, OR FERRET OWNED BY A**  
24 **PERSON WHO RESIDES OR IS LOCATED OUTSIDE THE LOCAL JURISDICTION, THE**  
25 **LOCAL AGENCY SHALL FORWARD THE INFORMATION TO THE LOCAL AGENCY FOR**  
26 **THE OTHER LOCAL JURISDICTION.**

27           **[(b)] (E)**     The information in the rabies vaccination record that a licensed  
28 veterinarian keeps may not be used~~[:~~

29                   (1)     To license the dog, cat, or ferret; or

30                   (2)     To] **TO** tax the owner of the dog, cat, or ferret.

1           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
2   October 1, 2017.
