## A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Commercial Bingo – Permits**

3 FOR the purpose of establishing a commercial instant bingo permit in Baltimore City;  
4 authorizing the Bureau of Revenue Collections to issue a permit to an entity that  
5 meets certain requirements; specifying that for commercial purposes the permit  
6 holder may resume operating games of instant bingo in a certain manner under  
7 certain circumstances; requiring the Bureau to adopt regulations to carry out this  
8 Act; and generally relating to commercial bingo in Baltimore City.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
25 That the Laws of Maryland read as follows:

4 (a) (1) This section and § 13-509 of this subtitle also apply to games of instant  
5 bingo.

6 (2) **THIS SECTION DOES NOT APPLY TO GAMES OF COMMERCIAL**  
7 **INSTANT BINGO AUTHORIZED UNDER § 13-511 OF THIS SUBTITLE.**

8 **13-511.**

9 (A) **THERE IS A COMMERCIAL INSTANT BINGO PERMIT.**

10 (B) **THE BUREAU OF REVENUE COLLECTIONS MAY ISSUE A COMMERCIAL**  
11 **INSTANT BINGO PERMIT TO A QUALIFIED ORGANIZATION, AS DEFINED IN § 13-201**  
12 **OF THIS TITLE, THAT WAS AUTHORIZED TO OFFER INSTANT BINGO ON JULY 1, 1995.**

13 (C) **FOR COMMERCIAL PURPOSES, THE PERMIT HOLDER MAY RESUME**  
14 **OPERATING GAMES OF INSTANT BINGO IN THE SAME MANNER USING ELECTRONIC**  
15 **MACHINES, PROVIDED THAT:**

16 (1) **THE MACHINES WERE IN OPERATION FOR A 1-YEAR PERIOD**  
17 **ENDING ON JUNE 30, 1996;**

18 (2) **THE ENTITY DOES NOT OPERATE MORE THAN THE NUMBER OF**  
19 **ELECTRONIC MACHINES IN OPERATION ON JUNE 30, 1996; AND**

20 (3) **THE CONDUCT OF THE GAMING AND OPERATION OF THE**  
21 **MACHINES ARE CONSISTENT WITH ALL OTHER PROVISIONS OF THIS ARTICLE.**

22 (D) **THE BUREAU OF REVENUE COLLECTIONS SHALL ADOPT REGULATIONS**  
23 **TO CARRY OUT THIS SECTION.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 October 1, 2017.
