#### 2 Oyster Poaching – Administrative Penalties – Gear Violations

17 (a) (1) In addition to any other penalty or fine provided in this title, a person 18 who holds a license to catch oysters under § 4–701 of this title and receives a citation for an 19 offense listed under paragraph (2) of this subsection may have the license revoked in 20 accordance with this section.

21 (2) The following offenses, committed in violation of this title or of any 22 regulation adopted under this title, are grounds for revocation of a license to catch oysters 23 under this section:
