## A BILL ENTITLED

1 AN ACT concerning

## 2 Natural Resources – Protection and Restoration of State–Owned Lakes

3 FOR the purpose of establishing the State Lakes Protection and Restoration Fund as a 4 special, nonlapsing fund; specifying the purpose of the Fund; requiring the Secretary  $\mathbf{5}$ of Natural Resources to administer the Fund; requiring the State Treasurer to hold 6 the Fund and the Comptroller to account for the Fund; specifying the contents of the 7 Fund; specifying the purpose for which the Fund may be used; requiring interest 8 earnings of the Fund to be credited to the Fund; requiring the Department of Natural 9 Resources to develop a certain budget; requiring the Department to develop, in coordination with local governments, organizations, and citizens, a certain annual 10 11 work plan; exempting the Fund from a certain provision of law requiring interest 12earnings on State money to accrue to the General Fund of the State; defining a 13 certain term; and generally relating to the protection and restoration of State-owned 14 lakes.

3 **EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE (I)** WITH THE STATE BUDGET. 4

 $\mathbf{5}$ (J) MONEY EXPENDED FROM THE FUND FOR THE PROTECTION OR 6 **RESTORATION OF STATE-OWNED LAKES IS SUPPLEMENTAL TO AND IS NOT** 7 INTENDED TO TAKE THE PLACE OF FUNDING THAT WOULD OTHERWISE BE APPROPRIATED FOR THE PROTECTION OR RESTORATION OF STATE-OWNED LAKES. 8

THE DEPARTMENT SHALL DEVELOP A WORKING BUDGET FOR THE 10 (A) FUNDS RECEIVED FROM THE STATE LAKES PROTECTION AND RESTORATION FUND 11 ESTABLISHED UNDER § 8–205 OF THIS SUBTITLE. 12

13THE DEPARTMENT SHALL DEVELOP, IN COORDINATION WITH LOCAL **(B)** 14GOVERNMENTS, ORGANIZATIONS, AND CITIZENS, AN ANNUAL WORK PLAN THAT PRIORITIZES AND DETAILS PROJECTS THAT WILL RECEIVE FUNDING FROM THE 15STATE LAKES PROTECTION AND RESTORATION FUND. 16

Notwithstanding any other provision of law, and unless 19 (2)(a) (i) 20inconsistent with a federal law, grant agreement, or other federal requirement or with the 21terms of a gift or settlement agreement, net interest on all State money allocated by the 22State Treasurer under this section to special funds or accounts, and otherwise entitled to 23receive interest earnings, as accounted for by the Comptroller, shall accrue to the General Fund of the State. 24
