Elective Franchise - Registration and Voting at Polling Place

- 3 FOR the purpose of authorizing the General Assembly to provide by suitable enactment a 4 process to allow a qualified individual to register and vote at a polling place on election day or on a day designated for voting before election day; making a stylistic 5 6 change; and submitting this amendment to the qualified voters of the State for their adoption or rejection.

- 19 All elections shall be by ballot. Except as provided in **Section 2A OR** Section 3 of
- 20 this article, every citizen of the United States, of the age of 18 years or upwards, who is a
- 21 resident of the State as of the time for the closing of registration next preceding the election,

- 6 [The] EXCEPT AS PROVIDED IN SECTION 2A OF THIS ARTICLE, THE General 7 Assembly shall provide by law for a uniform Registration of the names of all the voters in 8 this State, who possess the qualifications prescribed in this Article, which Registration 9 shall be conclusive evidence to the Judges of Election of the right of every person, thus 10 registered, to vote at any election thereafter held in this State; but no person shall vote, at 11 any election, Federal or State, hereafter to be held in this State, or at any municipal election 12 in the City of Baltimore, unless [his] THE PERSON'S name appears in the list of registered 13 voters; the names of all persons shall be added to the list of qualified voters by the officers 14 of Registration, who have the qualifications prescribed in the first section of this Article, 15 and who are not disqualified under the provisions of the second and third sections thereof.

- THE GENERAL ASSEMBLY SHALL HAVE THE POWER TO PROVIDE BY SUITABLE
 ENACTMENT A PROCESS TO ALLOW A QUALIFIED INDIVIDUAL TO REGISTER AND
 VOTE AT A POLLING PLACE ON ELECTION DAY OR ON A DAY DESIGNATED FOR
 VOTING BEFORE ELECTION DAY IN ACCORDANCE WITH SECTION 3(B) OF THIS
 ARTICLE.
 - SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly determines that the amendment to the Maryland Constitution proposed by this Act affects multiple jurisdictions and that the provisions of Article XIV, § 1 of the Maryland Constitution concerning local approval of constitutional amendments do not apply.
 - SECTION 3. AND BE IT FURTHER ENACTED, That the aforegoing section proposed as an amendment to the Maryland Constitution shall be submitted to the qualified voters of the State at the next general election to be held in November 2018 for their adoption or rejection pursuant to Article XIV of the Maryland Constitution. At that general election, the vote on this proposed amendment to the Constitution shall be by ballot, and upon each ballot there shall be printed the words "For the Constitutional Amendment" and "Against the Constitutional Amendment," as now provided by law. Immediately after the election, all returns shall be made to the Governor of the vote for and against the proposed amendment, as directed by Article XIV of the Maryland Constitution, and further proceedings had in accordance with Article XIV.
