2 **Annual Corrective Bill**

3 FOR the purpose of correcting certain errors or omissions in certain articles of the
4 Annotated Code and in certain uncodified laws; clarifying language; correcting
5 certain obsolete references; reorganizing certain sections of the Annotated Code;
6 ratifying certain corrections made by the publishers of the Annotated Code;
7 providing that this Act is not intended to affect any law other than to correct
8 technical errors; providing for the correction of certain errors and obsolete provisions
9 by the publishers of the Annotated Code; providing for the effect and construction of
10 certain provisions of this Act; and making this Act an emergency measure.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
26 That the Laws of Maryland read as follows:

29 (c) If the money remaining in the Maryland Agricultural Land Preservation Fund
30 at the end of the fiscal year [are] IS insufficient to distribute the total amount applied for
31 under subsection (a) of this section, the maximum amount that may be distributed to any

34 additional funds under this section; less

21 **LICENSE** fees are:

22 (i) \$75 for the issuing fee; and

23 (ii) \$75 for the annual fee.

24 (2) A holder of a Class B–resort license shall pay:

25 (iii) an issuing fee for each new [permit] **DRAFT BEER LICENSE** in
26 an amount equal to the annual fee.

25 **[(7) (V) a Class D beer, wine, and liquor license.**

1 (c) The privilege authorizes the license holder to sell the alcoholic beverages
 2 authorized by the license in commemorative or special event bottles for off-premises
 3 consumption if:

4 (1) the privilege is exercised at a catered event **OR AN EVENT HELD BY A**
 5 **HOLDER OF A CLASS C 2-DAY, 6-DAY, OR 12-DAY LICENSE OR A CLASS C MULTIPLE**
 6 **EVENT LICENSE;**

7 (2) the Board approves the commemorative or special event bottles before
 8 the event occurs; and

9 (3) the commemorative or special event bottles are sold only on the hours
 10 and days that the Board allows.

20 Annotated Code of Maryland, subject to the approval of the Department of Legislative
21 Services, shall make any changes in the text of the Annotated Code necessary to effectuate
22 any termination provision that was enacted by the General Assembly and has taken effect
23 or will take effect prior to October 1, 2017. Any enactment of the 2017 Session of the General
24 Assembly that negates or extends the effect of a previously enacted termination provision
25 shall prevail over the provisions of this section.

26 **SECTION 6. AND BE IT FURTHER ENACTED,** That the publishers of the
27 Annotated Code of Maryland, in consultation with and subject to the approval of the
28 Department of Legislative Services, shall make nonsubstantive corrections to codification,
29 style, capitalization, punctuation, grammar, spelling, and any reference rendered incorrect
30 or obsolete by an Act of the General Assembly, with no further action required by the
31 General Assembly. The publishers shall adequately describe any such correction in an
32 editor’s note following the section affected.

33 **SECTION 7. AND BE IT FURTHER ENACTED,** That Section 2 of this Act shall take
34 effect October 1, 2017, the effective date of Section 2 of Chapter 515 of the Acts of the

1 General Assembly of 2016. If the effective date of Section 2 of Chapter 515 is amended,
2 Section 2 of this Act shall take effect on the taking effect of Section 2 of Chapter 515.

3 SECTION 8. AND BE IT FURTHER ENACTED, That this Act is an emergency
4 measure, is necessary for the immediate preservation of the public health or safety, has
5 been passed by a yea and nay vote supported by three-fifths of all the members elected to
6 each of the two Houses of the General Assembly, and shall take effect from the date it is
7 enacted.
