1 AN ACT concerning

2 **Small Claim Action Appeals From District Court – Nonattorney Representation**

3 FOR the purpose of exempting certain representatives of certain entities from the
4 requirement of admission to the Bar of Maryland and other requirements of the
5 Court of Appeals for representing the entity in the appeals of certain civil actions
6 originating in the District Court under certain circumstances; and generally relating
7 to nonattorney representation in small claim action appeals.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Business Occupations and Professions**

4 10–206.

5 (a) Except as otherwise provided by law, before an individual may practice law in
6 the State, the individual shall:

7 (1) be admitted to the Bar; and

8 (2) meet any requirement that the Court of Appeals may set by rule.

9 (b) This section does not apply to:

10 (1) a person while representing a landlord in a summary ejectment or a
11 rent escrow proceeding in the District Court of Maryland;

12 (2) a person while representing a tenant in a summary ejectment or a rent
13 escrow proceeding in the District Court of Maryland if the person is:

14 (i) a law student practicing in a clinical law program at a law school
15 accredited by the American Bar Association with the in–court supervision of a faculty
16 member; or

17 (ii) employed by a nonprofit organization receiving grants from the
18 Maryland Legal Services Corporation and:

19 1. the person has training and experience;

20 2. the person is supervised by a lawyer; and

21 3. the supervising lawyer’s appearance is entered in the
22 proceeding;

23 (3) an insurance company while defending an insured through staff
24 counsel;

25 (4) an officer of a corporation, an employee designated by an officer of a
26 corporation, a partner in a business operated as a partnership or an employee designated
27 by a partner, a member of a limited liability company or an employee designated by a
28 member of a limited liability company, or an employee designated by the owner of a
29 business operated as a sole proprietorship while the officer, partner, member, or employee
30 is appearing on behalf of the corporation, partnership, limited liability company, or

1 business in a civil action in the District Court of Maryland **OR AN APPEAL FROM THE**
2 **DISTRICT COURT OF MARYLAND** if:

3 (i) the action **OR APPEAL**:

4 1. is based on a claim that does not exceed the amount set
5 under § 4–405 of the Courts Article for a small claim action; and

6 2. is not based on an assignment, to the corporation,
7 partnership, or business, of the claim of another;

8 (ii) in the case of a designated employee, the employee:

9 1. is not assigned on a full–time basis to appear in the
10 District Court on behalf of the corporation, partnership, or business;

11 2. provides the court a power of attorney sworn to by the
12 employer that certifies that the designated employee is an authorized agent of the
13 corporation, partnership, limited liability company, or sole proprietorship and may bind the
14 corporation, partnership, limited liability company, or sole proprietorship on matters
15 pending before the court; and

16 3. is not an individual who is disbarred or suspended as a
17 lawyer in any state; and

18 (iii) the corporation, partnership, limited liability company, or
19 business does not contract, hire, or employ another business entity to provide appearance
20 services;

21 (5) an individual who is authorized by a county employee to represent the
22 employee at any step of the county’s grievance procedure; or

23 (6) a director or an officer of a common ownership community while
24 representing the common ownership community in a dispute, hearing, or other matter
25 before a board or commission established to oversee one or more of the following common
26 ownership communities:

27 (i) a development subject to a declaration enforced by a homeowners
28 association as defined in § 11B–101 of the Real Property Article;

29 (ii) a residential condominium as defined in § 11–101 of the Real
30 Property Article; or

31 (iii) a cooperative housing corporation as defined in § 5–6B–01 of the
32 Corporations and Associations Article.

2 The District Court has exclusive jurisdiction over a small claim action, which, for
3 purposes of this section, means a civil action for money in which the amount claimed does
4 not exceed \$5,000 exclusive of interest, costs, and attorney’s fees, if attorney’s fees are
5 recoverable by law or contract; and landlord tenant action under §§ 8-401 and 8-402 of the
6 Real Property Article, in which the amount of rent claimed does not exceed \$5,000 exclusive
7 of interest and costs.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2017.
