### 1 AN ACT concerning

# Baltimore City – Property Tax Credit – Rental Discount for Baltimore City Police Officers

4 FOR the purpose of authorizing the Mayor and City Council of Baltimore City to grant, by  $\mathbf{5}$ law, a certain property tax credit against the property tax imposed on certain 6 apartment buildings in Baltimore City; establishing that certain landlords that 7 provide certain rental discounts to certain police officers may be eligible for the tax 8 credit; establishing the amount of the tax credit; authorizing the Mayor and City 9 Council of Baltimore City to establish, by law, the duration of the credit and certain other provisions relating to the tax credit; providing for the application of this Act; 10 11 defining certain terms; and generally relating to a property tax credit in Baltimore 12City for rental discounts provided to police officers in Baltimore City.

"Apartment 1 **(II)** BUILDING" MEANS Α MULTI-UNIT  $\mathbf{2}$ **RESIDENTIAL BUILDING LOCATED IN BALTIMORE CITY THAT CONTAINS 10 OR MORE** 3 **DWELLING UNITS.** (III) "QUALIFIED LANDLORD" MEANS A LANDLORD THAT: 4  $\mathbf{5}$ 1. **OWNS AN APARTMENT BUILDING; AND** 6 2. THE RENT AMOUNT FOR AN EQUIVALENT DWELLING 22UNIT IN THE APARTMENT BUILDING; OR 232. THE FAIR MARKET RENTAL VALUE OF THE DWELLING 24UNIT. (3) A PROPERTY TAX CREDIT GRANTED UNDER THIS SUBSECTION 25FOR A TAXABLE YEAR SHALL EQUAL 100% OF THE TOTAL DOLLAR VALUE OF THE 2627DISCOUNTS APPLIED TO THE RENT OF A QUALIFIED TENANT DURING THE TAXABLE 28YEAR. 29THE MAYOR AND CITY COUNCIL OF BALTIMORE CITY MAY (4) 30 ESTABLISH, BY LAW:

3 (II) ADDITIONAL REQUIREMENTS FOR OR LIMITATIONS ON 4 ELIGIBILITY FOR THE CREDIT; AND

5(III) ANY OTHER PROVISIONS NECESSARY TO IMPLEMENT THE6CREDIT.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
1, 2017, and shall be applicable to all taxable years beginning after June 30, 2017.
