A LICENSE MAY NOT BE ISSUED FOR:

- 1 (I) A LOCATION THAT HAS BEEN LICENSED UNDER ANY CLASS OF ON–SALE LICENSE WITHIN 2 YEARS PRECEDING THE DATE OF APPLICATION FOR THE LICENSE; OR
- 4 (II) A RESTAURANT THAT ALLOWS SERVICE OF PURCHASED 5 FOOD TO A CUSTOMER WHO IS NOT SEATED AT A TABLE.
- 6 (2) A LICENSE MAY NOT BE CONVERTED TO ANY OTHER CLASS OF 7 LICENSE.
- 8 (D) THE QUALIFICATIONS FOR A LICENSE HOLDER, THE LICENSE FEES, AND
 9 THE HOURS AND DAYS OF SALE FOR A LICENSE EXEMPTED UNDER SUBSECTION
 10 (B)(6) OF THIS SECTION ARE THE SAME AS THOSE FOR A CLASS B BEER, WINE, AND
 11 LIQUOR (ON-SALE) HOTEL AND RESTAURANT LICENSE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 13 1, 2017.
