A BILL ENTITLED

1 AN ACT concerning

2 **Queen Anne's County – Alcoholic Beverages – Class D Beer, Wine, and Liquor**
3 **and Class 9 Limited Distillery Licenses**

4 FOR the purpose of authorizing in Queen Anne's County a holder of a Class D beer, wine,
5 and liquor license and a Class 9 limited distillery license to sell liquor for
6 off-premises consumption under certain conditions; prohibiting the holder of a Class
7 D beer, wine, and liquor license and a Class 9 limited distillery license from selling
8 beer for off-premises consumption; and generally relating to alcoholic beverages
9 sales in Queen Anne's County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Alcoholic Beverages**

23 27–102.

24 This title applies only in Queen Anne's County.

2 (a) There is a Class D beer, wine, and liquor license.

3 (b) **(1) [The] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE**
4 license authorizes the license holder to sell:

5 **[(1)] (I) beer, wine, and liquor for on-premises consumption; and**

6 **[(2)] (II) beer for off-premises consumption.**

7 **(2) A HOLDER OF A CLASS D BEER, WINE, AND LIQUOR LICENSE AND**
8 **A CLASS 9 LIMITED DISTILLERY LICENSE:**

9 **(I) MAY SELL:**

10 **1. BEER, WINE, AND LIQUOR FOR ON-PREMISES**
11 **CONSUMPTION; AND**

12 **2. LIQUOR THAT IS DISTILLED AT THE LOCATION**
13 **DESCRIBED IN THE LICENSE FOR OFF-PREMISES CONSUMPTION; BUT**

14 **(II) MAY NOT SELL BEER FOR OFF-PREMISES CONSUMPTION.**

15 (c) The license may not be issued for use by a drugstore.

16 (d) The annual license fee is \$1,800.

17 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June**
18 **1, 2017.**
