A BILL ENTITLED

1 AN ACT concerning

2 **Children in Need of Assistance – Sex Trafficking**

3 FOR the purpose of altering the definition of “sexual abuse” in provisions of law relating to
4 children in need of assistance to include an act that involves the sex trafficking of a
5 child by any individual; defining the terms “sexual molestation or exploitation” and
6 “sex trafficking” in provisions of law relating to children in need of assistance;
7 making certain conforming changes; and generally relating to children in need of
8 assistance and sex trafficking.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That the Laws of Maryland read as follows:

1 **Article – Courts and Judicial Proceedings**

2 3–801.

3 (a) In this subtitle the following words have the meanings indicated.

4 (f) “Child in need of assistance” means a child who requires court intervention
5 because:

6 (1) The child has been abused, has been neglected, has a developmental
7 disability, or has a mental disorder; and

8 (2) The child’s parents, guardian, or custodian are unable or unwilling to
9 give proper care and attention to the child and the child’s needs.

10 **(X) “SEX TRAFFICKING” MEANS THE RECRUITMENT, HARBORING,**
11 **TRANSPORTATION, PROVISION, OBTAINING, PATRONIZING, OR SOLICITING OF A**
12 **CHILD FOR THE PURPOSE OF A COMMERCIAL SEX ACT.**

13 ~~[(x) (1)]~~ **(Y)** “Sexual abuse” means an act that involves [sexual]:

14 **(1) SEXUAL** molestation or [sexual] exploitation of a child by:

15 (i) A parent or other individual who has permanent or temporary
16 care or custody or responsibility for supervision of the child; or

17 (ii) A household or family member; **OR**

18 **(2) SEX TRAFFICKING OF A CHILD BY ANY INDIVIDUAL.**

19 ~~[(2)]~~ **(Z)** [“Sexual abuse”] **“SEXUAL MOLESTATION OR EXPLOITATION”**
20 includes:

21 ~~[(i)]~~ **(1)** Allowing or encouraging a child to engage in:

22 [1.] **(I)** Obscene photography, films, poses, or similar
23 activity;

24 [2.] **(II)** Pornographic photography, films, poses, or similar
25 activity; or

26 [3.] **(III)** Prostitution;

27 [(ii) Human trafficking;]

28 [(iii)] **(2)** Incest;

- 1 [(iv)] (3) Rape;
- 2 [(v)] (4) Sexual offense in any degree;
- 3 [(vi)] (5) Sodomy; and
- 4 [(vii)] (6) Unnatural or perverted sexual practices.

5 [(y)] (AA) “Shelter care” means a temporary placement of a child outside of the
6 home at any time before disposition.

7 [(z)] (BB) “Shelter care hearing” means a hearing held before disposition to
8 determine whether the temporary placement of the child outside of the home is warranted.

9 [(aa)] (CC) “TPR proceeding” means a proceeding to terminate parental rights.

10 [(bb)] (DD) “Voluntary placement” means a placement in accordance with §
11 5–525(b)(1)(i) or (iii) or (3) of the Family Law Article.

12 [(cc)] (EE) “Voluntary placement hearing” means a hearing to obtain a judicial
13 determination as to whether continuing a voluntary placement is in the best interests of
14 the child.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
16 1, 2017.
