~~where "W" = overall gross weight on any group of 2 or more consecutive axles to the nearest 500 pounds, "L" = distance in feet measured horizontally between the vertical centerlines of the extreme of any group of 2 or more consecutive axles, and "N" = number of axles in group under consideration, except that 2 consecutive sets of tandem axles may carry a gross load of 34,000 pounds each providing the overall distance between the first and last axles of such consecutive sets of tandem axles is 36 feet or more; provided, that such overall gross weight may not exceed eighty thousand (80,000) pounds, including any enforcement or statutory tolerances.~~

 24 specified in this article; and

25 (iii) For a violation of a weight restriction specified in this section
 26 that exceeds 5,000 pounds, subject the exceptional hauling permit to immediate
 27 confiscation by an officer or authorized civilian employee of the Department of State Police,
 28 an officer of the Maryland Transportation Authority Police, or any police officer.

29 (2) A person who confiscates an exceptional hauling permit under

9 (i) 1. \$250 for the issuance of a new annual permit or the annual
10 renewal; or

11 2. \$30 for the issuance of a 30-day permit;

12 (ii) \$1,000 for the reinstatement of a permit that was revoked under
13 subsection (f)(3) of this section for a first violation; and

14 (iii) \$5,000 for the reinstatement of a permit that was revoked under
15 subsection (f)(3) of this section for a second or subsequent violation within the prior 24
16 months.

17 (2) A fee paid under this subsection is nonrefundable.

18 **[(i)] (J)** Except as otherwise provided in this section, an exceptional hauling
19 permit is valid for:

20 (1) 1 year from the date of issuance for an annual permit; or

21 (2) 30 consecutive days for a 30-day permit.

22 **[(j)] (K)** In consultation with the Secretary of State Police, the State Highway
23 Administration shall adopt regulations to implement this section.

24 **[(k)] (L)** (1) An exceptional hauling permit is issued under this section at the
25 discretion of the State Highway Administrator.

26 (2) The State Highway Administrator may stop issuing or renewing
27 exceptional hauling permits under this section if the Administrator determines that the
28 use of the permits is adversely affecting any part of the State highway system.

29 (3) The State Highway Administrator shall promptly report to the General
30 Assembly, in accordance with § 2-1246 of the State Government Article, regarding any
31 decision to stop issuing or renewing exceptional hauling permits under this section and the
32 reason for the decision.

1 SECTION 2. AND BE IT FURTHER ENACTED, That:

2 (a) The State Highway Administration shall notify the Department of Legislative
 3 Services within 5 days after determining that 45% of the poultry processing facility
 4 industry's combinations of vehicles used for carrying live poultry have an axle configuration
 5 of not less than six axles.

6 (b) (1) If the notice required under subsection (a) of this section is not received
 7 by the Department of Legislative Services on or before October 31, 2020, this Act shall be
 8 abrogated and of no further force and effect without the necessity of further action by the
 9 General Assembly.

10 (2) If the notice required under subsection (a) of this section is received by
 11 the Department of Legislative Services on or before October 31, 2020, this Act shall, at the
 12 end of October 31, 2022, be abrogated and of no further force and effect without the necessity
 13 of further action by the General Assembly.
