## Counties and Municipalities - Land Bank Authorities

3 FOR the purpose of altering certain provisions of law concerning the authority of a 4 municipality to establish a land bank authority; making certain provisions of law 5 concerning the establishment of a land bank authority applicable to a municipality 6 or county; authorizing two or more local governments to enter into a certain 7 intergovernmental cooperation agreement; providing for the continued operation of 8 an authority under certain circumstances; establishing certain powers of an 9 authority; authorizing an authority to enforce a water and sewer lien under certain 10 circumstances; providing for the tax treatment of property sold by an authority to a 11 nonprofit organization under certain circumstances; exempting property held by an 12 authority from a certain requirement to sell; authorizing the Mayor and City Council 13 of Baltimore City a governing body of a county or other taxing authority to transfer 14 certain interest in property to an authority under certain circumstances; exempting 15 property held by an authority from certain taxes under certain circumstances; 16 altering and defining certain terms; making certain conforming changes; and 17 generally relating to land bank authorities.



38 39 Until a judgment is issued by the circuit court that forecloses all rights of redemption in any property sold by the collector, the property shall continue to be assessed as though no sale had been made, whether the governing body of the county or some other person holds the certificate of sale. Once the judgment is passed, the property shall be transferred on the assessment books or records to the holder of the certificate of sale notwithstanding the provisions of § 3–104 of the Real Property Article. After the transfer, the property shall be assessed to the holder of the certificate of sale for property tax purposes.
