## A BILL ENTITLED

1 AN ACT concerning

### 2 **Family Law – Child Abuse and Neglect – Definitions**

3 FOR the purpose of altering the definition of “abuse” for the purpose of certain child abuse  
4 and neglect statutes to include the physical or mental injury of a child by a person  
5 who, because of the person’s position or occupation, exercises authority over the child  
6 under certain circumstances; providing that “abuse” does not include the physical  
7 injury of a child by accidental means; altering the definition of “mental injury” for  
8 the purpose of certain child abuse and neglect statutes; making certain conforming  
9 changes to the definition of “sexual abuse” for the purpose of certain child abuse and  
10 neglect statutes; and generally relating to child abuse and neglect.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

17 That the Laws of Maryland read as follows:

### 18 **Article – Family Law**

19 5–701.

20 (b) (1) “Abuse” means:

21 [(1)] (I) the physical or mental injury of a child [by any parent or other  
22 person who has permanent or temporary care or custody or responsibility for supervision  
23 of a child, or by any household or family member,] under circumstances that indicate that  
24 the child’s health or welfare is harmed or at substantial risk of being harmed **BY:**

13                   **(r) "Mental injury" means the observable, identifiable, and substantial**

14                   **impairment of a child's mental or psychological ability to function CAUSED BY AN**

15                   **INTENTIONAL ACT OR SERIES OF ACTS, REGARDLESS OF WHETHER THERE WAS AN**

16                   **INTENT TO HARM THE CHILD.**

17                   **(x) (1) "Sexual abuse" means any act that involves sexual molestation or**

18                   **exploitation of a child by [a parent or other person who has permanent or temporary care**

19                   **or custody or responsibility for supervision of a child, or by any household or family**

20                   **member]:**

21                   **(I) A PARENT;**

22                   **(II) A HOUSEHOLD MEMBER OR FAMILY MEMBER;**

23                   **(III) A PERSON WHO HAS PERMANENT OR TEMPORARY CARE OR**

24                   **CUSTODY OF THE CHILD;**

25                   **(IV) A PERSON WHO HAS RESPONSIBILITY FOR SUPERVISION OF**

26                   **THE CHILD; OR**

27                   **(V) A PERSON WHO, BECAUSE OF THE PERSON'S POSITION OR**

28                   **OCCUPATION, EXERCISES AUTHORITY OVER THE CHILD.**

29                   **(2) "Sexual abuse" includes:**

- (i) allowing or encouraging a child to engage in:
    1. obscene photography, films, poses, or similar activity;
    2. pornographic photography, films, poses, or similar
    3. prostitution;
  - (ii) human trafficking;
  - (iii) incest;
  - (iv) rape;
  - (v) sexual offense in any degree;
  - (vi) sodomy; and
  - (vii) unnatural or perverted sexual practices.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect

13 October 1, 2017.
