A BILL ENTITLED

1 AN ACT concerning

2 **Natalie M. LaPrade Medical Cannabis Commission Reform Act**

3 FOR the purpose of repealing provisions of law establishing the Natalie M. LaPrade
4 Medical Cannabis Commission, authorizing the Commission to register certifying
5 providers, authorizing the Commission to license medical cannabis growers,
6 dispensaries, processors, certain agents, and independent testing laboratories, and
7 requiring the Commission to provide certain reports and adopt certain regulations;
8 repealing provisions of law related to the functions of the Commission; establishing
9 the Medical Cannabis Division in the Department of Health and Mental Hygiene;
10 providing for the purpose of the Division; requiring the Division to develop certain
11 identification cards and adopt certain regulations; requiring the Division to develop
12 and maintain a Web site that provides certain information; authorizing the Division
13 to employ certain staff and set certain fees; establishing the Natalie M. LaPrade
14 Medical Cannabis Licensing Unit in the Division; providing for the membership of
15 the Unit; requiring the membership of the Unit to reflect the racial and gender
16 diversity of the State; providing for the terms of the members; requiring the
17 Governor to designate the chair of the Unit; providing that a majority of the full
18 authorized membership of the Unit is a quorum; providing that a member of the Unit
19 shall receive a certain annual salary and is entitled to certain reimbursement;
20 requiring the Unit to solicit, review, minimally qualify, and rank applications for
21 certain licenses each year; establishing the Natalie M. LaPrade Medical Cannabis
22 Division Fund; requiring the Division to administer the Fund; providing that the
23 Fund is a special, nonlapsing fund that is not subject to a certain provision of law;
24 requiring the State Treasurer to hold the Fund separately, and the Comptroller to
25 account for the Fund; requiring the Fund to be invested and reinvested in a certain
26 manner; providing that investment earnings of the Fund shall be retained to the
27 credit of the Fund; providing that the Fund is subject to a certain audit; requiring
28 the Comptroller to pay out money from the Fund as directed by the Division;
29 providing that the Fund consists of certain money and fees; prohibiting any part of
30 the Fund from reverting or being credited to certain funds; providing that
31 expenditures from the Fund may be made only in accordance with the State budget;

2 Account under the authority of the Board of Public Works; providing for the purpose
3 of the Account; providing that the Account shall receive a certain percentage of
4 certain sales; requiring money in the Account to be invested and reinvested by the
5 Treasurer and that interest and earnings shall accrue to the Account; requiring the
6 Comptroller to account for the Account and to pay out money from the Account in a
7 certain manner; providing that the Account is a special, nonlapsing fund that is not
8 subject to a certain provision of law; providing that expenditures from the Account
9 shall be made only in a certain manner; requiring the Board of Public Works to make
10 certain grants; requiring certain eligible fund managers to reserve a certain portion
11 of certain grants for a certain purpose; requiring the Unit to consider certain funds
12 when scoring and ranking certain applications; requiring certain eligible fund
13 managers to prioritize meeting certain needs, keep certain records, and provide a
14 certain annual report; authorizing certain eligible fund managers to make a certain
15 determination; providing that certain eligible fund managers are subject to a certain
16 audit; authorizing an eligible fund manager to use certain money to pay certain
17 expenses; requiring the Division to register certain individuals as certifying
18 providers; requiring a provider to submit a certain proposal to the Division to be
19 registered as a certifying provider; prohibiting the Division from requiring an
20 individual to meet certain requirements to be registered as a certifying provider;
21 encouraging the Division to approve provider applications for certain medical
22 conditions; prohibiting the Division from limiting treatment of a particular medical
23 condition to one class of providers; authorizing the Division to approve certain
24 applications; prohibiting a certifying provider or the spouse of a certifying provider
25 from receiving certain gifts or having a certain ownership interest; authorizing a
26 certifying provider to receive certain compensation under certain circumstances;
27 providing that a qualifying patient may be a patient of a certifying provider or may
28 be referred by the certifying provider; requiring a certifying provider to provide each
29 written certification to the Division; requiring the Division to issue an identification
30 card to certain individuals under certain circumstances; authorizing a certifying
31 provider to discuss medical cannabis with a patient; providing that a qualifying
32 patient or caregiver may obtain medical cannabis only from certain entities;
33 providing that certain qualifying patients may obtain medical cannabis only through
34 a certain individual; providing that a caregiver may serve no more than a certain
35 number of qualifying patients at any time; providing that a qualifying patient may
36 have no more than a certain number of caregivers; authorizing a certifying provider
37 to register on a certain basis; requiring the Division to grant or deny a certain
38 renewal based on the performance of the certifying provider in complying with
39 certain regulations; requiring the Division, on or before a certain date each year, to
40 report certain information to the Governor and the General Assembly; requiring the
41 Division to license medical cannabis growers that meet certain requirements;
42 requiring the Division, on or before a certain date, to provide certain assistance to
43 the Unit and to award a certain number of medical cannabis grower licenses;
44 authorizing the Division, on or before a certain date and with a certain frequency, to
45 award a certain number of medical cannabis grower licenses; requiring the Division
46 to establish a certain application review process; requiring that certain applicants
47 be placed on a certain waiting list in a certain order; requiring the Division to

1 consider a certain applicant's placement on the waiting list when awarding certain
2 licenses unless the Division makes a certain determination; prohibiting the Division
3 from awarding more than one medical cannabis grower license to each applicant;
4 requiring a medical cannabis grower to pay a certain application fee; requiring the
5 Division to set certain standards; requiring each medical cannabis grower agent to
6 be registered with the Division and to obtain a certain criminal history records check;
7 requiring a medical cannabis grower to apply to the Division for a certain
8 registration card in a certain manner; requiring a medical cannabis grower to follow
9 certain procedures after a grower agent ceases to be associated with the grower
10 within a certain time frame; requiring the Division to take certain action on receipt
11 of a certain notice; prohibiting the Division from registering certain persons as
12 grower agents; providing that a medical cannabis grower license is valid for a certain
13 number of years on initial licensure and on renewal; providing that a certain
14 application may be submitted in certain forms; requiring the Division to encourage
15 the licensure of certain medical cannabis growers; requiring certain factors to
16 account for certain percentages of a certain score if a certain scoring system is used;
17 requiring the Division to actively seek to achieve certain diversity when licensing
18 certain growers, processors, and dispensaries; requiring the Division to strongly
19 encourage and conduct ongoing outreach to certain business enterprises to apply for
20 certain licensure; requiring the Division to establish a certain evaluation preference;
21 requiring certain growers, dispensaries, and processors, beginning on a certain date,
22 to provide certain information to the Division at certain intervals; requiring certain
23 entities to meet certain requirements; providing that certain growers may provide
24 medical cannabis only to certain entities and individuals; authorizing certain
25 growers to dispense medical cannabis from a certain location; authorizing certain
26 individuals to obtain medical cannabis from certain facilities; authorizing certain
27 entities to grow and process medical cannabis on the same premises; requiring
28 certain growers to ensure that certain safety precautions are followed; requiring the
29 Division to establish certain requirements; authorizing the Division to inspect
30 certain entities for a certain purpose; authorizing the Division to impose certain
31 penalties or rescind certain licenses under certain circumstances; requiring the
32 Division to license medical cannabis dispensaries; requiring an applicant for a
33 medical cannabis dispensary license to submit a certain application and fee to the
34 Division; requiring the Division to award a certain number of medical cannabis
35 dispensary licenses; prohibiting the Division from awarding more than one medical
36 cannabis dispensary license to each applicant; providing that a medical cannabis
37 dispensary license is valid for a certain number of years on initial licensure and on
38 renewal; providing that certain dispensaries and certain dispensary agents may not
39 be subject to certain penalties; requiring each medical cannabis dispensary agent to
40 be at least a certain age, be registered with the Division, and obtain a certain
41 criminal history records check; requiring a medical cannabis dispensary to apply to
42 the Division for a certain registration card in a certain manner; requiring a medical
43 cannabis dispensary to follow certain procedures after a dispensary agent ceases to
44 be associated with the dispensary within a certain time frame; prohibiting the
45 Division from registering certain individuals as dispensary agents; requiring the
46 Division to license medical cannabis processors; requiring an applicant for a medical
47 cannabis processor license to submit a certain application and fee to the Division;

1 requiring the Division to award a certain number of medical cannabis processor
2 licenses; prohibiting the Division from awarding more than one medical cannabis
3 processor license to each applicant; providing that a medical cannabis processor
4 license is valid for a certain number of years on initial licensure and on renewal;
5 providing that certain processors and certain processor agents may not be subject to
6 certain penalties; requiring each medical cannabis processor agent to be at least a
7 certain age, be registered with the Division, and obtain a certain criminal history
8 records check; requiring a medical cannabis processor to apply to the Division for a
9 certain registration card in a certain manner; requiring a medical cannabis processor
10 to follow certain procedures after a processor agent ceases to be associated with the
11 processor within a certain time frame; prohibiting the Division from registering
12 certain persons as processor agents; requiring the Division to license at least a
13 certain number of private independent testing laboratories for a certain purpose;
14 requiring a laboratory to meet certain requirements to be registered as an
15 independent testing laboratory; authorizing the Division to inspect certain
16 independent testing laboratories for a certain purpose; authorizing the sale or
17 transfer of certain licenses under certain circumstances; providing for the forfeiture
18 of certain licenses under certain circumstances with a certain exception; requiring
19 certain entities to follow certain procedures when selling or transferring a certain
20 license; requiring certain applicants to submit certain forms and fees to the Criminal
21 Justice Information System Central Repository as part of a certain process; requiring
22 the Central Repository to forward certain information to the Division; authorizing
23 the Division to accept an alternate method of a criminal history records check under
24 certain circumstances; providing that certain information is confidential, may not be
25 redisseminated, and may be used only for a certain purpose; authorizing certain
26 individuals to contest the contents of certain statements as provided in a certain
27 provision of law; providing that certain persons may not be subject to certain
28 penalties for the medical use of cannabis; prohibiting a person from distributing,
29 possessing, manufacturing, or using cannabis that has been diverted from certain
30 individuals or entities; establishing certain penalties; providing that certain
31 penalties are in addition to certain other penalties; providing that certain provisions
32 of this Act may not be construed to authorize an individual to engage in certain
33 activities and does not prevent the imposition of certain penalties for certain actions;
34 providing that this Act may not be construed to provide certain immunity to certain
35 persons; providing that this Act may not be construed to require certain facilities or
36 programs to report certain disciplinary actions to the Division; providing that certain
37 State employees are eligible for certain reimbursement under certain circumstances;
38 authorizing the Governor to suspend implementation of certain provisions of this Act
39 under certain circumstances; making a conforming change; requiring all functions,
40 powers, duties, equipment, assets, liabilities, and employees of the Natalie M.
41 LaPrade Medical Cannabis Commission to be transferred to the Medical Cannabis
42 Division; requiring the Department to take certain actions to ensure that the Medical
43 Cannabis Division and the Unit are operational within a certain period of time;
44 requiring the Department to assign certain staff to the Division and to the Unit;
45 providing that certain actions of the Natalie M. LaPrade Medical Cannabis
46 Commission shall be given full force and effect by the Division; specifying the terms
47 of the initial members of the Unit; making the provisions of this Act severable;

1 defining certain terms; making this Act an emergency measure; and generally
2 relating to the repeal of the Natalie M. LaPrade Medical Cannabis Commission and
3 the establishment of the Medical Cannabis Division and the Natalie M. LaPrade
4 Medical Cannabis Licensing Unit in the Department of Health and Mental Hygiene.

28 That Section(s) 13–3301 through 13–3316 and the subtitle “Subtitle 33. Natalie M. LaPrade
29 Medical Cannabis Commission” of Article – Health – General of the Annotated Code of
30 Maryland be repealed.

36 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**

1 (B) "ACCOUNT" MEANS THE SMALL, MINORITY, AND WOMEN-OWNED
2 MEDICAL CANNABIS BUSINESS ACCOUNT ESTABLISHED UNDER § 13-3304 OF THIS
3 SUBTITLE.

4 (C) "CAREGIVER" MEANS:

5 (1) A PERSON WHO HAS AGREED TO ASSIST WITH A QUALIFYING
6 PATIENT'S MEDICAL USE OF CANNABIS; AND

7 (2) FOR A QUALIFYING PATIENT UNDER THE AGE OF 18 YEARS, A
8 PARENT OR LEGAL GUARDIAN.

9 (D) "CERTIFYING PROVIDER" MEANS AN INDIVIDUAL WHO:

10 (1) (I) 1. HAS AN ACTIVE, UNRESTRICTED LICENSE TO
11 PRACTICE MEDICINE THAT WAS ISSUED BY THE STATE BOARD OF PHYSICIANS
12 UNDER TITLE 14 OF THE HEALTH OCCUPATIONS ARTICLE; AND

13 2. IS IN GOOD STANDING WITH THE STATE BOARD OF
14 PHYSICIANS;

15 (II) 1. HAS AN ACTIVE, UNRESTRICTED LICENSE TO
16 PRACTICE DENTISTRY THAT WAS ISSUED BY THE STATE BOARD OF DENTAL
17 EXAMINERS UNDER TITLE 4 OF THE HEALTH OCCUPATIONS ARTICLE; AND

18 2. IS IN GOOD STANDING WITH THE STATE BOARD OF
19 DENTAL EXAMINERS;

20 (III) 1. HAS AN ACTIVE, UNRESTRICTED LICENSE TO
21 PRACTICE PODIATRY THAT WAS ISSUED BY THE STATE BOARD OF PODIATRIC
22 MEDICAL EXAMINERS UNDER TITLE 16 OF THE HEALTH OCCUPATIONS ARTICLE;
23 AND

24 2. IS IN GOOD STANDING WITH THE STATE BOARD OF
25 PODIATRIC MEDICAL EXAMINERS; OR

26 (IV) 1. HAS AN ACTIVE, UNRESTRICTED LICENSE TO
27 PRACTICE REGISTERED NURSING AND HAS AN ACTIVE, UNRESTRICTED
28 CERTIFICATION TO PRACTICE AS A NURSE PRACTITIONER OR A NURSE MIDWIFE
29 THAT WERE ISSUED BY THE STATE BOARD OF NURSING UNDER TITLE 8 OF THE
30 HEALTH OCCUPATIONS ARTICLE; AND

1 2. IS IN GOOD STANDING WITH THE STATE BOARD OF
2 NURSING;

3 (2) HAS A STATE CONTROLLED DANGEROUS SUBSTANCES
4 REGISTRATION; AND

5 (3) IS REGISTERED WITH THE DIVISION TO MAKE CANNABIS
6 AVAILABLE TO PATIENTS FOR MEDICAL USE IN ACCORDANCE WITH REGULATIONS
7 ADOPTED BY THE DIVISION.

8 (E) “COMMISSION” MEANS THE NATALIE M. LAPRADE MEDICAL CANNABIS
9 COMMISSION.

10 (F) “DISPENSARY” MEANS AN ENTITY LICENSED UNDER THIS SUBTITLE
11 THAT ACQUIRES, POSSESSES, PROCESSES, TRANSFERS, TRANSPORTS, SELLS,
12 DISTRIBUTES, DISPENSES, OR ADMINISTERS CANNABIS, PRODUCTS CONTAINING
13 CANNABIS, RELATED SUPPLIES, RELATED PRODUCTS CONTAINING CANNABIS
14 INCLUDING FOOD, TINCTURES, AEROSOLS, OILS, OR OINTMENTS, OR EDUCATIONAL
15 MATERIALS FOR USE BY A QUALIFYING PATIENT OR CAREGIVER.

16 (G) “DISPENSARY AGENT” MEANS AN OWNER, A MEMBER, AN EMPLOYEE, A
17 VOLUNTEER, AN OFFICER, OR A DIRECTOR OF A DISPENSARY.

18 (H) “DIVISION” MEANS THE MEDICAL CANNABIS DIVISION IN THE
19 DEPARTMENT.

20 (I) “FUND” MEANS THE NATALIE M. LAPRADE MEDICAL CANNABIS
21 DIVISION FUND ESTABLISHED UNDER § 13–3304 OF THIS SUBTITLE.

22 (J) “GROWER” MEANS AN ENTITY LICENSED UNDER THIS SUBTITLE THAT:

23 (1) (I) CULTIVATES, MANUFACTURES, PROCESSES, PACKAGES, OR
24 DISPENSES MEDICAL CANNABIS; OR

25 (II) PROCESSES MEDICAL CANNABIS PRODUCTS; AND

26 (2) IS AUTHORIZED BY THE DIVISION TO PROVIDE CANNABIS TO A
27 QUALIFYING PATIENT, A CAREGIVER, A PROCESSOR, A DISPENSARY, OR AN
28 INDEPENDENT TESTING LABORATORY.

29 (K) “GROWER AGENT” MEANS AN OWNER, AN EMPLOYEE, A VOLUNTEER, AN
30 OFFICER, OR A DIRECTOR OF A GROWER.

1 (L) “INDEPENDENT TESTING LABORATORY” MEANS A FACILITY, AN ENTITY,
2 OR A SITE THAT OFFERS OR PERFORMS TESTS RELATED TO THE INSPECTION AND
3 TESTING OF CANNABIS AND PRODUCTS CONTAINING CANNABIS.

4 (M) “PROCESSOR” MEANS AN ENTITY THAT:

5 (1) TRANSFORMS MEDICAL CANNABIS INTO ANOTHER PRODUCT OR
6 EXTRACTS; AND

7 (2) PACKAGES AND LABELS MEDICAL CANNABIS.

8 (N) “PROCESSOR AGENT” MEANS AN OWNER, A MEMBER, AN EMPLOYEE, A
9 VOLUNTEER, AN OFFICER, OR A DIRECTOR OF A PROCESSOR.

10 (O) “QUALIFYING PATIENT” MEANS AN INDIVIDUAL WHO:

11 (1) HAS BEEN PROVIDED WITH A WRITTEN CERTIFICATION BY A
12 CERTIFYING PROVIDER IN ACCORDANCE WITH A BONA FIDE PROVIDER–PATIENT
13 RELATIONSHIP; AND

14 (2) IF UNDER THE AGE OF 18 YEARS, HAS A CAREGIVER.

15 (P) “UNIT” MEANS THE NATALIE M. LAPRADE MEDICAL CANNABIS
16 LICENSING UNIT IN THE DIVISION.

17 (Q) “WRITTEN CERTIFICATION” MEANS A CERTIFICATION THAT:

18 (1) IS ISSUED BY A CERTIFYING PROVIDER TO A QUALIFYING PATIENT
19 WITH WHOM THE PROVIDER HAS A BONA FIDE PROVIDER–PATIENT RELATIONSHIP;

20 (2) INCLUDES A WRITTEN STATEMENT CERTIFYING THAT, IN THE
21 PROVIDER’S PROFESSIONAL OPINION, AFTER HAVING COMPLETED AN ASSESSMENT
22 OF THE PATIENT’S MEDICAL HISTORY AND CURRENT MEDICAL CONDITION, THE
23 PATIENT HAS A CONDITION:

24 (I) THAT MEETS THE INCLUSION CRITERIA AND DOES NOT
25 MEET THE EXCLUSION CRITERIA OF THE CERTIFYING PROVIDER’S APPLICATION;
26 AND

27 (II) FOR WHICH THE POTENTIAL BENEFITS OF THE MEDICAL
28 USE OF CANNABIS WOULD LIKELY OUTWEIGH THE HEALTH RISKS FOR THE PATIENT;
29 AND

1 **(3) MAY INCLUDE A WRITTEN STATEMENT CERTIFYING THAT, IN THE**
2 **PROVIDER'S PROFESSIONAL OPINION, A 30-DAY SUPPLY OF MEDICAL CANNABIS**
3 **WOULD BE INADEQUATE TO MEET THE MEDICAL NEEDS OF THE QUALIFYING**
4 **PATIENT.**

6 **(A) THERE IS A MEDICAL CANNABIS DIVISION IN THE DEPARTMENT.**

7 **(B) THE PURPOSE OF THE DIVISION IS TO DEVELOP POLICIES,**
8 **PROCEDURES, GUIDELINES, AND REGULATIONS TO IMPLEMENT PROGRAMS TO**
9 **MAKE MEDICAL CANNABIS AVAILABLE TO QUALIFYING PATIENTS IN A SAFE AND**
10 **EFFECTIVE MANNER.**

11 **(C) (1) THE DIVISION SHALL DEVELOP IDENTIFICATION CARDS FOR**
12 **QUALIFYING PATIENTS AND CAREGIVERS.**

13 **(2) (I) THE DIVISION SHALL ADOPT REGULATIONS THAT**
14 **ESTABLISH THE REQUIREMENTS FOR IDENTIFICATION CARDS PROVIDED BY THE**
15 **DIVISION.**

16 **(II) THE REGULATIONS ADOPTED UNDER SUBPARAGRAPH (I)**
17 **OF THIS PARAGRAPH SHALL INCLUDE:**

18 1. **THE INFORMATION TO BE INCLUDED ON AN**
19 **IDENTIFICATION CARD;**

20 2. **THE METHOD THROUGH WHICH THE DIVISION WILL**
21 **DISTRIBUTE IDENTIFICATION CARDS; AND**

22 3. **THE METHOD THROUGH WHICH THE DIVISION WILL**
23 **TRACK IDENTIFICATION CARDS.**

24 **(D) THE DIVISION SHALL DEVELOP AND MAINTAIN A WEB SITE THAT:**

25 **(1) PROVIDES INFORMATION ON HOW AN INDIVIDUAL CAN OBTAIN**
26 **MEDICAL CANNABIS IN THE STATE; AND**

27 **(2) PROVIDES CONTACT INFORMATION FOR LICENSED GROWERS,**
28 **PROCESSORS, AND DISPENSARIES.**

29 **(E) THE DIVISION MAY EMPLOY A STAFF, INCLUDING CONTRACTUAL STAFF,**
30 **IN ACCORDANCE WITH THE STATE BUDGET.**

1 (F) THE DIVISION MAY SET REASONABLE FEES TO COVER THE COSTS OF
2 OPERATING THE DIVISION.

4 (A) THERE IS A NATALIE M. LAPRADE MEDICAL CANNABIS LICENSING
5 UNIT IN THE DIVISION.

6 (B) THE UNIT CONSISTS OF THE FOLLOWING MEMBERS:

7 (1) THREE MEMBERS OF THE PUBLIC, APPOINTED BY THE GOVERNOR
8 WITH THE CONSENT OF THE SENATE OF MARYLAND AND THE HOUSE OF
9 DELEGATES;

10 (2) THREE MEMBERS OF THE PUBLIC, APPOINTED BY THE
11 PRESIDENT OF THE SENATE, WITH THE CONSENT OF THE SENATE OF MARYLAND
12 AND THE HOUSE OF DELEGATES; AND

13 (3) THREE MEMBERS OF THE PUBLIC, APPOINTED BY THE SPEAKER
14 OF THE HOUSE OF DELEGATES, WITH THE CONSENT OF THE SENATE OF MARYLAND
