## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Publication of Notices**

3 FOR the purpose of requiring the Board of License Commissioners for Harford County to  
4 publish notice of a hearing for an alcoholic beverages license application in a certain  
5 manner; altering the manner in which the Board is required to publish certain  
6 licensing decisions; and generally relating to alcoholic beverages in Harford County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages**

3 (a) The following sections of Title 4, Subtitle 2 (“Issuance or Denial of Local  
4 Licenses”) of Division I of this article apply in the county without exception or variation:

5 (1) § 4–205 (“Chain store, supermarket, or discount house”);

6 (2) § 4–206 (“Limitations on retail sales floor space”);

7 (3) § 4–207 (“Licenses issued to minors”);

8 (4) § 4–209 (“Hearing”);

9 (5) § 4–213 (“Replacement licenses”); and

10 (6) § 4–214 (“Waiting periods after denial of license applications”).

11 (b) The following sections of Title 4, Subtitle 2 (“Issuance or Denial of Local  
12 Licenses”) of Division I of this article apply in the county:

13 (1) § 4–202 (“Authority of local licensing boards”), subject to § 22–1502 of  
14 this subtitle;

15 (2) § 4–203 (“Prohibition against issuing multiple licenses to individual or  
16 for use of entity”), subject to §§ 22–1503 and 22–1504 of this subtitle and Subtitle 13, Part  
17 III and Subtitle 16, Part II of this title;

18 (3) § 4–204 (“Prohibition against issuing multiple licenses for same  
19 premises”), subject to §§ 22–1503 and 22–1504 of this subtitle and Subtitle 13, Part III of  
20 this title;

21 (4) § 4–208 (“Notice of license application required”), subject to § 22–1505  
22 of this subtitle;

23 (5) § 4–210 (“Approval or denial of license application”), subject to §§  
24 22–1506 and 22–1507 of this subtitle;

25 (6) § 4–211 (“License forms; effective date; expiration”), subject to §  
26 22–1508 of this subtitle; and

27 (7) § 4–212 (“License not property”), in addition to § 22–1509 of this  
28 subtitle.

1           **(a) BEFORE HOLDING A HEARING FOR AN APPLICATION FOR A LICENSE,**  
2 **THE BOARD SHALL PUBLISH NOTICE OF THE APPLICATION TWO TIMES IN 2**  
3 **SUCCESSIVE WEEKS:**

4                   **(1) IN ONE NEWSPAPER OF GENERAL CIRCULATION PUBLISHED IN**  
5 **THE COUNTY; ~~OR~~ AND**

6                   **(2) ON THE BOARD'S WEB SITE.**

7           **(B) (1)** For a hearing for an application for a new license or an upgrade to an  
8 existing license, the Board shall post a notice in a conspicuous location on the exterior of  
9 the location described in the application.

10                   **(2)** The notice shall be on a sign that measures at least 12 by 18 inches and  
11 include:

12                           (i) the class of license for which application is made;

13                           (ii) the name of the applicant; and

14                           (iii) the date, time, and location for the application hearing.

15                   **(3)** The notice shall remain posted for 20 days before the hearing.

16           **[(b)] (C) (1)** The Board shall publish its decision on an application for a new  
17 license, an upgrade of an existing license, or a change of location of an existing license:

18                           **(I)** in [two newspapers] **ONE NEWSPAPER** of general circulation  
19 published in the county; ~~OR~~ AND

20                           **(II) ON THE BOARD'S WEB SITE.**

21                   **(2)** The decision shall state the name of the license holder, the type of  
22 license, and the location of the premises.

23           **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect July  
24 1, 2017.
