- **(B)** THERE IS A HOME SPRINKLER AND FIRE SAFETY ASSISTANCE FUND. 1 2 THE PURPOSE OF THE FUND IS TO PROVIDE GRANTS TO OFFSET THE (C) 3 COSTS OF INSTALLING A SPRINKLER SYSTEM WHEN PURCHASING A HOME. THE DEPARTMENT SHALL ADMINISTER THE FUND. SECTION, THE DEPARTMENT SHALL:

- 1 (2) USE THE NONTARGETED LIMITS IF THE TARGETED LIMITS ARE UNAVAILABLE; AND
- 3 (3) USE THE APPROPRIATE TARGET LIMIT FOR THE HOUSEHOLD SIZE.
- 4 (I) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND 5 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.
- 6 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO THE GENERAL FUND OF THE STATE.
- 8 (J) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE 9 WITH THE STATE BUDGET.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 11 October 1, 2017.
