10. Description and Purpose of Organization (Limit length to visible area)				
Cylburn Arboretum Association, a 501(c)3 friends group, supports the Arboretum, a Baltimore City park, through its mission: maintenance of the trees and gardens, 4 miles of woodland trails, and an extensive educational program focused on nature and cultural arts A summer nature camp for children ages 5-11 is accessible to all through scholarship support. Field trips for school-age children, nature enthusiasts, and other visitors are led by volunteer naturalists. The Nature Museum, in the historic Carriage House, displays natural history artifacts native to the Mid-Atlantic Piedmont, and is central to the educational programming. The Association employs an Executive Director and two office staff members, as well as four part-time gardeners. A team of volunteers provides garden and plant care, trail maintenance and staffs programs and other activities.				

11. Description and Purpose of Project (Limit length to visible area)

We seek funding to support Phase II of the preservation and renovation of the the historic Carriage House; funding provided last year by SB 191, matched by the City of Baltimore Department of Recreation and Parks, is on hand to complete Phase I stabilization of the structure. We now request funding to obtain architectural design services for complete restoration of the upper and lower levels of the structure, to design an addition to house fully accessible expanded education space, restrooms, and elevator; design a new entrance and lobby and the infrastructure to support all the facilities; and to design, construct and install an historically correct Portico to replace the dilapidated Portico being removed. The budget includes civil engineering site design work for the existing and all proposed construction.

Round all amounts to the nearest \$1,000. The totals in Items 12 (Estimated Capital Costs) and 13 (Proposed Funding Sources) must match. The proposed funding sources must not include the value of real property unless an equivalent value is shown under Estimated Capital Costs.

28. Comments

The 19th Century Carriage House at Cylburn Arboretum is an historically significant structure designed by George A. Frederick, who also designed Baltimore's City Hall. It is perfectly located to serve as the home and center of educational programming provided by the Cylburn Arboretum Association; it will house the Nature Museum (which includes the most complete collection of Maryland birds, display for which will be expanded), expanded indoor and outdoor education space (including a new addition of unique and compelling design), hands-on exhibits for children and adults alike, and provide much needed office and storage space for the Association staff. Our project includes preservation and restoration of the historic space, replacement of the infrastructure and systems, construction of additional facilities--education and exhibit space, accessible restrooms, an elevator, a new lobby--appropriate connections between the original structure and the new construction, storage, and meeting space.

The renewed facility will serve as a vital center connecting our neighbors and visitors with the natural environment, drawing an expanded group of visitors to the Arboretum and serving the citizens of the area. In addition, the project will rescue a sadly deteriorated historic structure and transform it into an attractive and well-utilized building. The new addition will be aesthetically stunning and a new magnet for visitors, drawing an expanded audience to the Arboretum.
