Environment and Transportation

St. Mary's County - Sheriff, County Treasurer, and State's Attorney - Salaries

This bill increases, beginning in calendar 2018, the salary of the St. Mary's County Sheriff by establishing that the salary is equal to the salary of a Department of State Police (DSP) Lieutenant Colonel (Step 12). The bill also increases the salary of the State's Attorney in St. Mary's County by establishing that the salary is equal to the salary of a circuit court judge. Finally, the bill increases to \$63,000 the salary of the Treasurer of St. Mary's County. Pursuant to constitutional requirements, the salary increases take effect at the beginning of the next terms of offices.

Fiscal Summary

State Effect: None.

Local Effect: St. Mary's County expenditures increase by approximately \$38,000 in FY 2019 and by approximately \$76,000 annually thereafter. Local revenues are not affected.

Small Business Effect: None.

Analysis

Current Law/Background: The salary of the Sheriff of St. Mary's County is set at \$104,040 for calendar 2017 and \$106,120 for calendar 2018. The State's Attorney for St. Mary's County receives a salary of \$127,200, which is equal to 90% of the salary of a judge of the District Court (set at \$141,333). **Exhibit 1** shows the salary for the state's attorney and sheriff in each county based on fiscal 2017 data, as provided by the Maryland Association of Counties. The annual salary of the County Treasurer of St. Mary's County is set at \$51,005 for calendar 2017 and \$51,515 for calendar 2018. Not all counties have a

county treasurer (which is an elected position); however, **Exhibit 2** shows fiscal 2017 salary information for those that do.

Article III, § 35 of the Maryland Constitution prohibits the salary or compensation of any public officer from being increased or diminished during the individual's term of office, except those whose full term is fixed by law in excess of four years.

Local Expenditures: St. Mary's County expenditures increase by \$38,011 in fiscal 2019 and by \$76,021 annually thereafter. Although the bill specifies that the salaries of the Sheriff and the Treasurer are for calendar 2018, pursuant to constitutional requirements, the salaries are not altered until the next terms of offices, which are estimated to commence in January 2019. Accordingly, the estimate accounts for all increases taking effect in January 2019, includes fringe benefits, and is based on the current salaries for a lieutenant colonel of DSP at Step 12 (\$128,219) and circuit court judge (\$154,433).
