AMENDMENTS TO SENATE BILL 740
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, after “program;” insert “authorizing a certain nonpublic school to participate in a certain feeding program; requiring the State to be responsible for reimbursing certain nonpublic schools under certain circumstances; providing for the distribution of certain funding to certain nonpublic schools and county boards;”; in line 6, strike “a nonprofit” and substitute “certain”; in lines 7 and 9, in each instance, strike “school” and substitute “schools”; in lines 8 and 11, in each instance, strike “nonprofit” and substitute “certain”; and in line 10, after the semicolon insert “requiring certain nonpublic schools to provide a free feeding program for certain children; providing for the use of certain funds for certain nonpublic schools; authorizing a nonpublic school to provide a certain free breakfast program; providing for the eligibility for certain nonpublic schools for a certain State reimbursement under certain circumstances;”.

AMENDMENT NO. 2

On page 2, in line 11, strike “a”; in the same line, strike “free feeding”; in line 12, strike “PROGRAM” and substitute “**THE PROGRAM**”; in line 16, after “boards” insert “**AND PARTICIPATING NONPUBLIC SCHOOLS IN THE SAME MANNER AS THE PROCESS ESTABLISHED**”; in line 17, after “(C)” insert “**(1) A NONPUBLIC SCHOOL IN THE STATE THAT PARTICIPATES IN THE FEDERAL SCHOOL BREAKFAST PROGRAM OR THE NATIONAL SCHOOL LUNCH PROGRAM MAY PARTICIPATE IN THE STATE FREE FEEDING PROGRAM.**”

(2) IF A NONPUBLIC SCHOOL PARTICIPATES IN THE STATE FREE FEEDING PROGRAM, THE STATE SHALL BE RESPONSIBLE FOR REIMBURSING THE PARTICIPATING NONPUBLIC SCHOOL UNDER SUBSECTION (D) OF THIS SECTION.

and in line 18, strike “**NONPROFIT**” and substitute “**PARTICIPATING**”.

On page 3, in line 7, strike “**(D)**” and substitute “**(E)**”; in lines 8 and 12, in each instance, strike “**NONPROFIT**” and substitute “**PARTICIPATING**”; in line 9, strike the second “A” and substitute “**THE**”; in line 15, after “school” insert “**AND PARTICIPATING NONPUBLIC SCHOOL**”; and in line 20, after “board” insert “**AND PARTICIPATING NONPUBLIC SCHOOL**”.

On page 4, in line 7, after “(a)” insert “**(1)**”; and after line 9, insert:

“(2) (I) A NONPUBLIC ELEMENTARY SCHOOL MAY PROVIDE A FREE BREAKFAST PROGRAM IN ACCORDANCE WITH THIS SUBTITLE.

“(II) IF A NONPUBLIC ELEMENTARY SCHOOL PROVIDES A FREE BREAKFAST PROGRAM, THE PARTICIPATING NONPUBLIC ELEMENTARY SCHOOL SHALL BE ELIGIBLE FOR THE STATE REIMBURSEMENT OF THE STUDENT SHARE OF THE COSTS FOR THOSE BREAKFASTS UNDER § 7-703 OF THIS ARTICLE.”

On page 5, in line 13, strike “**NONPROFIT**” and substitute “**PARTICIPATING**”.
