AMENDMENTS TO HOUSE BILL 653

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Vogt” and substitute “Vogt, Pena–Melnyk, West, Kipke, Krebs, McDonough, and Morgan”; in line 2, after “Opioid” insert “and Benzodiazepine”; in the same line, strike “Information” and substitute “Benefits”; in line 4, after “requiring” insert “that”; in the same line, strike “health care providers to discuss certain information” and substitute “patients be advised of the benefits”; in line 5, strike “with certain patients or,” and substitute “and benzodiazepines”; strike beginning with the comma in line 6 down through “changes” in line 14 and substitute “providing that a violation of this Act is grounds for disciplinary action by a certain health occupations board”; in line 14, strike “the discussion of information and” and substitute “advice regarding benefits and”; and in line 15, after “opioids” insert “and benzodiazepines”.

AMENDMENT NO. 2

On pages 2 and 3, strike in their entirety the lines beginning with line 6 on page 2 through line 14 on page 3, inclusive.

On page 3, in lines 15, 17, 18, 21, 22, 23, 25, 26, 27, 30, and 31, in each instance, strike the bracket; in lines 15, 17, 18, 21, 22, 23, 25, 26, 30, and 31, strike “**(C)** **(1)**”, “**(I)**”, “**(II)**”, “**1.**”, “**2.**”, “**3.**”, “**4.**”, “**(2)**”, “**(I)**”, and “**(II)**”, respectively; in line 27, strike “**PARAGRAPH (1)**”; and in the same line, strike “**SUBSECTION**”.

On page 4, in line 1, strike the brackets; in the same line, strike “**(III)**”; after line 1, insert:

“(D) (1) WHEN A PATIENT IS PRESCRIBED AN OPIOID UNDER SUBSECTION (B) OF THIS SECTION, THE PATIENT SHALL BE ADVISED OF THE BENEFITS AND RISKS ASSOCIATED WITH THE OPIOID.”

“(2) WHEN A PATIENT IS CO-PRESCRIBED A BENZODIAZEPINE WITH AN OPIOID THAT IS PRESCRIBED UNDER SUBSECTION (B) OF THIS SECTION, THE PATIENT SHALL BE ADVISED OF THE BENEFITS AND RISKS ASSOCIATED WITH THE BENZODIAZEPINE AND THE CO-PRESCRIPTION OF THE BENZODIAZEPINE.”;

in line 2, strike “(d)” and substitute “(E)”; in the same line, strike the brackets; and in the same line, after “(b)” insert “OR (D)”.
