On page 6, in line 5, strike "<u>7–326(a)</u>, and 12–202(g)" and substitute "<u>and 7–326(a)</u> and (e)"; in line 10, after "<u>5–7B–07</u>," insert "<u>and</u>"; and in line 11, strike "<u>, 7–326(e)</u>, <u>8–301</u>, and 12–202(a)".

On page 19, in line 8, strike "THE INTERAGENCY COMMISSION" and substitute "FOR THE PURPOSES OF THIS SECTION OTHER THAN SUBSECTION (C), THE BOARD OF PUBLIC WORKS"; in lines 13 and 24, in each instance, strike "INTERAGENCY COMMISSION" and substitute "BOARD OF PUBLIC WORKS"; and in line 16, before "INTERAGENCY" insert "BOARD OF PUBLIC WORKS, AT THE RECOMMENDATION OF THE".

On page 20, in lines 13, 16, and 18 and 19, in each instance, strike "INTERAGENCY COMMISSION" and substitute "BOARD OF PUBLIC WORKS".

On page 21, in lines 17 and 18, strike "<u>INTERAGENCY COMMISSION</u>" and substitute "<u>BOARD OF PUBLIC WORKS</u>"; in lines 30 and 31, strike "<u>INTERAGENCY COMMISSION</u>"; and in line 31, after "decisions" insert "<u>BY THE INTERAGENCY COMMISSION TO THE BOARD OF PUBLIC WORKS</u>".

On page 22, in lines 4 and 5, 15, 20, 23 and 24, and 29, in each instance, strike "INTERAGENCY COMMISSION" and substitute "BOARD OF PUBLIC WORKS".

On page 23, in lines 3, 5, 10, 18, 19, and 36, in each instance, strike "INTERAGENCY COMMISSION" and substitute "BOARD OF PUBLIC WORKS".

On page 26, in lines 9 and 20 and 21, in each instance, strike "INTERAGENCY COMMISSION" and substitute "BOARD OF PUBLIC WORKS"; in line 11, after "The" insert "BOARD OF PUBLIC WORKS OR THE"; in line 25, strike "APPROVE" and substitute "PROVIDE RECOMMENDATIONS TO THE BOARD OF PUBLIC WORKS FOR"; strike in their entirety lines 29 through 32, inclusive; in line 33, strike "(4)" and substitute "(3)"; in line 34, after "to" insert "THE BOARD OF PUBLIC WORKS,"; and in line 35, after "Assembly" insert a comma.

On page 27, strike in their entirety lines 10 through 19, inclusive, and substitute:

"(4) THE REMAINING PUBLIC SCHOOL CONSTRUCTION ALLOCATION FOR THE FOLLOWING FISCAL YEAR MAY BE ALLOCATED BY THE BOARD OF PUBLIC WORKS AS PROVIDED IN REGULATION.";

and in lines 20 and 25, strike "(D)" and "(E)", respectively, and substitute "(C)" and "(D)", respectively.

On page 28, in lines 1 and 24, strike "<u>(F)</u>" and "<u>(G)</u>", respectively, and substitute "<u>(E)</u>" and "<u>(F)</u>", respectively.

On page 33, in line 28, strike "<u>INTERAGENCY COMMISSION</u>" and substitute "BOARD OF PUBLIC WORKS".
