On page 1, in line 12, after "Committee;" insert "requiring that certain written materials be provided in the preferred language of the Advisory Committee members, as necessary; requiring that training or educational opportunities be made available to Advisory Committee members on certain processes;"; in line 15, after the semicolon insert "providing that, subject to a certain exception, a certified community health worker training program must be approved by the Department before operating in the State; providing that certain apprenticeship programs may be accredited by the Department as community health worker training programs;"; in line 16, after "accrediting" insert "certified"; in line 18, after the semicolon insert "authorizing the Department to adopt certain regulations related to the certification of community health workers; authorizing the Department to adopt certain regulations recommended by the Advisory Committee;"; and strike beginning with "establishing" in line 21 down through the semicolon in line 24 and substitute "requiring the Department to establish a deadline after which an individual must be certified under this Act to make certain representations; prohibiting a certain individual from making a certain representation to the public after a certain date; providing that an individual who violates a certain provision of this Act is subject to a certain penalty;".

AMENDMENT NO. 2

"(F) WRITTEN MATERIALS USED TO CONDUCT THE BUSINESS OF THE ADVISORY COMMITTEE SHALL BE PROVIDED IN THE PREFERRED LANGUAGE OF THE ADVISORY COMMITTEE MEMBERS, AS NECESSARY.

(G) TRAINING OR EDUCATIONAL OPPORTUNITIES SHALL BE MADE AVAILABLE TO ADVISORY COMMITTEE MEMBERS ON THE FORMAL AND INFORMAL PROCESSES THAT WILL BE USED TO CONDUCT THE BUSINESS OF THE ADVISORY COMMITTEE.";

in line 19, strike "THE" and substitute "AFTER SEEKING INPUT FROM THE DEPARTMENT OF LABOR, LICENSING, AND REGULATION, THE MARYLAND HIGHER EDUCATION COMMISSION, THE MARYLAND RURAL HEALTH ASSOCIATION, THE MARYLAND ACADEMY OF NUTRITION AND DIETETICS, THE MARYLAND STATE DENTAL ASSOCIATION, COMMUNITY AND HOSPITAL EMPLOYERS OF COMMUNITY HEALTH WORKERS, AND INSTITUTIONS OF POSTSECONDARY EDUCATION WITH PROGRAMS IN NURSING, SOCIAL WORK, AND DIETETICS, THE"; in line 20, after "TRAINING" insert "PROGRAMS"; and strike beginning with "CRIMINAL" in line 25 down through "(5)" in line 27.

(III) AN APPRENTICESHIP PROGRAM REGISTERED WITH THE DEPARTMENT OF LABOR, LICENSING, AND REGULATION MAY BE ACCREDITED BY THE DEPARTMENT AS A CERTIFIED COMMUNITY HEALTH WORKER TRAINING PROGRAM.

AMENDMENT NO. 5

"(F) (1) THE DEPARTMENT SHALL ESTABLISH A DEADLINE AFTER WHICH AN INDIVIDUAL MUST BE CERTIFIED UNDER THIS SUBTITLE TO MAKE REPRESENTATIONS TO THE PUBLIC THAT THE INDIVIDUAL IS A CERTIFIED COMMUNITY HEALTH WORKER.

(2) ON OR AFTER THE DATE SET UNDER PARAGRAPH (1) OF THIS SUBSECTION, UNLESS CERTIFIED AS A COMMUNITY HEALTH WORKER UNDER THIS SUBTITLE, AN INDIVIDUAL MAY NOT REPRESENT TO THE PUBLIC BY TITLE THAT THE INDIVIDUAL IS CERTIFIED AS A COMMUNITY HEALTH WORKER.

(3) AN INDIVIDUAL WHO VIOLATES PARAGRAPH (2) OF THIS SUBSECTION IS SUBJECT TO A PENALTY DETERMINED AND COLLECTED BY THE DEPARTMENT.".
