AMENDMENTS TO HOUSE BILL 1615

AMENDMENT NO. 1

On page 1, in line 8, strike “eligibility for” and substitute “entitlement to”; in line 10, strike “report” and substitute “form”; in line 11, strike the first comma and substitute “and”; in the same line, strike “, and record certain information”; strike beginning with “requiring” in line 17 down through “regulations;” in line 19; in line 20, after “manner;” insert “requiring the monthly allowable assistance under the Program to equal a certain amount in a certain fiscal year;”; in the same line, after “equal” insert “at least”; strike beginning with “authorizing” in line 21 down through the semicolon in line 27; in line 28, strike the first comma and substitute “and”; and strike beginning with “, prescribe” in line 28 down through “actions” in line 29.

On page 2, in line 15, strike “5-5B-12” and substitute “5-5B-09”.

AMENDMENT NO. 2

On page 4, in line 4, strike “(A)”; in lines 4 and 5, strike “ELIGIBLE FOR” and substitute “ENTITLED TO”; in line 13, after “ON” insert “THE”; in the same line, strike “FINDINGS” and substitute “FORM REQUIRED UNDER § 5-5B-05 OF THIS SUBTITLE”; in line 14, strike “THAT RENDERS THE APPLICANT UNABLE TO WORK FOR” and substitute “THAT IS EXPECTED TO LAST”; strike in their entirety lines 16 through 19, inclusive; strike beginning with “RENDER” in line 21 down through “FOR” in line 22 and substitute “LAST”; and in line 27, strike “1.” and substitute “(I)”.

On page 4 in line 24, on page 6 in line 28, and on page 7 in lines 8, 13, and 14, in each instance, strike “INSURANCE” and substitute “INCOME”.

On page 5, in line 1, strike “2.” and substitute “(II)”; in line 8, strike “IN A MANNER PRESCRIBED BY THE ADMINISTRATION” and substitute “ON THE MEDICAL FORM REQUIRED UNDER § 5-5B-05 OF THIS SUBTITLE”; in line 10, strike “INSURANCE” and substitute “INCOME THAT HAS NOT BEEN WITHDRAWN OR FINALLY DENIED”; in line 19, strike “REPORT” and substitute “FORM”; in line 20, strike “A STATEMENT ON THE NATURE” and substitute “THE NAME”; in line 22, strike “AN EXAMINING PHYSICIAN” and substitute “A LICENSED HEALTH CARE PROVIDER”; and in line 24, strike “THAT” and substitute “WHETHER”.

On pages 5 and 6, strike beginning with “VERIFY” in line 25 on page 5 down through “(2)” in line 1 on page 6 and substitute “EVALUATE WHETHER”.

On page 6, in line 1, strike “OTHER”; strike in their entirety lines 5 through 10, inclusive; in line 14, strike “REPORT PROVIDED” and substitute “FORM REQUIRED”; in lines 18 and 19, in each instance, strike “IN” and substitute “ON”; and in lines 18 and 20, in each instance, strike “REPORT” and substitute “FORM”.

On page 7, strike in their entirety lines 23 through 28, inclusive.

On page 8, in line 1, before “THE” insert “(A)”; after line 15, insert:

“(B) ASSISTANCE SHALL BE PAID TO THE APPLICANT MONTHLY.”;

in line 3, after “IS” insert “EQUAL TO AT LEAST”; strike beginning with “EQUAL” in line 4 down through “2020” in line 7 and substitute “\$215”; in line 8, strike “EQUAL TO 85%” and substitute “72%”; in line 11, strike “AND”; strike beginning with “AND” in line 12 down through “TO” in line 13 and substitute “, 75% OF”; and in line 15, strike “THAT FISCAL YEAR” and substitute “FISCAL YEAR 2022”;

(4) FOR FISCAL YEAR 2023, 78% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2023;

(5) FOR FISCAL YEAR 2024, 81% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2024;

(6) FOR FISCAL YEAR 2025, 84% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2025;

(7) FOR FISCAL YEAR 2026, 87% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2026;

(8) FOR FISCAL YEAR 2027, 90% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2027;

(9) FOR FISCAL YEAR 2028, 93% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2028;

(Over)

(10) FOR FISCAL YEAR 2029, 96% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM IN FISCAL YEAR 2029; AND

(11) FOR FISCAL YEAR 2030 AND EACH YEAR THEREAFTER, 100% OF THE MONTHLY ALLOWABLE BENEFIT FOR A ONE-PERSON HOUSEHOLD RECEIVING TEMPORARY CASH ASSISTANCE THROUGH THE FAMILY INVESTMENT PROGRAM FOR THAT FISCAL YEAR".

On pages 8 and 9, strike in their entirety the lines beginning with line 16 on page 8 through line 14 on page 9, inclusive, and substitute "**5-5B-09**".

On page 9, in line 17, after the semicolon insert "**AND**".

On pages 9 and 10, strike beginning with the comma in line 19 on page 9 down through "**DIRECTS**" in line 4 on page 10.
