(C) (1) IF A PUBLIC SCHOOL IS UNABLE TO MEET THE REQUIREMENT UNDER SUBSECTION (B) OF THIS SECTION, THE DEPARTMENT OF STATE POLICE SHALL ASSIGN A STATE POLICE OFFICER TO THE PUBLIC SCHOOL.
(2) A STATE POLICE OFFICER ASSIGNED TO A PUBLIC SCHOOL UNDER PARAGRAPH (1) OF THIS SUBSECTION SHALL BE PRESENT ON SCHOOL GROUNDS DURING REGULAR SCHOOL HOURS ON SCHOOL DAYS.
(D) A SCHOOL RESOURCE OFFICER OR A STATE POLICE OFFICER ASSIGNED TO A PUBLIC SCHOOL UNDER THIS SECTION SHALL:
(1) PERFORM SCREENINGS AT THE ENTRANCE TO THE SCHOOL;
(2) REGULARLY PATROL SCHOOL GROUNDS;
(3) INTERACT WITH STUDENTS; AND
(4) PARTICIPATE IN ANY FIRE DRILL OR OTHER SCHOOL DRILL.

(F) A PRIVATE SCHOOL MAY HAVE A SCHOOL RESOURCE OFFICER PRESENT ON SCHOOL GROUNDS.".
