AMENDMENTS TO SENATE BILL 1265, AS AMENDED  
(Third Reading File Bill)

AMENDMENT NO. 1

On page 2 of the bill, in line 34, after “officers” insert “and other school security employees”; and in line 42, after the semicolon insert “beginning on a certain date, requiring an individual to complete a certain training program to be employed as a school security employee.”.

AMENDMENT NO. 2

On page 11 of the bill, after line 13, insert:

**“(K) “SCHOOL SECURITY EMPLOYEE” MEANS AN INDIVIDUAL, AS DEFINED IN REGULATIONS ADOPTED BY THE SUBCABINET, WHO:**

**(1) IS NOT A SCHOOL RESOURCE OFFICER; AND**

**(2) IS EMPLOYED BY A LOCAL SCHOOL SYSTEM TO PROVIDE SAFETY AND SECURITY-RELATED SERVICES AT A PUBLIC SCHOOL.”;**

and in lines 14 and 15, strike “**(K)**” and “**(L)**”, respectively, and substitute “**(L)**” and “**(M)**”, respectively.

On page 17 of the bill, after line 26, insert:

**“(9) ADOPT REGULATIONS TO DEFINE A SCHOOL SECURITY EMPLOYEE FOR THE PURPOSE OF THE TRAINING AND REPORT REQUIRED FOR SCHOOL SECURITY EMPLOYEES UNDER § 7-1508 OF THIS SUBTITLE.”;**

and in lines 27, 28, 29 and 31, strike “**(9)**”, “**(10)**”, “**(11)**”, and “**(12)**”, respectively, and substitute “**(10)**”, “**(11)**”, “**(12)**”, and “**(13)**”, respectively.

On page 24 of the bill, in line 16, after “**OFFICERS**” insert “**AND SCHOOL SECURITY EMPLOYEES**”.

On page 25 of the bill, after line 31, insert:

**“(5) BEGINNING SEPTEMBER 1, 2019, TO BE EMPLOYED AS A SCHOOL SECURITY EMPLOYEE AT A PUBLIC SCHOOL, AN INDIVIDUAL SHALL COMPLETE:**

**(I) THE MODEL TRAINING PROGRAM DEVELOPED BY THE CENTER UNDER PARAGRAPH (2) OF THIS SUBSECTION THROUGH INSTRUCTION PROVIDED BY THE CENTER IN COLLABORATION WITH THE MARYLAND POLICE TRAINING AND STANDARDS COMMISSION; OR**

**(II) A LOCAL LAW ENFORCEMENT AGENCY’S TRAINING PROGRAM DEVELOPED UNDER PARAGRAPH (3)(II) OF THIS SUBSECTION.”.**

On page 32 of the bill, after line 9, insert:

**“(6) ENROLLING SCHOOL SECURITY EMPLOYEES IN TRAINING PROVIDED BY THE CENTER;”;**

and in lines 10, 14, 17, and 22, strike “**(6)**”, “**(7)**”, “**(8)**”, and “**(9)**”, respectively, and substitute “**(7)**”, “**(8)**”, “**(9)**”, and “**(10)**”, respectively.

In the Committee on Ways and Means Amendment (SB1265/655168/1), in line 4, strike “**ANY**” and substitute “:

and in line 5, after "DUTIES" insert ";AND

**(II) ANY SCHOOL SECURITY EMPLOYEE AND A STUDENT  
WHILE THE SCHOOL SECURITY EMPLOYEE IS CARRYING OUT THE EMPLOYEE'S  
DUTIES**".
