AMENDMENTS TO HOUSE BILL 1076
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “Delegates Beidle and Gaines” and substitute “Anne Arundel County Delegation”; in line 2, strike “Attendants –” and substitute “Safety”; in lines 3 and 12, in each instance, strike “Attendant” and substitute “Safety”; strike beginning with “establishing” in line 4 down through “duty” in line 6 and substitute “requiring a law enforcement officer to be on duty during certain hours”; and strike beginning with “select” in line 6 down through “program” in line 8 and substitute “implement the pilot program at certain transit stations under its jurisdiction”.

AMENDMENT NO. 2

On page 1 in line 23, and on page 2 in line 1, in each instance, strike “ATTENDANT” and substitute “SAFETY”.

AMENDMENT NO. 3

On page 2, strike beginning with “HIRE” in line 2 down through “STATIONS” in line 4 and substitute “PROVIDE LAW ENFORCEMENT OFFICERS AT TRANSIT STATIONS TO ENHANCE PUBLIC SAFETY”; strike beginning with “A” in line 5 down through “(E)” in line 19; in line 19, strike “STATION ATTENDANT” and substitute “LAW ENFORCEMENT OFFICER”; in the same line, strike “MONDAY THROUGH FRIDAY:” and substitute “DURING THE OPERATING HOURS OF THE STATIONS IDENTIFIED UNDER SUBSECTION (E) OF THIS SECTION.”; strike in their entirety lines 20 through 24, inclusive, and substitute:

“(E) THE ADMINISTRATION SHALL IMPLEMENT THE PILOT PROGRAM AT THE FOLLOWING TRANSIT STATIONS UNDER ITS JURISDICTION:

**(1) LINTHICUM STATION LOCATED AT 595 CAMP MEADE ROAD,
LINTHICUM HEIGHTS; AND**

ANNAPOLIS BOULEVARD, GLEN BURNIE.”;**

and in lines 25 and 27, strike “(G)” and “(H)”, respectively, and substitute “(F)” and “(G)”, respectively.

AMENDMENT NO. 4

On page 3, in line 2, strike “June” and substitute “October”; in line 3, strike “2 years” and substitute “1 year”; and in the same line, strike “May 31, 2020” and substitute “September 30, 2019”.
