On page 1 of the bill, in line 2, after "Presidential" insert "<u>Ticket and General Assembly</u>"; in line 4, after "States" insert "<u>and certain candidates for election as a member of the General Assembly</u>"; in lines 4, 5, 7, and 13, in each instance, strike "federal"; in line 6, strike "presidential" and substitute "<u>certain</u>"; in line 8, before "publicly" insert "<u>and candidates for election as members of the General Assembly</u>"; in line 10, before "who" insert "<u>and the names of candidates for election as a member of the General Assembly</u>"; and in line 12, strike "for President or Vice President of the United States" and substitute "<u>on a Presidential ticket and candidates for election as a member of the General Assembly</u>".

On page 1 of the Education, Health, and Environmental Affairs Committee Amendments (SB0256/504331/1), in line 2 of Amendment No. 1, before " \underline{a} " insert "candidates on".

AMENDMENT NO. 2

On page 2 of the Education, Health, and Environmental Affairs Committee Amendments, in line 3 of Amendment No. 2, after "<u>UNIT.</u>" insert:

"(4) "STATE INCOME TAX RETURN" MEANS A RETURN FILED UNDER TITLE 10, SUBTITLE 8 OF THE TAX – GENERAL ARTICLE.";

<u>**GENERAL ASSEMBLY**</u>"; in the same line, strike "<u>**EACH**</u>" and substitute "<u>**THE**</u>"; in line 15, before "<u>(F)</u>" insert:

"(2) <u>THE NAME OF A CANDIDATE FOR ELECTION AS A MEMBER OF</u> <u>THE GENERAL ASSEMBLY MAY NOT APPEAR ON THE GENERAL ELECTION BALLOT</u> <u>IF THE CANDIDATE FAILS TO SATISFY THE REQUIREMENTS OF THIS SECTION.</u>";

in the same line, strike "(F)" and substitute "(G)"; and in line 20, strike "§ 5-102(F)" and substitute "§ 5-102(G)".

On page 2 of the bill, in line 2, strike "**PRESIDENTIAL**"; in the same line, after "**ELECTION**" insert "**IN WHICH THE NAME OF THE CANDIDATE WOULD APPEAR ON** <u>**THE BALLOT**</u>"; in line 3, strike "A" and substitute "<u>**EACH CANDIDATE ON A**</u>"; and after line 11, insert:

"(D) <u>NO LATER THAN 65 DAYS BEFORE A GENERAL ELECTION, A</u> <u>CANDIDATE FOR ELECTION AS A MEMBER OF THE GENERAL ASSEMBLY SHALL</u> <u>FILE WITH THE STATE BOARD:</u>

(1) <u>A COPY OF THE CANDIDATE'S STATE INCOME TAX RETURN FOR</u> <u>AT LEAST THE 5 MOST RECENT TAXABLE YEARS FOR WHICH THE CANDIDATE</u> <u>FILED A RETURN WITH THE STATE COMPTROLLER; AND</u>

(2) WRITTEN CONSENT, ON THE FORM THE STATE BOARD PRESCRIBES, FOR THE DISCLOSURE OF THE STATE INCOME TAX RETURNS SPECIFIED UNDER ITEM (1) OF THIS SUBSECTION IN THE MANNER PROVIDED IN SUBSECTION (E) OF THIS SECTION.".
