AMENDMENT NO. 1

On page 1, in line 7, after "<u>location</u>" insert "<u>for a certain period of time and for certain purposes</u>"; and in lines 21 and 22, strike "<u>requiring certain transferred employees to be allowed to maintain a certain work location</u>;".

AMENDMENT NO. 2

On page 7, after line 2, insert:

"(5) "QUALIFIED HEALTH CARE PROVIDER" MEANS AN INDIVIDUAL WHO IS LICENSED BY A HEALTH OCCUPATIONS BOARD ESTABLISHED UNDER THE HEALTH OCCUPATIONS ARTICLE.";

in line 3, strike "(5)" and substitute "(6)"; in line 13, after "PHYSICIAN" insert ", A QUALIFIED HEALTH CARE PROVIDER,"; in line 18, after "PHYSICIAN" insert ", QUALIFIED HEALTH CARE PROVIDER,"; and after line 30, insert:

"(III) A QUALIFIED HEALTH CARE PROVIDER;".

On page 8, in lines 1 and 2, strike "(III)" and "(IV)", respectively, and substitute "(IV)" and "(V)", respectively; in line 4, after "PHYSICIAN" insert "OR A QUALIFIED HEALTH CARE PROVIDER"; and in lines 6 and 10, in each instance, after "PHYSICIAN" insert "OR QUALIFIED HEALTH CARE PROVIDER".

On page 12, strike beginning with the semicolon in line 19 down through "<u>City</u>" in line 20 and substitute "<u>. The Criminal Injuries Compensation Board shall maintain an office at its current location in Baltimore City until at least July 1, 2020, for the</u>

purpose of accepting claims, providing assistance on filing claims, and holding hearings"; and in line 24, after "Prevention" insert "and deposited in the Criminal Injuries Compensation Fund".

On page 13, strike in their entirety lines 13 through 15, inclusive; and in lines 16, 22, 30, and 37, strike "<u>5.</u>", "<u>6.</u>", "<u>7.</u>", and "<u>8.</u>", respectively, and substitute "<u>4.</u>", "<u>5.</u>", "<u>6.</u>", and "<u>7.</u>", respectively.

On page 14, in lines 6 and 12, strike "9." and "10.", respectively, and substitute "8." and "9.", respectively.

On page 15, in lines 1 and 8, strike "11." and "12.", respectively, and substitute "10." and "11.", respectively.
