On page 2, in line 14, strike "<u>(1)</u>"; and strike in their entirety lines 16 and 17, inclusive.

AMENDMENT NO. 3

On page 5, in line 7, strike "<u>FOR</u>" and substitute "<u>SUBJECT TO PARAGRAPH (3)</u> <u>OF THIS SUBSECTION, FOR</u>"; in the same line, strike "<u>THE FOLLOWING</u>"; and strike in their entirety lines 8 through 30, inclusive, and substitute "<u>CAPITAL GRANTS SHALL</u> <u>BE APPROPRIATED FROM THE TRANSPORTATION TRUST FUND AS PROVIDED IN</u> <u>§ 3-216 OF THIS ARTICLE BASED ON THE FOLLOWING CALCULATIONS:</u>

(I) <u>AN AMOUNT EQUAL TO 8.3% OF FUNDS CREDITED TO THE</u> <u>GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT SHALL BE APPROPRIATED</u> <u>TO BALTIMORE CITY;</u>

(II) <u>AN AMOUNT EQUAL TO 3.2% OF FUNDS CREDITED TO THE</u> <u>GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT SHALL BE APPROPRIATED</u> <u>TO THE COUNTIES TO BE DISTRIBUTED AS PROVIDED IN § 8-404 OF THIS</u> <u>SUBTITLE; AND</u>

(III) AN AMOUNT EQUAL TO 2.0% OF FUNDS CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT SHALL BE APPROPRIATED TO THE MUNICIPALITIES TO BE DISTRIBUTED AS PROVIDED IN § 8-405 OF THIS SUBTITLE.

(2) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, FOR FISCAL YEAR 2025 AND EACH FISCAL YEAR THEREAFTER, CAPITAL GRANTS SHALL BE APPROPRIATED FROM THE TRANSPORTATION TRUST FUND AS PROVIDED IN § 3-216 OF THIS ARTICLE BASED ON THE FOLLOWING CALCULATIONS:

(I) <u>AN AMOUNT EQUAL TO 7.7% OF FUNDS CREDITED TO THE</u> <u>GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT SHALL BE APPROPRIATED</u> <u>TO BALTIMORE CITY;</u>

(II) AN AMOUNT EQUAL TO 1.5% OF FUNDS CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT SHALL BE APPROPRIATED TO THE COUNTIES TO BE DISTRIBUTED AS PROVIDED IN § 8-404 OF THIS SUBTITLE; AND

(III) AN AMOUNT EQUAL TO 0.4% OF FUNDS CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT SHALL BE APPROPRIATED TO THE MUNICIPALITIES TO BE DISTRIBUTED AS PROVIDED IN § 8-405 OF THIS SUBTITLE.

(3) THE CAPITAL GRANTS MADE UNDER THIS SUBTITLE SHALL BE APPROPRIATED ONLY IF ALL DEBT SERVICE REQUIREMENTS AND DEPARTMENTAL OPERATING EXPENSES HAVE BEEN FUNDED AND SUFFICIENT FUNDS ARE AVAILABLE TO FUND THE CAPITAL PROGRAM.".

On page 7, after line 27, insert:

"<u>SECTION 2. AND BE IT FURTHER ENACTED</u>, That the Laws of Maryland read as follows:

<u>Article – Transportation</u>

<u>8–401.</u>

(a) In this subtitle the following words have the meanings indicated.

(d) <u>"Highway user revenues" means the [funds credited to the Gasoline and</u> <u>Motor Vehicle Revenue Account of the Transportation Trust Fund] CAPITAL GRANTS</u> <u>APPROPRIATED TO BALTIMORE CITY, COUNTIES, AND MUNICIPALITIES UNDER §</u> <u>8–403(B) OF THIS SUBTITLE.</u>

<u>SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall</u> take effect July 1, 2019.";

in line 28, strike "2." and substitute "<u>4.</u>"; and in the same line, after "That" insert "<u>,</u> <u>except as provided in Section 3 of this Act,</u>".
