AMENDMENT NO. 1

On page 1, in line 15, strike "require" and substitute "<u>authorize</u>"; and in line 19, before the first "and" insert "<u>specifying that an institution may not discourage a student</u> from retaining an attorney; specifying that the Commission is not required to pay a <u>student's attorney's fees for representation in a criminal or civil matter;</u>".

AMENDMENT NO. 2

On page 6, in line 12, strike "<u>A CULTURALLY</u>" and substitute "<u>AN</u>".

AMENDMENT NO. 3

On page 7, in line 5, after "<u>CREDIBILITY</u>" insert "<u>AFTER THAT STUDENT HAS</u> <u>PUT HIS OR HER OWN PRIOR SEXUAL CONDUCT AT ISSUE</u>".

AMENDMENT NO. 4

On page 7, in line 23, strike "<u>REQUIRE THAT COUNSEL BE PROVIDED AND</u>" and substitute "<u>AUTHORIZE STUDENTS TO ACCESS COUNSEL</u>".

AMENDMENT NO. 5

On page 7, strike in their entirety lines 26 through 31, inclusive, and substitute:

"1. <u>A CURRENT OR FORMER STUDENT WHO MAKES A</u> <u>COMPLAINT ON WHICH A FORMAL TITLE IX INVESTIGATION IS INITIATED AND</u> <u>WHO WAS ENROLLED AS A STUDENT AT THE INSTITUTION AT THE TIME OF THE</u> <u>INCIDENT THAT IS THE BASIS OF THE COMPLAINT, UNLESS THE STUDENT</u> <u>KNOWINGLY AND VOLUNTARILY CHOOSES NOT TO HAVE COUNSEL; AND</u>

2. <u>A CURRENT OR FORMER STUDENT WHO RESPONDS</u> TO A COMPLAINT ON WHICH A FORMAL TITLE IX INVESTIGATION IS INITIATED AND WHO WAS ENROLLED AS A STUDENT AT THE INSTITUTION AT THE TIME OF THE INCIDENT THAT IS THE BASIS OF THE COMPLAINT, UNLESS THE STUDENT KNOWINGLY AND VOLUNTARILY CHOOSES NOT TO HAVE COUNSEL.".

AMENDMENT NO. 6

On page 9, strike in their entirety lines 3 through 9, inclusive, and substitute:

"(IV) 1. <u>A STUDENT MAY SELECT AND RETAIN AN</u> <u>ATTORNEY BEFORE THE CONCLUSION OF THE FORMAL TITLE IX PROCEEDINGS.</u>

2. <u>AN INSTITUTION MAY NOT DISCOURAGE A</u> <u>STUDENT FROM RETAINING AN ATTORNEY.</u>".

AMENDMENT NO. 7

On page 9, after line 17, insert:

"(8) <u>THE COMMISSION IS NOT REQUIRED TO PAY A STUDENT'S</u> <u>ATTORNEY'S FEES FOR REPRESENTATION IN A CRIMINAL OR CIVIL MATTER.</u>".
