On page 1, in line 2, strike "– Exclusive Representatives"; in line 4, after "certain" insert "<u>State</u>"; in lines 4 and 5, strike "in the State Personnel Management System"; strike beginning with "to" in line 5 down through "restraint" in line 7 and substitute "<u>requiring a grievant to complete certain forms in a certain manner for a certain purpose; applying a certain definition of "grievance" to a certain requirement that the Department of Transportation adopt certain regulations relating to employee grievance <u>procedures</u>"; in line 9, strike "exclusive representatives of"; in line 12, strike "12–103(a)" and substitute "<u>12–108</u>"; and after line 14, insert:</u>

"BY repealing and reenacting, with amendments,

<u>Article - Transportation</u> <u>Section 2-103.4(d)(2)</u> <u>Annotated Code of Maryland</u> (2015 Replacement Volume and 2017 Supplement)".

AMENDMENT NO. 2

On page 2, strike beginning with the colon in line 4 down through "(I)" in line 5; in lines 7 and 9, in each instance, strike the brackets; in line 7, strike "1."; in line 8, strike "or"; in line 9, strike "2."; strike in their entirety lines 11 through 16, inclusive; in line 17, strike "2." and substitute "(III)"; and in the same line, strike "OVER".

On page 3, strike beginning with the colon in line 2 down through "(1)" in line 3; and strike beginning with "; AND" in line 4 down through "SYSTEM" in line 6 and substitute "<u>AND INDEPENDENT PERSONNEL SYSTEMS, EXCEPT FOR THE DEPARTMENT OF TRANSPORTATION</u>".
