#### AMENDMENT NO. 2

On page 3 of the House Judiciary Committee Amendments, in line 2 of Amendment No. 3, strike "<u>SUBSECTION</u>" and substitute "<u>SUBSECTIONS</u>"; in the same line, after "<u>(B)</u>" insert "<u>AND (C)</u>"; and in line 11, after "<u>ACTIVATOR.</u>" insert:

### "(C) <u>THIS SECTION DOES NOT APPLY TO A PERSON TRANSPORTING A</u> RAPID FIRE TRIGGER ACTIVATOR IF THE PERSON:

## (1) IS TRANSPORTING THE RAPID FIRE TRIGGER ACTIVATOR FOR THE PURPOSE OF SURRENDERING THE RAPID FIRE TRIGGER ACTIVATOR;

# (2) HAS NOTIFIED THE LAW ENFORCEMENT UNIT, BARRACKS, OR STATION THAT THE RAPID FIRE TRIGGER ACTIVATOR IS BEING TRANSPORTED FOR PURPOSES OF SURRENDERING THE RAPID FIRE TRIGGER ACTIVATOR; AND

## (3) TRANSPORTS THE RAPID FIRE TRIGGER ACTIVATOR DIRECTLY TO THE LAW ENFORCEMENT UNIT, BARRACKS, OR STATION.

(D) (1) BEGINNING JUNE 1, 2018, THE DEPARTMENT OF STATE POLICE AND LOCAL LAW ENFORCEMENT UNITS SHALL ACCEPT RAPID FIRE TRIGGER ACTIVATORS THAT ARE PEACEFULLY AND VOLUNTARILY SURRENDERED.

### (2) <u>The Governor's Office of Crime Control and</u> <u>Prevention shall advertise:</u>

# (I) THAT A PERSON WHO PEACEFULLY AND VOLUNTARILY SURRENDERS A RAPID FIRE TRIGGER ACTIVATOR IS NOT SUBJECT TO CRIMINAL PROSECUTION OR A CIVIL PENALTY;

### (II) LOCATIONS WHERE A PERSON MAY PEACEFULLY AND VOLUNTARILY SURRENDER A RAPID FIRE TRIGGER ACTIVATOR; AND

(III) PROCEDURES FOR SURRENDERING A RAPID FIRE TRIGGER ACTIVATOR.".

On page 4 of the House Judiciary Committee Amendments, in line 5 of Amendment No. 3, strike "<u>subsection (b)</u>" and substitute "<u>subsections (b) and (c)</u>".
