AMENDMENT NO. 1

On page 1, in line 2, strike "Coppin State University and Morgan State University" and substitute "Higher Education"; strike beginning with "Coppin" in line 4 down through the second "University" in line 5 and substitute "Baltimore City Community College, Bowie State University, Coppin State University, Morgan State University, and the University of Maryland Eastern Shore"; strike beginning with "prohibiting" in line 8 down through the semicolon in line 11; strike beginning with "from" in line 17 down through "institutions" in line 19 and substitute "for the Commission to provide grants to institutions of higher education for the Program"; strike beginning with "be" in line 21 down through "budget;" in line 23 and substitute "supplement and not supplant certain funds; requiring the Commission annually to allocate certain funds to certain institutions of higher education on a certain basis;"; in lines 23 and 24, strike "Coppin State University and Morgan State University" and substitute "certain institutions of higher education"; in line 24, after "to" insert "jointly"; in lines 24 and 25, strike "on their campuses"; and strike beginning with "at" in line 26 down through "University" in line 27.

AMENDMENT NO. 2

On page 2, strike line 30 in its entirety.

On page 3, strike line 1 in its entirety and substitute:

"(1) THE BOARD OF TRUSTEES OF BALTIMORE CITY COMMUNITY COLLEGE;

(2) THE PRESIDENT OF BOWIE STATE UNIVERSITY;

- (3) THE PRESIDENT OF COPPIN STATE UNIVERSITY;

On page 3, strike in their entirety lines 7 and 8 and substitute:

- "(1) BALTIMORE CITY COMMUNITY COLLEGE;
- (2) BOWIE STATE UNIVERSITY;
- (3) COPPIN STATE UNIVERSITY;
- (4) MORGAN STATE UNIVERSITY; AND
- (5) UNIVERSITY OF MARYLAND EASTERN SHORE.";

and strike in their entirety lines 13 through 20, inclusive.

On page 4, strike beginning with "FOR" in line 12 down through "YEAR" in line 16 and substitute "AN APPROPRIATION OF \$2,500,000 FOR THE COMMISSION TO PROVIDE GRANTS TO BALTIMORE CITY COMMUNITY COLLEGE, BOWIE STATE UNIVERSITY, COPPIN STATE UNIVERSITY, MORGAN STATE UNIVERSITY, AND THE UNIVERSITY OF MARYLAND EASTERN SHORE FOR THE PROGRAM ESTABLISHED UNDER THIS SECTION"; strike beginning with "GOVERNOR" in line 18 down through "YEAR" in line 20 and substitute "COMMISSION OF THE NUMBER OF STUDENTS ENROLLED IN EACH INSTITUTION'S PROGRAM FOR THE CURRENT

ACADEMIC YEAR"; and strike beginning with "BE" in line 22 down through "BUDGET" in line 27 and substitute "SUPPLEMENT, BUT NOT SUPPLANT, ANY FUNDS THAT WOULD OTHERWISE BE PROVIDED FOR EACH INSTITUTION.

BALTIMORE CITY COMMUNITY COLLEGE, BOWIE STATE UNIVERSITY, COPPIN STATE UNIVERSITY, MORGAN STATE UNIVERSITY, AND THE UNIVERSITY OF MARYLAND EASTERN SHORE ON A PRO RATA BASIS ACCORDING TO THE MOST RECENT ENROLLMENT DATA REQUIRED UNDER SUBSECTION (B) OF THIS SECTION".

On page 5, in line 2, strike "Coppin State University and Morgan State University" and substitute "Baltimore City Community College, Bowie State University, Coppin State University, Morgan State University, and the University of Maryland Eastern Shore"; in the same line, strike "each" and substitute "jointly"; and in line 3, strike "on their campuses".
